Overview

The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>Bureau of Justice Assistance</u> (BJA) seeks applications for funding to work in partnership with state, local, and tribal agencies to address the use of fines and fees and ensure they are being used in a constitutional and nondiscriminatory way. The purpose of this program is to address common barriers to creating a more equitable justice system by addressing how agencies use and apply fines and fees. This program furthers the DOJ's mission by creating a more fair and just system and reducing the use of confinement.

This solicitation incorporates guidance provided in the <u>OJP Grant Application Resource Guide</u> which provides additional information for applicants to prepare and submit applications to OJP for funding. If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.

Solicitation Categories

Eligible Applicants:

For profit organizations other than small businesses, Native American tribal organizations (other than Federally recognized tribal governments), Nonprofits having a 501(c)(3) status with the IRS, other than institutions of higher education, Nonprofits that do not

have a 501(c)(3) status with the IRS, other than institutions of higher education, Private institutions of higher education, Public and State controlled institutions of higher education, Small business

BJA will consider applications under which two or more entities would carry out the federal award; however, only one entity may be the applicant. Any others must be proposed as subrecipients (subgrantees). For additional information on subawards, see the <u>OJP Grant Application Resource Guide</u>.

BJA may elect to fund applications submitted under this FY 2023 solicitation in future fiscal years, dependent on, among other considerations, the merit of the applications and the availability of appropriations.

Program Description

Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

With this solicitation, BJA seeks to fund a training and technical assistance provider (TTA), to work in partnership with five states, local, and/or tribal criminal justice agencies or systems ("jurisdictions") to address the use of fines and fees and ensure they are being imposed in a constitutional and nondiscriminatory way. The provider will work with sites to address common barriers to creating a more equitable justice system by addressing how sites use and apply fines and fees.

Statutory Authority

Department of Justice Appropriations Act, 2023 (Pub. L. No. 117-328; 136 Stat. 4459, 4537).

Specific Information

BJA is committed to helping states and agencies therein ensure that their assessment of fines and fees is constitutional and nondiscriminatory. BJA recognizes that unjust imposition and enforcement of fines and fees can cause serious civil rights concerns that affect people accused of felonies, misdemeanors, quasi-criminal ordinance violations, and civil infractions. In some instances, courts assess fines and fees against defendants in criminal cases who have not been convicted of an offense, or who have had a case dismissed. In other instances, courts impose a jail or prison term along with fines and fees. In some instances, courts also impose fees for interpreters or translated materials against limited English proficient individuals who are trying to meaningfully access court proceedings and operations. Imposing and enforcing fines and fees on individuals who cannot afford to pay them can cause profound harm. Individuals may confront escalating debt; lose custody of their children; face repeated, unnecessary incarceration for nonpayment of fines and fees; experience extended periods of probation and parole; be subjected to changes in immigration status; and lose their employment, driver's license, voting rights, or home. This practice far too often traps individuals and their families in a cycle of poverty and punishment.

This solicitation seeks a TTA provider to work with five jurisdictions to identify the purpose and intent of their fines and fees policies and practices and the resulting impact of their policies and practices, including any racial disparities or other constitutional concerns. To that end, the TTA provider will help five jurisdictions analyze their usage of fines and fees; assess their reliance on fines and fees for operations, including supporting victim assistance and compensation; and create and implement a plan to align a jurisdiction's fines and fees scheme with constitutional principles and civil rights statutes. Through this process, the TTA provider will assist the jurisdictions in defining what are equitable fines and fees practices and developing alternatives for people who are unable to pay, as well as to analyze to which fines and fees are poverty-based sanctions.

The selected TTA provider may additionally be tasked to work with jurisdictions who are

identified by DOJ enforcement offices as out of compliance with civil rights statutes, other statutes, and not adhering to constitutional principles, at BJA's discretion.

Goals, Objectives, and Deliverables

Goals

The goals of this initiative are as follows:

- 1. Reduce the disproportionate impact of fines and fees on communities most impacted by poverty and inequality;
- 2. Understand the costs/benefits of fines and fees to fund operations;
- 3. Assist jurisdictions in reducing reliance on fines and fees to fund operations;
- 4. Assist jurisdictions in reducing jailing and other sanctions (e.g., debt-based license restrictions) for failure to pay; and/or
- 5. Ultimately redirect the resources used to effectuate assessment and collection of fines and fees into activities shown to have a greater return on public safety.

Objectives

An applicant should address all the objectives listed below in the Goals, Objectives, Deliverables and Timeline web-based form.

The objectives of this initiative are to assist jurisdictions with the following:

- 1. Understanding the impact of their fines and fees schemes via objective fiscal analysis
- 2. Quantifying the costs of operating a fines and fees scheme
- 3. Identifying policy and practice changes to ensure adherence to constitutional principles and civil rights statutes, and
- 4. Implementing identified changes.

Deliverables

The deliverables of this initiative are:

- 1. Develop and execute a process to select five jurisdictions, in consultation with BJA.
- 2. Work closely with the selected jurisdictions during the project period to:
 - a. Conduct cost-benefit analysis to define the impact on agencies and individuals including the following, and distinguishing fines from fees:
 - i. Analysis of the existing statutory and regulatory framework as well as judicial discretion for fines and fees schemes.
 - ii. Assessment of the jurisdiction's dependence on the collection of fines and fees.
 - iii. Analysis of the use of correctional and other resources to respond to failures to pay, including the costs of incarcerating people for nonpayment.
 - iv. Analysis of budget(s) and accounting that maps a jurisdiction's monies

expected to be paid, actually paid, and disbursed.

- b. Assess alignment of fines and fees schemes with constitutional principles and civil rights statutes, as they relate to indigent individuals, including but not limited to:
 - i. Alternatives to adverse consequences (e.g., incarceration)
 - ii. Reduced access to court proceedings, procedures, and programs, including diversion programs (e.g., barred from drug court)
 - iii. Penalty-free payment plans
 - iv. Potential conflicts of interest (e.g., judges are not neutral decisionmakers if they oversee collection of fines and fees that fund a substantial portion of a judicial expense fund administered by them).
- c. Present and facilitate a shared understanding of the findings, including any disproportionate impact on marginalized communities, across a task force or coalition and other relevant groups within the state.
- d. Provide subject matter expertise and facilitation to help stakeholders agree on targets for change within its jurisdiction. Develop a workplan for each jurisdiction to implement the policy and practice changes identified for that jurisdiction.
- e. Provide subject matter and project management expertise to support the jurisdiction to implement the workplan, and to develop and track performance measures.
- 3. At BJA's direction, work with other jurisdictions whose fines and fees schemes are identified by DOJ enforcement offices as not in compliance with constitutional principles and civil rights statutes.
- 4. Deliver a final report documenting jurisdictions' efforts and results.

The Goals, Objectives, and Deliverables are directly related to the performance measures that show the completed work's results, as discussed in the "Application and Submission Information" section.

1. Priority Considerations Supporting Executive Order 13985, Advancing Racial Equity and Support for Underserved Communities Through the Federal Government

In support of this <u>Executive Order</u>, OJP will provide priority consideration when making award decisions to the following:

A. Applications that propose project(s) that are designed to promote racial equity and the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality.

To receive this consideration, the applicant must describe how the proposed project(s) will address potential racial inequities and contribute to greater access to services and opportunities for communities that have been historically underserved, marginalized, and adversely affected by inequality, and identify how the project design and implementation will specifically incorporate the input or participation of those communities and populations disproportionately impacted by crime, violence, and the criminal justice system overall. Examples addressing this requirement include, but are not limited to, the following: budgeted project planning and/or implementation meetings with community stakeholders representing historically underserved and marginalized communities; outreach and/or public awareness campaigns specifically tailored to historically underserved and marginalized communities to encourage participation in the proposed project(s); budgeted incorporation of members representing historically underserved and marginalized communities in program evaluation, surveys, or other means of project feedback; and partnership with organizations that primarily serve communities that have been historically underserved, marginalized, and adversely affected by inequality.

B. Applicants that demonstrate that their capabilities and competencies for implementing their proposed project(s) are enhanced because they (or at least one proposed subrecipient that will receive **at least 40%** of the requested award funding, as demonstrated in the Budget Web-Based Form) identify as a *culturally specific organization*.

To receive this additional priority consideration, applicants must describe how being a culturally specific organization (or funding the culturally specific subrecipient organization(s)) will enhance their ability to implement the proposed project(s) and should also specify which populations are intended or expected to be served or to have their needs addressed under the proposed project (s).

Culturally specific organizations are defined for the purposes of this solicitation as private nonprofit or tribal organizations whose primary purpose as a whole is to provide culturally specific services to racial and ethnic groups, including, among others, Black people, Hispanic and Latino people, Native American and other Indigenous peoples of North America (including Alaska Native, Eskimo, and Aleut), Asian Americans, Native Hawaiians, and/or Pacific Islanders.

Note: Addressing these priority areas is one of many factors that OJP considers in making

funding decisions. Receiving priority consideration for one or more priority areas does not quarantee an award.

- Work Product Examples

If OJP determines that an application does not include these elements, it will neither proceed to peer review, nor receive further consideration.

Information to Complete the Application for Federal Assistance (SF-424) in Grants.gov

The SF-424 must be submitted in Grants.gov. It is a required standard form used as a cover sheet for submission of pre-applications, applications, and related information. See the <u>OJP</u> <u>Grant Application Resource Guide</u> for additional information on completing the SF-424.

In Section 8F of the SF-424, please include the name and contact information of the individual who will complete the application in JustGrants. JustGrants will use this information (email address) to assign the application to this user in JustGrants.

Proposal Abstract

A Proposal Abstract (no more than 400 words) summarizing the proposed project — including its purpose, primary activities, expected outcomes, the service area, intended beneficiaries, and subrecipients (if known) — must be completed in the JustGrants web-based form. This abstract should be in paragraph form without bullets or tables, written in the third person, and exclude personally identifiable information. Abstracts will be made publicly available on the OJP and USASpending.gov websites if the project is awarded. See the OJP Grant Application Resource Guide for an example of a proposal abstract.

Proposal Narrative

The Proposal Narrative should be submitted as an attachment in JustGrants. The attached document should be double-spaced, using a standard 12-point font; have no less than 1-inch margins; and should not exceed 15 numbered pages. If the Proposal Narrative fails to comply with these length restrictions, BJA may consider such noncompliance in peer review and in final award decision. Tables, charts, and graphs included in the program narrative can be created in a legible font smaller than 12-point and will count toward the page limit.

The Proposal Narrative must include the following sections:

a. Description of the Issue

Describe why these proposed activities are necessary (significance/value) or address a need. Include supporting information.

b. Project Design and Implementation

Describe the strategy to address the needs identified in the Description of the Issue. List the activities and describe how they relate to the stated objectives. Activities are the specific actions to be undertaken to fulfill the program's objectives and reach the program's goal(s). Provide a detailed description of the method(s) to be used to carry out each activity. Provide a timetable indicating roughly when the activities or program milestones are to be accomplished.

If the applicant is seeking priority consideration for Priority 1(A), it should address in this section how the proposed project(s) will promote racial equity and the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality, and identify how the project design and implementation will specifically incorporate the input or participation of these communities.

c. Capabilities and Competencies

Describe the capabilities and competencies required to accomplish the goals and objectives of

the project. Areas of expertise must include civil rights statutes, analysis, lived experience of people impacted by fines and fees.

If the applicant is seeking priority consideration under Priority 1(B), it should describe within this section how being a culturally specific organization (or funding a culturally specific subrecipient organization at a minimum of 40% of the project budget) will enhance its ability to implement the proposed project(s), should also specify which populations are intended or expected to be served or have their needs addressed under the proposed project(s), and should include the website address (if applicable) and formal or informal mission statement or principles of the culturally specific organization.

d. Plan for Collecting the Data Required for this Solicitation's Performance Measures

Describe the process for measuring project performance. Identify who will collect the data; who is responsible for performance measurements; and how the information will be used to guide and evaluate the project's impact. Describe the process to accurately report data.

Note: An applicant is **not** required to submit performance data with the application. Rather, performance measure information is included as a notification that award recipients will be required to submit performance data as part of each award's reporting requirements. Some measures are presented as examples, while others are the exact measures that every recipient will be expected to address.

OJP will require each award recipient to submit regular performance data that show the completed work's results. The performance data directly relate to the goals, objectives, and deliverables identified in the "Goals, Objectives, and Deliverables" discussion.
