Who May Apply:

Nonprofits having a 501(c)(3) status with the IRS, other than institutions of higher education; nonprofits that do not have a 501(c)(3) status with the IRS, other than institutions of higher education; for profit organizations other than small businesses; small businesses; and public and private institutions of higher education.

Why Apply:

Receive funding to continue the Prison Rape Elimination Act (PREA) Resource Center to ensure continued progress toward meaningful implementation of the PREA standards in the nation's confinement facilities and to strengthen the commitment of staff members in these facilities and the agencies that oversee them to eliminate sexual abuse and sexual harassment of persons who are confined.

Maximum per Award:

Up to \$4,580,222 for one award

BJA encourages the following entities to apply:

- Agencies that have not received BJA funding before.
- Convening or governing bodies that can apply on behalf of one or more entities.

Examples of strategies/ activities that can be funded:

- PREA training.
- PREA technical assistance.
- Clearinghouse for PREA information and resources.
- Strategic outreach to and communication with PREA stakeholders.
- Implementing and enhancing zero tolerance cultures in confinement facilities and agencies.

- **Start early!** To apply, you must first have a valid registration in the System for Award Management (SAM). **Registration and renewal can take up to 10 business days** to complete. Register at: sam.gov/content/home.

How to apply and when:

Submit a two-step application.

- (1) Register in [Grants.gov](https://grants.gov) and follow the prompts to submit two forms by June 5, 2023.
- (2) Then complete the full application in JustGrants.usdoj.gov by June 15, 2023. The application's major elements are:
 - (a) The **proposal abstract** that summarizes the problem you wish to address with your project (no more than 400 words).
 - (b) The **proposal narrative** that describes your project's strategies, activities, and major deliverables as well as your capacity to address the problem.
 - (c) The **web-based budget** form that details how you will allocate the grant funds by task, date, and responsible person.
