Overview

The [U.S. Department of Justice \(DOJ\)](#), [Office of Justice Programs \(OJP\)](#), [Bureau of Justice Assistance \(BJA\)](#), seeks applications for funding for state, local, and tribal community supervision agencies to develop and test new or enhanced applications of the swift, certain, and fair (SCF) principles of intervention to reduce recidivism and improve outcomes for people on community supervision. This program furthers DOJ's mission by promoting the fair administration of justice and advancing public safety, reducing recidivism, and improving outcomes for individuals on community supervision.

This solicitation incorporates guidance provided in the [OJP Grant Application Resource Guide](#) which provides additional information for applicants to prepare and submit applications to OJP for funding. **If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.**

Eligible Applicants:

City or township governments, County governments, Native American tribal governments (Federally recognized), Native American tribal organizations (other than Federally recognized tribal governments), Special district governments, State governments, Other

Other

State, city, township, county or tribal government acting directly or through agreements with other public or private entities on behalf of a single drug or treatment court.

BJA will consider applications under which two or more entities would carry out the federal award; however, only one entity may be the applicant. Any others must be proposed as subrecipients (subgrantees). For additional information on subawards, see the [OJP Grant Application Resource Guide](#).

BJA may elect to fund applications submitted under this FY 2023 solicitation in future fiscal years, dependent on, among other considerations, the merit of the applications and the availability of appropriations.

Submission Information

Registration: Before submitting an application, all applicants must register with the System for Award Management (SAM). You must renew and validate your registration every 12 months. Registration and renewal can take up to 10 business days to complete.

Submission: Applications must be submitted to DOJ electronically through a two-step process via Grants.gov and JustGrants.

Step 1: The applicant must submit by the Grants.gov deadline the required **Application for Federal Assistance standard form (SF-424)** and a **Disclosure of Lobbying Activities (SF-LLL)** form when they register in Grants.gov at <https://www.grants.gov/web/grants/register.html>. **Submit the SF-424 and SF-LLL as early as possible, but no later than 48 hours before the Grants.gov deadline.** If an applicant fails to submit in Grants.gov, they will be unable to apply in JustGrants.

Program Description

Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

With this solicitation, BJA seeks to provide state, local, and tribal community supervision agencies with information, resources, and training and technical assistance (TTA) to engage in collaborative problem solving with stakeholders using data and research-informed strategies to assess and improve responses to client behavior in accordance with the principles of swiftness, certainty, and fairness; improve supervision outcomes; lower recidivism rates; reduce crime and incarceration in their jurisdictions; promote the fair administration of justice; and advance public safety. Statutory Authority

Any awards under this solicitation would be made under the Department of Justice Appropriations Act, 2023 (Pub. L. No. 117-328; 136 Stat. 4459, 4536).

Specific Information

This grant program seeks to enhance community supervision agencies' capacity to help reduce recidivism among, and improve outcomes for, people under supervision by using the SCF principles of intervention. (Under this solicitation, "community supervision agencies" include: adult probation, parole, or pretrial supervision or their equivalents such as prosecutor-led, post-adjudication diversion.)

The SCF principles are:

Swiftness—Responding to behavior promptly so people under supervision connect the response to their behavior.

Certainty—Ensuring that sanctions and rewards are applied with consistency and predictability.

Fairness—Making sanctions proportionate to negative behavior and rewards appropriate to positive behavior.

SCF projects may be led by diverse stakeholders (courts, community supervision agencies, state or local corrections agencies, law enforcement agencies, and prosecutor's offices) and may be applied to many different criminal justice populations, including people under pretrial supervision, probationers and parolees who are at moderate to high risk to reoffend, people on probation for misdemeanor domestic-violence offenses, young-adult probation clients, female probation clients, and parolees with opioid use disorder.

SCF projects have used a variety of responses to deter unwanted behavior and incentivize positive behavior such as community service, increased drug testing, curfew, increased or modified reporting, electronic monitoring, home detention, and brief jail stays in the case of more

serious misbehaviors. Common rewards include verbal praise, letters of recommendation or recognition, reduced drug testing, reduced reporting, reduced supervision fees, reduced mandatory community service, and early termination from supervision.

Each jurisdiction that implements the SCF principles has a unique set of circumstances—problems, environments, and resources—and BJA expects that these differences will be reflected in project design. For example, the target population, the types of rewards and sanctions available, and the level of collaboration with justice partners (e.g., parole boards and courts) will vary by jurisdiction, so the starting points, proposed activities, and target outcomes should vary as well.

Goals, Objectives, and Deliverables

Goals

The goals of the SCF Supervision Program are to provide state, local, and tribal community supervision agencies with information, resources, and TTA to improve responses to client behavior in accordance with the principles of swiftness, certainty, and fairness; improve supervision outcomes; lower recidivism rates; and reduce crime and incarceration in their jurisdictions.

Objectives

An applicant should address the objectives listed below in the Goals, Objectives, Deliverables and Timeline web-based form.

BJA will make up to five awards for grantees to pursue the following objectives:

1. Identify a target population for the SCF project using a collaborative, data-driven process that is responsive to local circumstances. (For examples of target populations that may be identified, visit <https://bja.ojp.gov/program/swift-certain-and-fair-supervision-program/overview>)
2. Develop and implement supervision strategies based on the SCF principles, including responses to both positive and negative client behaviors.
3. Reduce recidivism among, and improve outcomes for, people under supervision.
4. Evaluate the effectiveness of SCF strategies to reduce recidivism and improve outcomes for individuals under community supervision.

Deliverables

The required deliverables are as follows:

1. An action plan consisting of a problem analysis, summary of strategies and intended outcomes, a research basis or data supporting the proposed strategies, and an evaluation plan delivered within 6 months of the award.
2. A final report that documents the process, intervention, outcomes, evaluation findings, and lessons learned.

Consistent with the objectives and deliverables outlined above, applicants should include in their proposals a commitment to hire a full-time, onsite program coordinator to manage the day-to-day operations of the SCF project. The program coordinator most likely will be housed in the community supervision agency, have experience in the field of criminal justice, and have proven capacity to work effectively with key SCF team members such as the chief judge, court staff,

parole or probation office, law enforcement, and other partners, where applicable. Applicants do have discretion in determining which agency would be the most suitable to house the program coordinator, based on the proposed project design and the roles and responsibilities of the partner agencies.

The Goals, Objectives, and Deliverables are directly related to the performance measures that show the completed work's results, as discussed in the "Application and Submission Information" section.

Evidence-Based Programs or Practices

Priority Areas

The Department of Justice is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

1. Priority Considerations Supporting Executive Order 13985, *Advancing Racial Equity and Support for Underserved Communities Through the Federal Government*

In support of this [Executive Order](#), OJP will provide priority consideration when making award decisions to the following:

A. Applications that propose project(s) that are designed to promote racial equity and the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality.

To receive this consideration, the applicant must describe how the proposed project(s) will address potential racial inequities and contribute to greater access to services and opportunities for communities that have been historically underserved, marginalized, and adversely affected by inequality, and identify how the project design and implementation will specifically incorporate the input or participation of those communities and populations disproportionately impacted by crime, violence, and the criminal justice system overall. Examples addressing this requirement include, but are not limited to, the following: budgeted project planning and/or implementation meetings with community stakeholders representing historically underserved and marginalized communities; outreach and/or public awareness campaigns specifically tailored to historically underserved and marginalized communities to encourage participation in the proposed project(s); budgeted incorporation of members representing historically underserved and marginalized communities in program evaluation, surveys, or other means of project feedback; and partnership

with organizations that primarily serve communities that have been historically underserved, marginalized, and adversely affected by inequality.

B. Applicants that demonstrate that their capabilities and competencies for implementing their proposed project(s) are enhanced because they (or at least one proposed subrecipient that will receive **at least 40%** of the requested award funding, as demonstrated in the Budget Web-Based Form) identify as a *culturally specific organization*.

To receive this additional priority consideration, applicants must describe how being a culturally specific organization (or funding the culturally specific subrecipient organization(s)) will enhance their ability to implement the proposed project(s) and should also specify which populations are intended or expected to be served or to have their needs addressed under the proposed project (s).

Culturally specific organizations are defined for the purposes of this solicitation as private nonprofit or tribal organizations whose primary purpose as a whole is to provide culturally specific services to racial and ethnic groups, including, among others, Black people, Hispanic and Latino people, Native American and other Indigenous peoples of North America (including Alaska Native, Eskimo, and Aleut), Asian Americans, Native Hawaiians, and/or Pacific Islanders.

Note: Addressing these priority areas is one of many factors that OJP considers in making funding decisions. Receiving priority consideration for one or more priority areas does not guarantee an award.

Availability of Funds

This solicitation, and awards under this solicitation, are subject to the availability of appropriated funds and to any modifications or additional requirements that may be imposed by the agency or by law. In addition, nothing in this solicitation is intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against the United States, its departments, agencies, or entities, its officers, employees, or agents, or any other person.

Type of Award

BJA expects to make awards under this solicitation as grants. Financial Management and System of Internal Controls

The budget for the final 12-month period should support evaluation activities only and may support the supervision agency’s role in data collection, review, and other evaluation-specific tasks, as well as the evaluation team’s role in completing evaluation activities and working with program staff to incorporate evaluation findings into the final report. The total budget must not exceed \$800,000, and \$100,000 must be spent on evaluation activities.

Applicants should budget funding for three members of the SCF team (including the program coordinator) to travel to a peer-learning event (such as a regional meeting). Additionally, estimate the costs of travel and accommodations for three team members to attend at least two meetings during the grant period at an SCF grantee site. All expenses must be reasonable, allowable, and necessary to the project. The estimates must provide a breakdown of all costs and adhere to the federal per diem. To become certified, the law enforcement agency must meet two mandatory conditions: (1) the agency’s use-of-force policies adhere to all applicable federal, state, and local laws, and (2) the agency’s use-of-force policies prohibit chokeholds except in situations where use of deadly force is allowed by law. The certification requirement also applies to law enforcement agencies receiving DOJ discretionary grant funding through a subaward. Application and Submission Information

Content of Application Submission

The following application elements **must** be included in the application to meet the basic minimum requirements to advance to peer review and receive consideration for funding:

- Proposal Abstract
- Proposal Narrative
- Budget Web-Based Form (The web-based form includes the budget details and the budget narrative.)
- Letters of Support from members of the applicant's SCF team, including, if applicable, the research partner and/or community supervision agency

If OJP determines that an application does not include these elements, it will neither proceed to peer review, nor receive further consideration.

Information to Complete the Application for Federal Assistance (SF-424) in Grants.gov

The SF-424 must be submitted in Grants.gov. It is a required standard form used as a cover sheet for submission of pre-applications, applications, and related information. See the [OJP Grant Application Resource Guide](#) for additional information on completing the SF-424.

In Section 8F of the SF-424, please include the name and contact information of the individual **who will complete the application in JustGrants**. JustGrants will use this information (*email address*) to assign the application to this user in JustGrants.

Standard Applicant Information (JustGrants 424 and General Agency Information)

The "Standard Applicant Information" section of the JustGrants application is pre-populated with the SF-424 data submitted in Grants.gov. The applicant will need to review the Standard Applicant Information in JustGrants and make edits as needed. Within this section, the applicant will need to add ZIP codes for areas affected by the project; confirm their Authorized Representative; and verify and confirm the organization's unique entity identifier, legal name, and address.

Proposal Abstract

A Proposal Abstract (no more than 400 words) summarizing the proposed project — including its purpose, primary activities, expected outcomes, the service area, intended beneficiaries, and subrecipients (if known) — must be completed in the JustGrants web-based form. This abstract should be in paragraph form without bullets or tables, written in the third person, and exclude personally identifiable information. Abstracts will be made publicly available on the OJP and USASpending.gov websites if the project is awarded. See the [OJP Grant Application Resource Guide](#) for an example of a proposal abstract.

Proposal Narrative

The Proposal Narrative should be submitted as an attachment in JustGrants. The attached document should be double-spaced, using a standard 12-point font; have no less than 1-inch margins; and should not exceed 15 numbered pages. If the Proposal Narrative fails to comply with these length restrictions, [Insert PO] may consider such noncompliance in peer review and in final award decision.

The Proposal Narrative must include the following sections:

a. Description of the Issue

Describe why this project and these proposed activities are necessary (significance/value) and/or address a need. Provide supporting information, including a discussion of relevant research.

b. Project Design and Implementation

Describe the strategy to address the needs identified in the Description of the Issue.

List the proposed project activities and describe how they relate to the stated objectives. Activities are the specific actions to be undertaken to fulfill the program objectives and reach the program goal(s).

Provide a detailed description of the method(s) to be used to carry out each activity.

Describe the partnership with an evaluator and whether random assignment or another type of comparison group will be used.

Provide a timetable indicating roughly when the activities or program milestones will be accomplished.

If the applicant is seeking priority consideration for Priority 1(A), it should address in this section how the proposed project(s) will promote racial equity and the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality, and identify how the project design and implementation will specifically incorporate the input or participation of these communities.

c. Capabilities and Competencies

Describe the capabilities and competencies to accomplish the goals and objectives of the project.

Describe the roles and responsibilities of the evaluation partner in the project.

Describe the qualification of the evaluation partner and their prior experience working with correctional agencies and other partners to conduct rigorous evaluations.

If the applicant is seeking priority consideration under Priority 1(B), it should describe within this section how being a culturally specific organization (or funding a culturally specific subrecipient organization at a minimum of 40% of the project budget) will enhance its ability to implement the proposed project(s), should also specify which populations are intended or expected to be served or have their needs addressed under the proposed project(s), and should include the website address (if applicable) and formal or informal mission statement or principles of the culturally specific organization.

d. Plan for Collecting the Data Required for this Solicitation's Performance Measures

Describe the process for measuring project performance. Identify who will collect the data, who is responsible for performance measurements, and how the information will be used to guide and evaluate the project's impact.

Describe the process to accurately report data.

Note: An applicant is **not** required to submit performance data with the application. Rather, performance measure information is included as a notification that award recipients will be required to submit performance data as part of each award's reporting requirements. Some measures are presented as examples, while others are the exact measures that every recipient will be expected to address.

OJP will require each award recipient to submit regular performance data that show the completed work's results. The performance data directly relate to the goals, objectives, and deliverables identified in the "Goals, Objectives, and Deliverables" discussion. BJA will require award recipients to submit performance measure data and performance reports in JustGrants.
