#### **Edward Byrne Memorial Justice Assistance Grant Program**

The Edward Byrne Memorial Justice Assistance Grant (JAG) Program is the leading source of federal justice funding to state and local jurisdictions. The JAG Program provides funding to improve the functioning of the criminal justice system through flexible, multipurpose formula grants to states, local governments, and Indian tribes. Awards support a wide range of criminal justice and public safety initiatives, including law enforcement, prosecution and courts, crime prevention and education, corrections and community corrections, drug treatment and enforcement, victims services, technology for law enforcement, and mental health programs.

#### **Body-Worn Camera Policy and Implementation Program**

BJA's Body-Worn Camera (BWC) Policy and Implementation Program is for law enforcement agencies seeking to implement BWC programs. The grant supports the purchase of BWCs for pilot programs, full implementations, or expansion of existing programs. While the program supports the purchase of cameras and related technology, grantees must commit to broader program goals, including the development of sound and comprehensive BWC policies, effective management of digital media evidence, tracking the impact of BWC deployment on indices such as use of force and complaint against officers, and training of officers on BWC policy and related legal and regulatory concerns. Grant funds may be used to support the costs of BWCs and related equipment as well as the costs of training, policy development, and BWC program management.

# **Bulletproof Vest Partnership Program**

Through the Bulletproof Vest Partnership (BVP) Program, any government unit (states, counties, federally recognized Indian tribes, cities, and local jurisdictions) recognized by the U.S. Census Bureau that employs law enforcement officers is eligible to apply for funding for the sole purpose of purchasing bullet-resistant body armor for its sworn law enforcement officers. A jurisdiction's chief executive is required to complete the online registration and to provide general oversight and approval of key transactions between the BVP Program and the jurisdiction's participating law enforcement agencies. BVP recipients are reimbursed up to 50 percent of the cost of each unit of eligible body armor purchased.

#### **National Sexual Assault Kit Initiative**

The National Sexual Assault Kit Initiative assists law enforcement and prosecutors in addressing the challenges associated with unsubmitted sexual assault kits (SAKs) and reducing the number of unsubmitted SAKs in their jurisdictions. The initiative

provides evidence and tools to help solve and reduce the number of violent crimes associated with sexual assault while achieving the long-term goal of improving the criminal justice response to sexual assault cases. Using a victim-centered approach, jurisdictions build their capacities to inventory, test, and track SAKs and improve their practices related to investigation, prosecution, and victim engagement and support in connection with evidence and cases resulting from the testing process. The program also helps grantees prevent future development of conditions that lead to high numbers of unsubmitted SAKs.

### Stop School Violence Act Program

The Student, Teachers, and Officers Preventing (STOP) School Violence Act of 2018 authorized BJA to manage this grant program to support efforts by state and local units of government and federally recognized Indian tribes to prevent and reduce school violence. Specifically, it supports efforts to train school personnel and educate students to prevent student violence; develop and operate anonymous reporting systems concerning threats of school violence, including mobile telephone applications, hotlines, and websites; and develop and operate school threat assessment and mental health intervention teams that may include coordination with law enforcement agencies and school personnel. In addition, the program may fund specialized training for school officials in intervening with and responding to individuals with mental health issues who may threaten school safety.

### **National Motor Vehicle Title Information System Law Enforcement Access Tool**

The National Motor Vehicle Title Information System (NMVTIS) Law Enforcement Access Tool provides law enforcement with vehicle information from state motor vehicle titling agencies, automobile recyclers, junk and salvage yards, insurance carriers, National Crime Information Center vehicle theft information, and possible storm damage and clone information in one system. This information can assist law enforcement and department of motor vehicle investigators with numerous vehicle-related crimes. Access to this federal search tool is free to law enforcement and can be accessed with a Regional Information Sharing System (RISS) or an FBI Law Enforcement Enterprise Portal (LEEP) account.

In structuring COAP, BJA included effective policy strategies that support our nation's first responders and strengthens their partnerships with behavioral health, public health, and other agencies that serve crime victims; encourage and support comprehensive cross-system planning and collaboration among officials who work in law enforcement, pretrial services, the courts, probation and parole, child welfare, reentry, prescription drug monitoring programs, and emergency medical services, as well as health care providers, public health partners, and agencies that provide substance abuse treatment and recovery support services; and enhance public safety, behavioral health, and public health information-sharing partnerships.

### **Public Safety Officer Medal of Valor**

The Public Safety Officer Medal of Valor is the nation's highest award for valor by a public safety officer who exhibited exceptional courage, regardless of personal safety, in an attempt to save or protect human life. It is annually awarded in the name of Congress by the President to a person (living or deceased) who at the time of the valorous incident served in a public agency, with or without compensation, as a firefighter; law enforcement officer, including a correction, court, or civil defense officer; or emergency services officer, as determined by the U.S. Attorney General.
