Background

The <u>Death in Custody Reporting Act</u> (DCRA; Public Law 113-242) requires states to report to the Attorney General information regarding the death of any person who is either detained, under arrest, in the process of being arrested, en route to be incarcerated, or is incarcerated at a municipal or county jail, state prison, state-run boot camp prison, boot camp prison that is contracted out by the state, or any state or local contract facility, or other local or state correctional facility (including any juvenile facility). These death-in-custody data were previously captured by the Bureau of Justice Statistics (BJS).

In 2019, the Bureau of Justice Assistance (BJA) took over the aggregation of state and local mortality data on behalf of the Department of Justice. State Administering Agencies (SAAs) continue to be responsible for collecting these data on a quarterly basis from state and local entities including law enforcement agencies, local jails, correctional institutions, medical examiners, and other state agencies. SAAs then compile and submit the data to BJA as part of their Justice Assistance Grant reporting.

Colorado's plan to collect the Death In Custody Data (DCRA) involves the collaboration between two offices within the Division of Criminal Justice (DCJ). The Office of Adult and Juvenile Justice Assistance (OAJJA) works with the Office of Research and Statistics (ORS) to collect the data from the Department of Corrections and local Law Enforcement.

In Colorado, reporting is required to the Division of Criminal Justice, which is the SAA for the state. Please note that reporting is required for all persons:

- 1. Detained
- 2. Under arrest
- 3. In the process of being arrested
- 4. En route to be incarcerated
- 5. Incarcerated at a municipal or county jail, state prison, state-run boot camp prison, boot camp prison that is contracted out by the state, or any state or local contract facility, or other local or state correctional facility (including any juvenile facility)

I. DCRA Data Collection Infrastructure

The state of Colorado currently has state statute <u>C.R.S. Section-24-31-903</u> that requires law enforcement agencies to report on contacts, use of force, and deaths related to police activity to the Office of Research and Statistics. The Office of Adult and Juvenile Justice Assistance requests from Law Enforcement Agencies, State Prisons, and Juvenile Correctional facilities in addition to include reporting the DCRA required data.

A. Reporting Universe

B. Engaging Non-Reporting Agencies

- Once the non-reporting agencies are identified the ORS and OAJJA will reach out notifying them of the DCRA Reporting requirements and process. We will be creating an automated process for this so that as agencies report they will be removed from the next follow-up reminder.
- 2. Training and Technical Assistance will be offered to assist them to come into compliance.

C. Training and Technical Assistance Provided

- 1. Instructions document on the website.
- 2. Designated Email to ask questions or request assistance.

D. Training and Technical Assistance Needs

At this time, Colorado is not in need of any training or technical assistance.

II. DCRA Data Collection Methods

The Office of Adult and Juvenile Justice Assistance is responsible for collecting data of all Death's in Custody as the administering office of the Byrne Justice Assistance Grant.

A. Reporting Time Frames

SUMMARY OF REQUIREMENT

Each required reporting agency must submit DCRA data quarterly to the Office of Adult and Juvenile Justice Assistance. All agencies are required to submit either "no data to report this quarter" or any qualifying death within their facility.

All reporting agencies are required to submit their deaths in custody via the DCRA Reporting Form link located on the <u>DCRA Website</u> on a quarterly basis. See the data reporting dates in the table below:

Quarter	Quarter Time Frame	Due Date
Q1	October 1 through December 31 st	January 15th
Q2	January 1 through March 31st	April 15 th
Q3	April 1 through June 30 th	July 15 th
Q4	July 1 through September 30 th	October 15th

If a reporting agency does not have any deaths in custody to report for the quarter, they still are required to submit in the system that there is no data to report. This is to ensure that all agencies are accounted for and verified there is no qualifying data to be reported.

B. DCRA Reporting Process

SUMMARY OF REQUIREMENT

All Colorado law enforcement agencies, jails, and correctional facilities, both adult and juvenile, are subject to DCRA reporting and are required to submit that data to the Division of Criminal Justice through the via the DCRA Reporting Form.

Reporting is required for all persons:

- 1. Detained
- 2. Under arrest
- 3. In the process of being arrested
- 4. En route to be incarcerated
- 5. Incarcerated at a municipal or county jail, state prison, state-run boot camp prison, boot camp prison that is contracted out by the state, or any state or local contract facility, or other local or state correctional facility (including any juvenile facility)

Steps to report DCRA data:

- 1. Go to the DCJ Death in Custody Reporting Website.
- 2. Complete the <u>DCRA Reporting Form</u> and submit.
- 3. The form will be approved by DCJ and if there are questions they will be in contact with the submitter.

C. Required Data Points

SUMMARY OF REQUIREMENT

Each quarter, states must either (1) report all deaths in custody that occurred in their jurisdictions during the corresponding quarter and provide basic information about the circumstances of those deaths or (2) affirm that no deaths in custody occurred in their jurisdictions during the reporting period.

What Kinds of Deaths Count?

All types of deaths should be reported, including those due to:

- Accident
- Death attributed to use of force
- Homicide
- Natural causes
- Suicide
- Execution

Information Needed to Submit a Report

For each death in custody, states must report the following information:

- The decedent's name, date of birth, gender, race, and ethnicity
- The date, time, and location of the death
- The law enforcement or correctional agency that detained, arrested, or was in the

process of arresting the deceased; and

• A brief description of the circumstances surrounding the death

Reporting Requirements for No Deaths

Every agency listed in the DCRA Reporting Universe is required to report quarterly. If there are no DCRA incidents to report, that agency must submit that there were no deaths with a "zero report" response.

D. Data Verification and Quality Assurance

SUMMARY OF REQUIREMENT

All DCRA data submitted via the DCRA Reporting Form should be reviewed for accuracy or missing information.

Review of DCRA Data Submissions

The designated Division of Criminal Justice (DCJ) staff member or the manager of the Office of Adult and Juvenile Justice Assistance (OAJJA) will review each individual data submission.

The review will consist of:

- 1. Missing data fields
- 2. Data entry errors
- 3. Incorrect category selection
- 4. The need for additional information in the brief description leading up to the incident/death.

If the data reviewer finds any of the above errors, the DCRA Reporting Form will be returned and a request to submit the missing or corrected information will be made. Those change

requests will be monitored with in the data collection system to ensure the needed changes are made and the submission is completed. (process still in development)

E. Other Sources for Identifying Qualifying DCRA Incidents

SUMMARY OF REQUIREMENT

The designated DCJ staff or OAJJA manager will conduct regular searches to identify any DCRA incidents that were not reported by required entities.

Other Sources Available

- 1. News Media, Social Media, and the Internet
- 2. Local Coroners' Office (process is still in development)

Outreach Process

- The designated employee will obtain a copy of the media story, medical record, or other documents.
- 2. A letter and copy of the document will be sent to the corresponding law enforcement agency requesting the submission of a DCRA Reporting Form
- 3. The designated employee will track and confirm the DCRA Reporting Form submission.
- 4. Reminders will be sent until the form is submitted.

III. DCRA Data Reporting Methods

A. Reporting Data to BJA

SUMMARY OF REQUIREMENT

Each quarter, states must either (1) report all deaths in custody that occurred in their jurisdictions during the corresponding quarter and provide basic information about the circumstances of those deaths or (2) affirm that no deaths in custody occurred in their jurisdictions during the reporting period in BJA's Performance Measurement Tool (PMT) and submit the information by the reporting deadline.

Reporting Deadlines

Quarter	Quarter Time Frame	Due Date
Q1	October 1 through December 31st	January 31st
Q2	January 1 through March 31st	April 30 th
Q3	April 1 through June 30 th	July 31st th
Q4	July 1 through September 30 th	October 31 st

Submission Process

 The designated employee will pull the final quarterly data report from the DCRA Reporting data base for final review.

- 2. Data will be prepared in the proper template for a bulk upload to the BJA PMT.
- The designated employee will log in to the BJA PMT, answer the initial questions, upload the data template, certify the data, and submit.

B. Tracking Data for Updates

SUMMARY OF REQUIREMENT

Cases that have insufficient information or remain under investigation should be tracked by the designated employee to follow up on final determinations of the "manner of death"

Reasons for Tracking

- 1. If a DCRA data submission included an "unknown" data value
- 2. If the "manner of death" was reported as "unavailable or investigation pending,"

Process for Tracking DCRA Submission (process is still in development)

- 1. A data "error" flag will be indicated for that submission and will trigger a reminder email to the entity/individual who reported the data to submit updated information.
- 2. Those reminders will be monitored and cleared once a updated submission is received.
- 3. If the entity fails to submitted an updated form, notices will be sent every 30 days.
- 4. Direct outreach will follow if the entity fails to respond to the request after 90 days.

C. Updating Previous Data Entries

SUMMARY OF REQUIREMENT

All updated DCRA Reporting Forms and data need to be reported and updated in the BJA PMT quarterly.

Process for Updating DCRA Data Submissions

- 1. The designated employee will prepare the updated DCRA Data submission to be entered into the BJA PMT.
- 2. They will contact the BJA PMT Support Desk to request the needed reporting period/quarter is reopened for data corrections.
- 3. Individual Data will be updated and resubmitted.

IV. Conclusion

A. Defining Challenges

- 1. Consistent Use of Force Death reporting
- 2. Receiving updated information on "Unavailable" or "Pending Investigation" data
- 3. Implementing a Zero Reporting policy/requirement
- 4. Timely DCRA submissions. Agencies miss deadlines and the OAJJA has to identify those late submissions outside of the reporting period and go back in the PMT to add those submissions. When that occurs, those late submissions have to be manually updated because the bulk upload option is not available and will replace any existing data.

A. Overcoming Challenges

- 3. The best way to overcome most of our challenges is to increase the awareness of the requirements, training, and the provision of additional TA to local and state agencies.
- 4. The design and full implementation of our new DCRA Reporting Database and designing the "data error" flagging and reminder functions.
