#### Overview

The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>Bureau of Justice Assistance</u> (BJA) seeks applications for funding to state, local, and tribal governments, as well as community-based nonprofit organizations, to enhance or implement clinical services and other evidence-based activities or services to improve reentry, reduce recidivism, and address the treatment and recovery needs of people with mental health, substance use, or co-occurring disorders who are currently involved in the criminal justice system or were formerly involved. This program furthers the DOJ's mission by reducing recidivism and expanding access to effective treatment and recovery services.

This solicitation incorporates guidance provided in the <u>OJP Grant Application Resource Guide</u> which provides additional information for applicants to prepare and submit applications to OJP for funding. If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.

### **Program Description**

#### Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

The Second Chance Act (SCA) of 2007 (Public Law 110-199), reauthorized by the First Step Act of 2018, provides a comprehensive response to assist in the transition individuals make from prison, jail, or juvenile residential facilities to their communities so that the transition is more successful and promotes public safety. SCA and reentry-focused grant funding is designed to help communities develop and implement comprehensive and collaborative strategies that address the challenges posed by reentry and recidivism reduction. "Reentry" is not a specific program but rather an ongoing process that starts from the moment an individual is initially incarcerated and continues throughout that individual's transition from incarceration and reintegration into the community.

With this solicitation, BJA seeks to implement programming and services in response to the Crisis Stabilization and Community Reentry Act of 2020. It includes two categories for funding:

- Adult and Youth Crisis Stabilization and Community Reentry Programs—State and Local Governments
- Adult and Youth Crisis Stabilization and Community Reentry Programs—Nonprofit Organizations and Tribal Governments

Please note that community-based nonprofit organizations, including culturally specific organizations, are eligible and encouraged to apply under Category 2 of this program in partnership with correctional agencies. Eligible applicants under Category 1 are encouraged to partner with community-based organizations, including culturally specific organizations, to achieve the goals of this program. For additional information, see the Proposal Narrative, Budget and Associated Documentation and MOUs section of this solicitation.

The Improving Adult and Youth Crisis Stabilization and Community Reentry Program is part of the Second Chance Act suite of program in FY 2023. This year, a range of programs for states, local government units, tribal governments, and nonprofit organizations are being competed, including:

- · Community Reentry
- · Improving Adult Reentry, Education, and Employment Outcomes
- Improving Substance Use Disorder Treatment and Recovery Outcomes for Adults in Reentry
- · Pay for Success
- · Smart Supervision
- · Swift, Certain, and Fair Supervision and HOPE Institute

Additionally, the Comprehensive Opioid, Stimulant, and Substance Abuse Site-Based Program, the Residential Substance Abuse Treatment Program for State Prisoners, and the Justice and Mental Health Collaboration Program are three other BJA programs that support the provision of behavioral health treatment and services to individuals during and after incarceration.

Not all entities are eligible for all programs. Applicants are encouraged to review each solicitation in its entirety to determine their eligibility, if it fits their proposal, and if taking advantage of another funding opportunity could further enhance a comprehensive approach to supporting individuals with substance use and other co-occurring disorders treatment and recovery support needs that have come in contact with the justice system. Additional details on the SCA suite and other BJA programs can be found on the DOJ Grants Program Plan.

#### Statutory Authority

Pub. L. No. 90-351, Title I, Part OO (codified at 34 U.S.C. 10751-10755)

#### Specific Information

The Crisis Stabilization and Community Reentry Program supports state, local, and tribal governments, as well as community-based nonprofit organizations and eligible behavioral health providers, to coordinate and provide comprehensive treatment, recovery, and other supportive reentry services to people experiencing mental health, substance use, or co-occurring disorders who are currently involved in the criminal justice system or were formerly involved. Programs funded under this solicitation must make sure that individuals are screened, assessed, and identified for program participation and clinical services during pretrial detention or as early as possible upon incarceration and prior to release. Following release from incarceration or pretrial detention, participants should receive discharge planning and wraparound services based on the results of their screening and assessment that support continuity of care and long-term recovery in the community. These services may include benefit coordination, case management, evidence-based programming, peer support, enrollment in healthcare coverage, relapse prevention, suicide prevention, homelessness prevention, and clinically indicated medications. Services must focus on care coordination and collaboration.

The collaboratively designed series of treatment, recovery, and transitional services must make sure that individuals are set up for success before their transition, so that the transition from a prison, jail, or juvenile detention facility to the community is safe and successful. A comprehensive and collaborative crisis stabilization and community reentry program should include benefit and care coordination among government stakeholders, community-based organizations, behavioral health providers such as community mental health centers and certified community behavioral health clinics, and youth assessment centers. Programming must include recovery support services including trauma informed care, access to clinically indicated medication while in an incarcerated setting or developmentally appropriate services for youth cases, and continuity of care during reentry into the community based on the results of the screening and assessment. Working in collaboration with a BJA-sponsored technical assistance provider, successful applicants are expected to modify their administrative and clinical processes to include best practices and evidence-based interventions such as appropriate treatment and recovery supports, building coordinated partnerships among jurisdictional stakeholders, and training on program implementation, crisis response, treatment adherence, and continuity of recovery in the community.

Initially declared a public health emergency in October 2017, the opioid crisis remains a significant public health emergency. This crisis continues to take a devastating toll on the lives of individuals, families and communities across the nation. In recent years, the increase in synthetic opioids in the nation's drug supply has only served to exacerbate and expand the reach of this devastation with over 100,000 drug overdose deaths in 2021, an increase of almost 15% from the prior year. Centers for Disease Control and Prevention data also show that overdose deaths disproportionately impact Black and American Indian/Alaska Native people.

To combat the morbidity and mortality of overdose and the chronic disease of opioid use disorder

(OUD) it is critical that individuals with OUD have access to evidence-based, FDA-approved treatments. The Biden-Harris Administration has made addressing the overdose epidemic a priority, including increasing access to evidence-based treatment—namely, medications for opioid use disorder (MOUD)—across all settings.

In April 2022, the Department of Justice's Civil Rights Division published <u>guidance</u> further clarifying protections under the Americans with Disabilities Act (ADA) for individuals with OUD, including potential violations of the ADA by facilities or programs that do not allow individuals to be able to continue taking doctor-prescribed MOUD. Recent agreements with <u>state and county correctional facilities</u> resolved <u>allegations</u> that the entities' refusal to permit the use of and provide MOUD violates the ADA. Similarly, a DOJ <u>findings report</u> regarding suicides and failure to provide MOUD in a county jail also helps to illustrate specific instances that were considered to violate the 8<sup>th</sup> and 14<sup>th</sup> amendment rights of institutionalized persons. Both the guidance and enforcement matters reflect the federal government's position that a correctional facility's refusal to permit incarcerated individuals to continue or initiate treatment for opioid use disorders when clinically needed may violate the ADA, the Constitution, or both.

This information is intended to educate and inform you and your partners in considering your application to this solicitation; ways that this and other funding opportunities could help to further enhance your capacity to identify, screen, and assess individuals that may have substance use disorder treatment and recovery support needs; and your work generally in support of the treatment and long-term recovery of individuals with substance use disorder.

#### Goals, Objectives, and Deliverables

#### Goals

Provide clinical and recovery support services that support treatment, suicide prevention, and continuity of recovery in the community for people with mental health, substance use, or co-occurring disorders upon their release from a correctional facility.

#### Objectives

An applicant should address all the objectives that are relevant to their proposed program/project in the Goals, Objectives, Deliverables and Timeline web-based form.

Provide training and education for criminal and juvenile justice agencies, mental health and substance use agencies, and community-based behavioral health providers on interventions that support:

- · Best practice diversion models
- · Crisis response services
- Engagement in recovery, treatment, and other support services
- Access to medication while incarcerated and continuity of care during reentry into the community

Confirmation of memoranda of understanding/agreements (MOUs/MOAs) and a description of partnerships with one or more correctional agencies, if the correctional agency is not the lead applicant.

Make sure that individuals with serious mental illness are given timely access to appropriate recovery supports that may include peer support services, medication management (including long-acting injectable medications where clinically appropriate), case management, and psychosocial therapies.

#### Deliverables

An action plan informed by and based on data developed with input from BJA and the assigned technical assistance provider and submitted within 6 months of receiving final budget approval.

A final report at the end of the project period.

To receive this consideration, the applicant must describe how the proposed project(s) will address potential racial inequities and contribute to greater access to services and opportunities for communities that have been historically underserved, marginalized, and adversely affected by inequality, and identify how the project design and implementation will specifically incorporate the input or participation of those communities and populations disproportionately impacted by crime, violence, and the criminal justice system overall. Examples addressing this requirement include, but are not limited to, the following: budgeted project planning and/or implementation meetings with community stakeholders representing historically underserved and marginalized communities; outreach and/or public awareness campaigns specifically tailored to historically underserved and marginalized communities to encourage participation in the proposed project(s); budgeted incorporation of members representing historically underserved and marginalized communities in program evaluation, surveys, or other means of project feedback; and partnership

B. Applicants that demonstrate that their capabilities and competencies for implementing their proposed project(s) are enhanced because they (or at least one proposed subrecipient that will receive **at least 40%** of the requested award funding, as demonstrated in the Budget Web-Based Form) identify as a *culturally specific organization*.

To receive this additional priority consideration, applicants must describe how being a culturally specific organization (or funding the culturally specific subrecipient organization(s)) will enhance their ability to implement the proposed project(s) and should also specify which populations are intended or expected to be served or to have their needs addressed under the proposed project (s).

Culturally specific organizations are defined for the purposes of this solicitation as private nonprofit or tribal organizations whose primary purpose as a whole is to provide culturally specific services to racial and ethnic groups, including, among others, Black people, Hispanic and Latino people, Native American and other Indigenous peoples of North America (including Alaska Native, Eskimo, and Aleut). Asian Americans. Native Hawaiians, and/or Pacific Islanders.

#### 2. Additional statutory priority considerations

As articulated in the Crisis Stabilization and Community Reentry Act of 2020, priority consideration will be given to applications that make sure program participants receive care continuously and without breaks in service through a Community Care Provider Program and adopt policies that focus on programming, strategies, and educational components for reducing recidivism and probation violations.

For the purposes of this priority, continous care shall involve the coordination of the correctional facility treatment program with qualified community behavioral health providers and other recovery supports, pretrial release programs, parole supervision programs, halfway house programs, and participation in peer recovery group programs, which may help in ongoing recovery after the individual is released from the correctional facility.

For the purposes of this priority, Community Care Provider Program means a community mental health center or certified community behavioral health clinic that directly provides to an individual, or assists in connecting an individual to the provision of, appropriate community-based treatment, medication management, and other recovery support services when the individual leaves a correctional facility at the end of a sentence or on parole.

To receive priority consideration under any of the areas listed earlier, applicants must specify, in the proposal narrative, how they will address the priority.

Note: Addressing these priority areas is one of many factors that OJP considers in making funding decisions. Receiving priority consideration for one or more priority areas does not guarantee an award.

Clearly specify and describe the validated assessment tool or tools used by the correctional agency, the community corrections agency, and/or the applicant to determine the risk level and

identify the criminogenic, and mental health and substance use disorder needs of the individuals to be referred to the program. Specify when the assessment and reassessment occur and by which agencies.

#### b. Project Design and Implementation

Describe the plan to provide transitional support, clinical, and reentry services to individuals returning from incarceration during the program period. Provide:

Confirmation of memorandums of understanding/agreements (MOUs/MOAs) and a description of partnerships with one or more correctional agencies, if the correctional agency is not the lead applicant.

The processes the applicant will use to identify and recruit potential participants and match services to their identified reentry and clinical needs, including:

The prerelease (if applicable) and post-release services that will be available to assist in the reintegration of formerly incarcerated individuals, whether provided by the applicant or a partner organization, including how case management and other evidence-based services will be integrated with connection to clinical care and recovery services and supports.

The process for matching pre-release (if applicable) and post-release services based on collaborative comprehensive case planning, including criminogenic risk and needs identified through the validated assessment, as well as substance use and mental health disorders.

A description of the target population, including the eligibility requirements, the number proposed to be served, and the justification and demonstration that this is a manageable number.

A description of how and by whom individuals will be referred to and accepted into grant program funded services.

A description of the plan for strengthening or developing crisis response services delivered by hotlines, mobile crisis teams, crisis stabilization and triage centers, peer support specialists, public safety officers, community-based behavioral health providers, and other stakeholders, including by providing technical support for interventions that promote long-term recovery.

A description of, and supporting documentation and letters of support for, engaging criminal and juvenile justice agencies, mental health agencies and community-based behavioral health providers, peer support networks, preliminary qualified representatives of the target population, family members of incarcerated individuals, and community residents and stakeholders in program design, program implementation, and training on crisis response services, including connection to recovery services and supports.

If the applicant is seeking priority consideration for Priority 1(A), it should address in this section how the proposed project(s) will promote racial equity and the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality, and identify how the project design and implementation will specifically incorporate the input or participation of these communities. Likewise, if the applicant is seeking statutory priority consideration, it should specifically address how this priority will be met (see section on statutory priority consideration).

#### c. Capabilities and Competencies
