Overview

The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>Bureau of Justice</u> <u>Assistance</u> (BJA), in partnership with the <u>U.S. Department of Homeland Security</u> (DHS), <u>Office</u> <u>of Intelligence & Analysis</u> (I&A), is seeking applications to support the standardization of information-sharing practices and the identification and sharing of state, local, Tribal, and territorial (SLTT) information-sharing exchange promising practices and lessons learned.

This program furthers DOJ's mission and the Attorney General's priorities by addressing national security issues through supporting and assisting state, local, Tribal, and territorial law enforcement to prevent acts of domestic terrorism and other threats within their jurisdictions while safeguarding the privacy, civil rights, and civil liberties (P/CRCL) of all citizens.

Program Description

Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

The BJA State, Local, Tribal, and Territorial Information Sharing Technical Assistance Program seeks applications to support the standardization of information-sharing practices and the identification and sharing of state, local, Tribal, and territorial information-sharing exchange promising practices and lessons learned.

Statutory Authority

This solicitation is supported by funds incoming from DHS, pursuant to 31 U.S.C. §§ 1535 and 1536.

Specific Information

The BJA State, Local, Tribal, and Territorial Information Sharing Technical Assistance Program is a collaborative effort with the DHS Office of Intelligence and Analysis (I&A) and the DOJ, in partnership with the Office of the Director of National Intelligence (ODNI), the Federal Bureau of Investigation (FBI), and experts from the state and local community—including the Global Justice Information Sharing Initiative (Global) and the Criminal Intelligence Coordinating Council (CICC). These entities have worked together to facilitate the development of SLTT intelligence and analytic capabilities. Through discrete, targeted activities such as workshops, seminars, information-sharing exchanges, guidance documents, and technical assistance offerings, this consortium has achieved significant success in providing the support necessary to assist the SLTT partners in improving their capability and capacity as required by and in accordance with national policy guidance, including the National Strategy for Information Sharing (NSIS), the Fusion Center Guidelines, and the Baseline Capabilities for State and Major Urban Area Fusion Centers.

Goals, Objectives, and Deliverables

Goals

The goals of this project include the following:

- Information-sharing Projects: In coordination with DOJ, ODNI, the FBI, and other applicable partners, provide support to select information-sharing projects as prioritized by the CICC and/or the State and Local Intelligence Council (SLIC). The CICC and the SLIC include SLTT and federal law enforcement and homeland security entities, which are integral to ensuring the standardization of information-sharing practices with a particular focus on safeguarding the P/CRCL of all citizens.
- SLTT Partner Operational Information-sharing Exchanges: Provide support to SLTT

b. Project Design and Implementation

Provide a complete description of the project's design and proposed implementation. Applications must relate information and criminal intelligence sharing to the objectives and performance measures and include a comprehensive discussion of how the project will ensure coordination among all appropriate federal, state, local, Tribal, and territorial public safety entities.

c. Capabilities and Competencies

Page 12 of 25 O-BJA-2023-171802 Fully describe the applicant's capabilities to implement this SLTT project and the competencies of the staff assigned to oversee the project. Applications must identify personnel critical to the project's successful implementation and discuss their roles, responsibilities, and qualifications, as well as discuss the organizational capabilities or competencies that will directly inform the ability to successfully implement the proposed enforcement project.

d. Plan for Collecting the Data Required for this Solicitation's Performance Measures

Describe the process for measuring project performance. Identify who will collect the data; who is responsible for performance measurements; and how the information will be used to guide and evaluate the project's impact. Describe the process to accurately report data.
