With this solicitation, BJA seeks applications for funding programs that support cross-system collaboration to improve public safety responses and outcomes for individuals with mental health disorders (MHDs) or co-occurring mental health and substance use disorders (MHSUDs). BJA provides grant funding to help organizations prepare, create, or expand comprehensive plans and then implement these collaborative projects to target people who qualify.

This program furthers the DOJ's mission to uphold the rule of law, to keep our country safe, and to protect civil rights.

Program Description

Program Description Overview

With this solicitation, BJA seeks applications for funding programs that support cross-system collaboration to improve public safety responses and outcomes for individuals with mental health disorders (MHDs) or co-occurring mental health and substance use disorders (MHSUDs). BJA provides grant funding to help organizations prepare, create, or expand comprehensive plans and then implement these collaborative projects to target people who qualify.

This program furthers the DOJ's mission to uphold the rule of law, to keep our country safe, and to protect civil rights.

Statutory Authority

Public Law No. 90-351, Title I, Sec. 2991 (codified at 34 U.S.C. 10651); (Public Law No. 117-103, 136 Stat. 49, 127). Any awards under this solicitation would be made under statutory authority provided by the Consolidated Appropriations Act, 2024. As of the writing of this solicitation, the Department of Justice is operating under a short-term Continuing Resolution with no full-year appropriation for the Department being enacted for FY 2024 currently.

Specific Information

The Justice and Mental Health Collaboration Program (JMHCP) specifically funds collaborative programs to reduce criminal justice involvement by and improve outcomes for individuals with MHDs or MHSUDs who come into contact with the criminal justice system or are leaving a custodial setting. Program activities include:

- Connecting individuals who have MHDs or MHSUDs with treatment and social services through support for the 988 <u>Suicide & Crisis Lifeline</u>.
- Connecting individuals who have MHDs or MHSUDs with programs and services including case management, crisis stabilization units and pre-arrest diversion.
- Creating or expanding mental health courts or other court-based approaches to preliminarily qualified individuals.
- Increasing prosecutor- or defense-led diversion strategies.
- Creating connections with entities and/or providing supported employment services for people with behavioral health conditions.
- Utilizing specialized caseloads for probation.
- Cross-system training of public safety officials and mental health providers.
- Increasing intergovernmental cooperation between state and local governments to support individuals with MHDs or MHSUDs.

For the purposes of this FY24 solicitation, JMHCP will focus on pretrial, prosecution, courts, probation/parole, and addressing the needs directly related to the criminal activity of adults with mental health conditions, living in homelessness or marginalized communities with minimal access to treatment, needing wrap around services, in the criminal justice system and leaving incarceration. BJA will only accept applications that demonstrate the proposed program will be administered jointly by an agency with responsibility for criminal or juvenile justice activities and a mental health agency.

Per the authorizing statute, JMHCP requires a two-phase process consisting of planning and then implementation activities during which grantees will develop a coordinated approach to

implementing or enhancing services for individuals with MHDs or MHSUDs who come into contact with the criminal justice system. Applicants must submit one application that proposes detailed activities for both a planning phase and an implementation phase. Solicitation Goals and Objectives

Goals

The goal of JMHCP is to improve outcomes for adults with mental health disorders, co-occurring mental health and substance use disorders, and people with intellectual and developmental disabilities who come into contact with the criminal justice system.

Objectives

With this solicitation, JMHCP supports grants to help eligible entities plan, implement, or expand comprehensive collaboration programs to improve public safety and public health for preliminarily qualified individuals with MHDs (including people with traumatic brain injury (TBI) and post-traumatic stress disorder (PTSD)) or MHSUDs who come in contact with the criminal justice system. The definition of "preliminarily qualified offender" is outlined in the 21st Century Cures Act and codified at 34 U.S.C. 10651(9)(A). Deliverables

Identify and publish strategies for validated screening and assessment within courts, probation/parole, and jails/prisons to identify people with MHDs and MHSUDs.

Develop and disseminate strategies to implement Medicaid 1115 demonstration waivers, as well as other relevant Medicaid waivers and state plan amendment opportunities to improve continuity of care and connections to treatment for people with MHDs and MHSUDs who come into contact with the criminal justice system.

Create national policy guidance in court case processing and strategies for states that provides relief to the courts and strengthens community collaboration.

Priority Areas

In order to further OJP's mission, OJP will provide priority consideration when making award decisions to the following:

1A. Applications that propose project(s) that are designed to meaningfully advance equity and remove barriers to accessing services and opportunities for communities that have been historically underserved, marginalized, adversely affected by inequality, and disproportionately impacted by crime, violence, and victimization.

To receive this consideration, the applicant must describe how the proposed project(s) will address identified inequities **and** contribute to greater access to services and opportunities for communities that have been historically underserved, marginalized, adversely affected by inequality, and disproportionately impacted by crime, violence, and victimization. Project activities under this consideration may include but are not limited to the following: improving victim services, justice responses, prevention initiatives, reentry services and other parts of an organization's or community's efforts to advance public safety. Applicants should propose activities that address the cultural (and linguistic, if appropriate) needs of communities, outline how the proposed activities will be informed by these communities, and implement culturally responsive and inclusive outreach and engagement.

1B. Applicants that demonstrate that their capabilities and competencies for implementing their proposed project(s) are enhanced because they (or at least one proposed subrecipient that will receive **at least 40 percent** of the requested award funding, as demonstrated in the Budget web-based form) are a *population specific organization* that serves communities that have been historically underserved, marginalized, adversely affected by inequality, and disproportionately impacted by crime, violence, and victimization.

For purposes of this solicitation, population specific organizations are nonprofit, nongovernmental, or Tribal organizations that primarily serve members of a specific underserved population and have demonstrated experience and expertise providing targeted services to members of that specific underserved population.

To receive this additional priority consideration, applicants must describe how being a population specific organization or funding the population specific subrecipient organization(s) will enhance their ability to implement the proposed project(s) and should also specify which historically underserved populations are intended or expected to be served or have their needs addressed under the proposed project(s).

- **2.** In addition to executing any OJP priority areas listed above the programmatic priority areas for consideration are:
 - Promote effective strategies for identification and treatment of females with MHDs who are involved with the criminal justice system.
 - Promote effective strategies to expand the use of mental health courts and related services.
 - Propose interventions that have been shown by empirical evidence to reduce recidivism.
 - When appropriate, use validated assessment tools to identify and prioritize individuals with a moderate or high risk of recidivism and a need for treatment services.
 - Demonstrate and ensure that funds are used for public health and public safety.
 - Demonstrate active participation of co-applicants in administering the program.
 - Document, in whole or in part, that funds used for treatment of incarcerated populations will provide transition and reentry services for such individuals.

To receive priority consideration under any of these areas, applicants must identify, in the proposal abstract, each area for which priority consideration is being sought and then describe, in the proposal narrative, how they will address each priority.

OJP may, in certain cases, provide additional funding in future years to awards made under this funding opportunity through continuation awards. Availability of Funds

This funding opportunity, and awards under this funding opportunity, are subject to the availability of funding and to any changes or additional requirements that may be imposed by the agency or by law. In addition, nothing in this solicitation is intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against the United States, its departments, agencies, or entities, its officers, employees, or agents, or any other person.

OJP expects to make awards under this funding opportunity as grants. How To Apply

Registration

If an applicant does not renew their SAM.gov registration, it will expire. An expired registration can delay or prevent application submission in Grants.gov and JustGrants. Applicants are encouraged to start the SAM.gov registration process at least 30 days prior to the application deadlines. Applicants who fail to begin the registration or renewal process at least 10 business days prior to the Grants.gov deadline may not complete the process in time and will not be considered for late submission.

Submission

Applications must be submitted to DOJ electronically through a two-step process that begins in Grants.gov and is completed in JustGrants.

Step 1: After registering with SAM.gov, the applicant must submit the SF-424 and SF-LLL in Grants.gov at https://grants.gov/register by the Grants.gov deadline. To leave time to address any technical issues that may arise, an applicant should submit the SF-424 and SF-LLL as early as possible and recommended not later than 48 hours before the Grants.gov deadline.  - Provide a timetable/project plan indicating roughly when the activities or program milestones are to be accomplished and who is responsible.
 - Address whether any of the program-specific priority areas have been met.

Deliverables Expected by Successful Applicants

Per the authorizing statute, JMHCP requires a two-phase process consisting of planning and then implementation activities, during which grantees will develop a coordinated approach to implementing or enhancing services for individuals with MHDs or MHSUDs who come in contact with the criminal justice system. Applicants must submit one application that proposes detailed activities for both a planning phase and an implementation phase.

The planning phase will be up to 12 months long, during which the recipient will have access to only \$100,000 in award funds for completion of the phase. The implementation phase will begin once the grantee has met the requirements of the planning phase, to include the recipient's completion and BJA's approval of the required "Planning and Implementation Guide," and it will continue for the remaining time of the grant.

Budget/Financial Attachments
