Synopsis

Program Description Overview

The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>Bureau of Justice Assistance</u> (BJA) is seeking applications for funding.

OJP is committed to advancing work that promotes civil rights and equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety, protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

With this solicitation, BJA seeks to fund organizations to serve as financial intermediaries to community-based reentry programs (subawardees) and to provide support via an incubator model in order to increase capability and capacity within the subawardees' organizations.

This program furthers the DOJ's mission to uphold the rule of law, to keep our country safe, and to protect civil rights.

Eligibility

 Nonprofits having a 501(c)(3) status with the IRS, other than institutions of higher education

An applicant may submit more than one application, if each application proposes a different project in response to the solicitation. Also, an entity may be proposed as a subrecipient (subgrantee) in more than one application.

BJA will consider applications under which two or more entities (project partners) would carry out the federal award; however, only one entity may be the applicant for the solicitation. Any others must be proposed as subrecipients (subgrantees). See the <u>Application Resource Guide</u> for additional information on subawards.

BJA may choose to fund applications submitted under this FY 2024 solicitation in future fiscal years, dependent on, among other considerations, the merit of the applications and the availability of appropriations.

Program Description

Program Description Overview

With this solicitation, BJA seeks to fund organizations to serve as financial intermediaries to community-based reentry programs (subawardees) and to provide support, via an incubator model, to increase capability and capacity within the subawardees' organizations. This program furthers the DOJ's mission to uphold the rule of law, to keep our country safe, and to protect civil rights.

Statutory Authority

Pub. L. No. 110-199, Sec. 211 (codified at 34 U.S.C. 60531); Department of Justice Appropriations Act, 2024 (Pub. L. No. 118-42, 138 Stat. 25, 148)

Specific Information

The purpose of the Second Chance Act (SCA) Community-based Reentry Incubator Initiative is to fund intermediary organizations ("awardees") to operate incubator models in order to build capability, capacity, and sustainability among community- and faith-based organizations ("subawardees") that are serving people returning home from incarceration.

For this solicitation, awardees are community-based organizations (CBOs) that are experienced at delivering reentry services, managing federal grants, administering subawards, and training others to do the same. Awardees will operate incubators—learning communities where subawardees can learn and grow—to help smaller CBOs enhance the delivery of reentry services and their operation management. Awardees will also have fiscal and administrative oversight of subawardees funding and projects. Subawardees are envisioned to be CBOs that are operating on a smaller scale and seeking to increase their organizational capacity and their capacity to deliver reentry services.

This solicitation seeks applications from CBOs to be awardees and operate an incubator for subawardees, as described earlier. Awardees will, in concert with BJA, select subawardees to participate in the incubator. To that end, applicants should submit proposals to operate incubators and describe their experience with reentry programming across a variety of settings, managing federal subawards, and building capacity of CBOs to implement reentry programming.

Subawards are expected to range between \$50,000 and \$150,000. Applicants are encouraged to include plans and proposed criteria in their proposals for identifying and selecting the subrecipients. OJP must approve the application process, selection criteria, and selection of subrecipients recommended by the applicant. The process and design should recognize and serve the capacity limitations of smaller entities to apply for and administer grant funding, suggest methods to build capacity while also ensuring accountability to reach the desired program outcomes, and propose cost effective approaches.

Subawards may include salary support, equipment, materials, training opportunities, and travel costs. Funds may also be used for developing curricula, assessment tools, or organizational policies and procedures, such as wellness plans to support reentry service provider staff. In administering financial support through subawards, intermediary organizations are responsible for ensuring that all funds are used appropriately according to the applicable accounting and financial management principles as set forth in the DOJ Grants Financial Guide.

BJA is open to a range of incubator models. Applicants may propose to focus on a particular geographic area (e.g., region) or subject matter (e.g., employment). Awardees are expected to include the following critical elements in their proposed projects:

- Propose budgets that pass-through at least 70 percent of the award to subawardees and retain 30 percent to support their work as an intermediary and technical assistance provider. For example, if the applicant applies for the maximum available award amount of \$4,000,000, BJA would expect \$2,800,000 be subawarded.
- In collaboration with BJA, competitively select CBOs to receive subawards of \$50,000– \$150,000.
- Provide training and technical assistance (TTA) support to the selected subawardees to implement new reentry programs or expand and/or enhance existing programs.
- Provide TTA support for subawardees to build their capacity and sustain those new capacities following the end of the project.

If applicable, applicants seeking statutory priority consideration should budget no more than 10 percent of the federal requested amount to contract and manage an independent process and outcome evaluation. This would reduce the proposed final budget amounts for the intermediary by 5% and reduce the proposed final budget amounts for the subawardees by 5 percent. The requirements for subrecipient monitoring can be found in 31 U.S.C. § 7502 and in Title 2.C.F.R.. § 200 (including, but not limited to, the sections on "Subrecipient Monitoring and Management" contained in Subpart D and audit requirements applicable to subrecipients contained in Subpart F).

The Community-based Reentry Incubator Initiative Program is part of the SCA suite of programs. In FY 2024, a range of other programs for states, local government units, tribal governments, and nonprofit organizations are being competed, including:

- Community-based Reentry
- Community Supervision Strategies
- Crisis Stabilization and Community Reentry
- Improving Adult Reentry, Education, and Employment Outcomes
- Improving Substance Use Disorder Treatment and Recovery Outcomes for Adults in Reentry

- Smart Supervision

Solicitation Goals and Objectives

Goals

Build programmatic, financial, and organizational capacity in CBOs and faith-based institutions to provide sustainable and effective services to people leaving incarceration that focus on community and family reintegration, building strengths-based assets, and reducing recidivism (including reducing arrests, new charges, convictions for new offenses, and reincarceration).

Objectives

Increase the administrative, operational, and organizational capacity of subawardees to serve the target population effectively using comprehensive case management plans and validated criminogenic risk assessments to deliver or facilitate reentry services in a manner consistent with participants' learning styles and abilities.

Ensure the responsible and effective administration of subawards to competitively selected CBOs providing reentry services to individuals transitioning from jail or prison to the community.

Priority Areas

In order to further OJP's mission, OJP will provide priority consideration when making award decisions to the following:

1A. Applications that propose project(s) that are designed to meaningfully advance equity and remove barriers to accessing services and opportunities for communities that have been historically underserved, marginalized, adversely affected by inequality, and disproportionately impacted by crime, violence, and victimization.

To receive this consideration, the applicant must describe how the proposed project(s) will address identified inequities **and** contribute to greater access to services and opportunities for communities that have been historically underserved, marginalized, adversely affected by inequality, and disproportionately impacted by crime, violence, and victimization. Project activities under this consideration may include but are not limited to the following: improving victim services, justice responses, prevention initiatives, reentry services and other parts of an organization's or community's efforts to advance public safety. Applicants should propose activities that address the cultural (and linguistic, if appropriate) needs of communities, outline how the proposed activities will be informed by these communities, and implement culturally responsive and inclusive outreach and engagement.

1B. Applicants that demonstrate that their capabilities and competencies for implementing their proposed project(s) are enhanced because they (or at least one proposed subrecipient that will receive **at least 40 percent** of the requested award funding, as demonstrated in the Budget web-based form) are a *population specific organization* that serves communities that have been historically underserved, marginalized, adversely affected by inequality, and disproportionately impacted by crime, violence, and victimization.

For purposes of this solicitation, population specific organizations are nonprofit, nongovernmental, or Tribal organizations that primarily serve members of a specific underserved population, and have demonstrated experience and expertise providing targeted services to members of that specific underserved population.

To receive this additional priority consideration, applicants must describe how being a population specific organization (or funding the population specific subrecipient organization(s)) will enhance their ability to implement the proposed project(s), and should also specify which historically underserved populations are intended or expected to be served or have their needs addressed under the proposed project(s).

Continuation Funding Intent

OJP may, in certain cases, provide additional funding in future years to awards made under this funding opportunity through continuation awards. OJP will consider, among other factors, OJP's strategic priorities, a recipient's overall management of the award, and the progress of the work funded under the award, when making continuation award decisions.

Availability of Funds

This funding opportunity, and awards under this funding opportunity, are subject to the availability of funding and to any changes or additional requirements that may be imposed by the agency or by law. In addition, nothing in this solicitation is intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against the United States, its departments, agencies, or entities, its officers, employees, or agents, or any other person.

OJP expects to make awards under this funding opportunity as cooperative agreements, which provide for OJP to have substantial involvement in carrying out award activities. This solicitation (notice of funding opportunity) incorporates guidance provided in the OJP Grant Application Resource Guide (Application Resource Guide), which provides additional information for applicants to prepare and submit applications to OJP for funding. If this solicitation requires something different from any guidance provided in the Application Resource Guide, the difference will be noted in this solicitation and the applicant is to follow the guidelines in this solicitation, rather than the guidance in the Application Resource Guide that is in conflict.

How To Apply

Registration

Before submitting an application, all applicants must register with the System for Award Management (SAM.gov). An applicant must renew their registration every 12 months. If an applicant does not renew their SAM.gov registration, it will expire. An expired registration can delay or prevent application submission in Grants.gov and JustGrants. Applicants are encouraged to start the SAM.gov registration process at least 30 days prior to the application deadlines. Applicants who fail to begin the registration or renewal process at least 10 business days prior to the Grants.gov deadline may not complete the process in time and will not be considered for late submission.

Submission

Applications must be submitted to DOJ electronically through a two-step process that begins in Grants.gov and is completed in JustGrants.

Step 1: After registering with SAM.gov, the applicant must submit the SF-424 and SF-LLL in Grants.gov at https://grants.gov/register by the Grants.gov deadline. To leave time to address any technical issues that may arise, an applicant should submit the SF-424 and SF-LLL as early as possible and recommended not later than 48 hours before the Grants.gov deadline. If an applicant fails to submit in Grants.gov by the deadline, they will be unable to apply in JustGrants. Applicants can confirm Grants.gov submission by verifying their application status shows as "submitted" or "agency tracking number assigned."

Step 2: The applicant must then submit the **full application**, including attachments, in JustGrants at JustGrants.usdoj.gov by the JustGrants deadline.

OJP recommends that applicants submit the complete application package in JustGrants at least 48 hours prior to the JustGrants deadline. Some of the required sections of the application will be entered directly into JustGrants, and other sections will require documents to be uploaded and attached. Experiencing Unforeseen Technical Issues Preventing Submission of an Application (Technical Waivers)

OJP will only consider requests to submit an application after the deadline when the applicant can document that a technical issue with a government system prevented submission of the application on time.

If an applicant misses a deadline due to unforeseen technical issues with SAM.gov, Grants.gov, or JustGrants, the applicant may request a waiver to submit an application after the deadline. However, the waiver request will not be considered unless it includes documentation of attempts to receive technical assistance to resolve the issue prior to the application deadline. Entity and User Verification (First Time Applicant)

Proposal Abstract

This abstract should be in paragraph form without bullets or tables, written in the third person, and exclude personally identifiable information. Abstracts will be made publicly available on the OJP and USASpending.gov websites if the project is awarded. See the Application Resource Guide for an example of a proposal abstract.

Data Requested With Application

The following application elements should be submitted in the web-based forms in JustGrants.

Financial Management and System of Internal Controls Questionnaire (including Applicant Disclosure of High Risk Status)

Proposal Narrative

Describe the challenges for CBOs in applying for and managing public and private grant funds.

b. Project Design and Implementation

Identify strategies for designing and implementing the deliverables described in this solicitation.
