### **Synopsis**

#### **Program Description Overview**

The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>Bureau of Justice Assistance</u> (BJA) is seeking applications for funding.

OJP is committed to advancing work that promotes civil rights and equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety, protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

With this solicitation, BJA seeks a training and technical assistance (TTA) provider with expertise in working with communities to improve access to integrated treatment for justice-involved individuals with co-occurring mental health and substance use disorders (MHSUDs). The provider will work with BJA to lead a national TTA program and administer subawards to local demonstration sites. The program will promote cross-system collaboration among justice stakeholders, behavioral health service providers, and community support organizations to improve access to integrated treatment for individuals with co-occurring mental health and substance use disorders.

This program furthers the DOJ's mission to uphold the rule of law, to keep our country safe, and to protect civil rights.

#### **Eligibility**

- Public- and State-controlled institutions of higher education
- Nonprofits having a 501(c)(3) status with the IRS, other than institutions of higher education
- Nonprofits that do not have a 501(c)(3) status with the IRS, other than institutions of higher education
- Private institutions of higher education
- For-profit organizations other than small businesses
- Small businesses

BJA will consider applications under which two or more entities (project partners) would carry out the federal award; however, only one entity may be the applicant for the solicitation. Any others must be proposed as subrecipients (subgrantees). See the <u>Application Resource Guide</u> for additional information on subawards.

BJA may choose to fund applications submitted under this FY 2024 solicitation in future fiscal years, dependent on, among other considerations, the merit of the applications and the availability of appropriations.

### **Program Description**

#### **Program Description Overview**

With this solicitation, BJA seeks a training and technical assistance (TTA) provider with expertise in working with communities to improve access to integrated treatment for justice-involved populations with co-occurring mental health and substance use disorders (MHSUDs). The provider will work with BJA to lead a national TTA program and administer subawards to local demonstration sites. The program will promote cross-system collaboration among justice stakeholders, behavioral health service providers, and community support organizations to improve access to integrated treatment for individuals with co-occurring MHSUDs.

#### **Statutory Authority**

Department of Justice Appropriations Act, 2024 (Pub. L. No. 118-42, 138 Stat. 25, 148-49); Pub. L. No. 90-351, Title I, Sec. 2991 (codified at 34 U.S.C. 10651)

#### **Specific Information**

More than 1 in 9 adults with co-occurring MHSUDs are arrested annually. Individuals with cooccurring MHSUDs involved with the criminal justice system face unique challenges and are more susceptible to further criminal justice involvement. They are less likely to post bond and be released before trial, more likely to be sentenced to jail or prison, experience longer periods of incarceration, and are often placed in settings that may aggravate mental health symptoms. Post arrest, there are opportunities for people involved in the justice system with co-occurring disorders to be connected to services in the community that can improve these outcomes. The combination of mental health and substance use disorders, if left untreated, can be disabling and may require the coordination of services and systems for effective treatment and recovery. Thus, connections to integrated treatment services—a unified approach that treats both mental health and substance use disorders simultaneously—can better address co-occurring disorders. However, the number of integrated services provided to individuals with co-occurring MHSUDs are scarce. For those connections to be successful, there must be collaboration among justice stakeholders, behavioral health, and community partners. BJA is committed to improving access to integrated treatment services in order to build local capacity to more effectively address the challenges of individuals in the criminal justice system, improve safety outcomes for communities, and strengthening critical health and justice partnerships through the provision of TTA.

A TTA provider with expertise in supporting communities to promote access to treatment for justice-involved populations with co-occurring MHSUDs will be competitively selected to lead a national TTA program and administer subawards to local demonstration sites. The program will promote cross-system collaboration among justice stakeholders, behavioral health service providers, and community support organizations to improve access to coordinated and integrated treatment for individuals in the criminal justice system with co-occurring MHSUDs.

The TTA will focus on the post-arrest, pre-disposition phase of the criminal justice system by identifying people with complex behavioral health needs who are moving through intercepts two and three of the <u>Sequential Intercept Model</u>. Selected sites will identify innovative alternatives to incarceration, engaging prosecutors and court personnel to plan and connect people to treatment services while maintaining accountability to the community. Subsequent sites may be selected at additional intercepts. Each site will be required to complete a rigorous planning

phase with the TTA provider, including the approval of an implementation plan in order to receive a full award. The TTA provider will also competitively award and administer up to 12 subawards to demonstration sites in local communities. The TTA provider is expected to provide comprehensive TTA to sub awardees and develop practical and replicable tools with direct applicability to the broader field to facilitate cross-system collaboration among the criminal justice, mental health, and substance use treatment systems. The TTA provider will be responsible for supporting the sites and monitoring their progress.

For planning and budget purposes, applicants to this solicitation will budget a total of \$5,000,000 for subawards to communities to support individuals in the criminal justice system with co-occurring MHSUDs. The funding level for these individual microgrants would average approximately \$400,000 per site. The remaining \$2,000,000 in funds will be used for provision of TTA to the subawards and the field at large, and administration of the award.

These demonstration sites are to be competitively selected post-award in collaboration with BJA. TTA applicants are encouraged to include plans in their proposals for identifying and selecting those 12 sites. The application process suggested by the applicant must ultimately be approved by BJA. The design should suggest methods to ensure accountability and reach desired program outcomes.

#### **Solicitation Goals and Objectives**

#### Goals

The goal of the Integrated Treatment for Individuals with Co-occurring Disorders in the Criminal Justice System Program is to assist and provide comprehensive TTA to local demonstration sites and the field to facilitate cross-system collaboration among justice stakeholders, behavioral health service providers and community support organizations to improve access to coordinated and integrated treatment for individuals in the criminal justice system with co-occurring mental health and substance use disorders (MHSUDs). TTA will specifically focus on demonstration sites effectively connecting individuals with co-occurring MHSUDs who present at the post arrest, pre-disposition phase of the criminal justice system to treatment.

#### **Objectives**

Enhance collaboration: Foster cross-system collaboration among justice stakeholders, behavioral health service providers, and community support organizations to better address the needs of individuals with co-occurring MHSUDs within the criminal justice system.

Build Capacity in the Field Through Technical Assistance (TA): Deliver comprehensive TA to local demonstration sites, focusing on building capacity and expertise in addressing behavioral health needs during the post-arrest pre-trial phase. Develop resources and materials to support replication for the field at large.

Support Demonstration Sites: Assist local demonstration sites in developing effective strategies for identifying, assessing, and treating individuals with co-occurring behavioral health disorders within the criminal justice system, promoting evidence-based practices.

Promote Integration: Encourage the integration of MHSUD treatment services at the post-arrest pre-disposition phase, ensuring a holistic approach to addressing the complex needs of the target population.

Enhance Training: Develop and implement training programs that equip justice stakeholders, behavioral health service providers, and community support organizations with the necessary skills and knowledge to effectively collaborate and address the behavioral health needs of individuals in the criminal justice system.

Monitor and Evaluate: Establish a system for continuous monitoring and evaluation of program outcomes, refining strategies based on feedback and emerging best practices to continually improve the program's impact.

#### **Priority Areas**

In order to further OJP's mission, OJP will provide priority consideration when making award decisions to the following:

**1A.** Applications that propose project(s) that are designed to meaningfully advance equity and remove barriers to accessing services and opportunities for communities that have been historically underserved, marginalized, adversely affected by inequality, and disproportionately impacted by crime, violence, and victimization.

To receive this consideration, the applicant must describe how the proposed project(s) will address identified inequities **and** contribute to greater access to services and opportunities for communities that have been historically underserved, marginalized, adversely affected by inequality, and disproportionately impacted by crime, violence, and victimization. Project activities under this consideration may include, but are not limited to the following: improving victim services, justice responses, prevention initiatives, reentry services and other parts of an organization's or community's efforts to advance public safety. Applicants should propose activities that address the cultural (and linguistic, if appropriate) needs of communities, outline how the proposed activities will be informed by these communities, and implement culturally responsive and inclusive outreach and engagement.

**1B.** Applicants that demonstrate that their capabilities and competencies for implementing their proposed project(s) are enhanced because they (or at least one proposed subrecipient that will receive **at least 40 percent** of the requested award funding, as demonstrated in the Budget web-based form) are a *population specific organization* that serves communities that have been historically underserved, marginalized, adversely affected by inequality, and disproportionately impacted by crime, violence, and victimization.

For purposes of this solicitation, population specific organizations are nonprofit, nongovernmental, or Tribal organizations that primarily serve members of a specific underserved population, and have demonstrated experience and expertise providing targeted services to members of that specific underserved population.

To receive this additional priority consideration, applicants must describe how being a population specific organization (or funding the population specific subrecipient organization(s)) will enhance their ability to implement the proposed project(s), and should also specify which historically underserved populations are intended or expected to be served or have their needs addressed under the proposed project(s).

This solicitation (notice of funding opportunity) incorporates guidance provided in the OJP Grant Application Resource Guide (Application Resource Guide), which provides additional information for applicants to prepare and submit applications to OJP for funding. #### **How To Apply**

#### Registration

Before submitting an application, all applicants must register with the System for Award Management (SAM.gov). An applicant must renew their registration every 12 months. If an applicant does not renew their SAM.gov registration, it will expire. An expired registration can delay or prevent application submission in Grants.gov and JustGrants. Applicants are encouraged to start the SAM.gov registration process at least 30 days prior to the application deadlines. Applicants who fail to begin the registration or renewal process at least 10 business days prior to the Grants.gov deadline may not complete the process in time and will not be considered for late submission.

A small business, in addition to obtaining the SAM.gov registration, should obtain an Employer Identification Number (EIN) from the Internal Revenue Service. The person applying for an award will submit the EIN value as the Tax Identification Number (TIN). The applicant should not submit their social security numbers. OJP recommends that applicants submit the complete application package in JustGrants at least 48 hours prior to the JustGrants deadline. Some of the required sections of the application will be entered directly into JustGrants, and other sections will require documents to be uploaded and attached. Therefore, applicants should allow enough time before the JustGrants deadline to prepare all the requirements of the application. Applicants may save their progress in the system and add to or change the application as needed prior to hitting the "Submit" button at the end of the application in JustGrants.
