Byrne Discretionary Community Project Funding/Byrne Discretionary Grants Program Frequently Asked Questions

May 2024

This Frequently Asked Questions (FAQs) document pertains to the Community Project Funding (CPF) / Congressionally Directed Spending (CDS) appropriations designated for the Office of Justice Programs (OJP) under the Byrne heading. These funds are also known as the Byrne Discretionary Community Project Funding/Byrne Discretionary Grants Program. Projects designated for funding were included in the Department of Justice Appropriations Acts beginning in FY 2022 and onward.

General Information

1. What is the purpose of the Byrne Discretionary Community Project Funding/Byrne Discretionary Grants Program (Byrne Discretionary)?

The purpose of Byrne Discretionary is to provide funding for specific community projects designated for funding in the Department of Justice Appropriations Acts. Byrne Discretionary aims to improve the functioning of the criminal justice system, prevent or combat juvenile delinquency, and assist victims of crime (other than compensation). Funding shall be used for the projects, and in the amounts, specified under the OJP-Byrne account in the Congressional Joint Explanatory Statement (JES), and are incorporated by reference into the public law.

Eligible applicants/recipients of Byrne Discretionary funding should refer to the solicitation under which they applied, or will apply, to receive funding.

2. How much funding is available under Byrne Discretionary?

The total funding available varies by fiscal year, and this information is typically provided in the solicitation or accessible through the links provided in the <u>Appendix</u>. Grant awards will only be made in the amount designated for funding for each authorized project.

Eligibility and Award Amounts

3. Who is eligible to apply for Byrne Discretionary funds?

Only entities listed as recipients of funding in the JES are eligible to apply for an award under this program. The list of eligible recipients/projects is provided as an Appendix to this document, along with the OJP office that will administer the grant. The legal name (or "doing business as" name) associated with the applicant's unique entity identifier (UEI) as registered in the System of Award Management (SAM) must coincide with the recipient listed in the JES. See the Application Submission section for more information.

4. How were Byrne Discretionary award amounts determined?

The JES designates a specific amount of funding for each project, and OJP will only issue grant

awards for each project in accordance with the specified amount.

5. We already applied for funding to Congress. Why do we have to apply again?

Congress appropriated the funding as a discretionary grant, necessitating the application process for OJP. OJP must receive a grant application in order to issue the grant award agreement and obligate award funds. This is a non-competitive grant process, with funding exclusively available for the designated projects.

Application Submission

6. When are Byrne Discretionary applications due?

Eligible Byrne Discretionary applicants will receive an invitation to apply for funding along with a link to an invitational solicitation. The solicitation will provide key details about the Byrne Discretionary program, application requirements, resources, and helpful information on how to apply. Please refer to the deadlines outlined in the solicitation under which you were invited to apply. Each OJP office administering Byrne Discretionary projects will release a solicitation under the program. _relevant resources.

7. Can I use a different project title when I apply for a Byrne Discretionary grant?

No, per the instructions in the solicitation, you must enter the project title in the SF-424 form and in JustGrants as it appears in the JES. Further, you will not be allowed to change the project title after an award has been granted.

8. What is the period of performance for Byrne Discretionary grants, and must I expend all funds by the end of the federal fiscal year for which funding was enacted?

There is no requirement to expend funds by the end of the federal fiscal year. OJP will issue the award with a project start date the same as the date the Consolidated Appropriations Act was enacted, unless a later start date is requested. If you request a later start date, the start date must be the first day of a month and cannot be later than October 1 of the next federal fiscal year. Note that pre-award costs (costs incurred prior to the start date) are generally not allowable.

OJP will issue awards with 12-month project periods, but applicants can request up to a 48-month project period. Enter a project end date in both the SF-424 and application to correspond to the start date and requested project period.

Costs incurred on/after the project start date, but prior to issuance of an award and approval of the project budget by OJP may be reimbursed, but are incurred at the applicant's own risk, as authorized costs will be limited to those approved by OJP.

9. What is OJP's timeline for application processing and issuance of awards?

OJP will expedite the review and approval of Byrne Discretionary applications. We anticipate issuing all award notifications by September 30, but will prioritize issuing awards on a rolling basis.

10. Once awards are made, how quickly will funds be available for use by recipients?

Recipients will have access to grant funds upon the completion of <u>Award Acceptance in JustGrants</u>, completion of registration in the <u>Automated Standard Application for Payments (ASAP)</u> system, and submission of any additional documentation needed for any <u>award conditions</u> that may withhold funds. Your assigned OJP grant manager can assist you with addressing any withholding award conditions placed on your award, such as for budget approval.

Allowable Costs and Related Administrative Requirements

11. Are Byrne Discretionary funds limited to only the projects approved by Congress?

Yes, as mentioned above, OJP will only issue awards to fund the specific projects identified in the JES, which is incorporated by reference into the appropriation. Further, OJP cannot approve a change to the purpose of a grant or project title.

12. Are Byrne Discretionary funds limited to the specific costs in the budget I submitted to Congress when I requested the appropriation for our community project?

You are not necessarily limited to the specific costs or the budget you submitted to Congress, as the full details of your request to Congress were not incorporated into the public law; however, the costs must support the project as appropriated in the law and cannot exceed the amount appropriated. All costs must be reasonable and allowable.

13. Can I use Byrne Discretionary grant funds for any costs I want for the project authorized by Congress?

No, since these awards will be administered as federal grants, the administrative requirements outlined in the <u>Uniform Requirements</u>, <u>Title 2 C.F.R. Part 200</u> will apply. Additionally, you are also required to adhere to the guidelines outlined in the <u>DOJ Grants Financial Guide</u>, which includes requirements concerning allowable costs. **Consequently, OJP must approve the project budget before grant funds can be expended or drawn down.**

14. Are other costs unallowable under Byrne Discretionary in addition to the unallowable costs listed in the DOJ Grants Financial Guide and 2 C.F.R. Part 200?

Yes, per the solicitation:

No funds provided under this program may be used, directly or indirectly, to provide any security enhancements or any equipment to any nongovernmental entity that is not engaged in criminal justice or public safety.

Absent sufficiently specific authorization in the Consolidated Appropriations Act, recipients of all OJP awards dated after May 1, 2023, must comply with restrictions on the <u>use of federal funds for certain prohibited and controlled expenditures, consistent with OJP's policy implementing Executive Order 14074, "Advancing Effective, Accountable Policing and Criminal Justice Practices To Enhance Public Trust and Public Safety." All recipients must comply with the OJP/BJA policy prohibiting the expenditure of grant funds on unmanned aircraft systems (UAS), including unmanned aircraft vehicles (UAV), and all accompanying accessories to support UAS or UAV.</u>

In addition to the unallowable costs identified in the DOJ Grants Financial Guide, award funds may not be used for the following:

- Rewards, entertainment, prizes, trinkets, or any other monetary incentives
- Client/participant stipends
- Gift cards
- Food and beverage.

15. What are some examples of allowable costs under Byrne Discretionary?

Given the wide variety of criminal justice projects authorized by law, specific costs for each project will vary. Depending on the nature of the project, grant funds could, by way of example and not limitation, be used for project staff salaries and fringe benefits, supplies or equipment purchases, travel costs, subawards to other agencies delegated to complete part of the project, and/or procurement contracts for goods or services needed for the project. This list of general costs is not exhaustive. Applicants should develop budgets consistent with their project needs and within the guidelines of allowability discussed above. See the OJP Grant Application Resource Guide for instructions on the application budget.

16. Our authorized Byrne Discretionary project involves a research and/or evaluation component. What should I know about OJP's requirements related to research and evaluation?

At a minimum, you should consult the <u>OJP Grant Application Resource Guide</u> and the links therein related to DOJ's requirements related to research.

17. Our authorized Byrne Discretionary project involves a conference/meeting/training. What should I know about OJP's requirements related to using grant funds for these events?

At a minimum, you should consult the <u>OJP Grant Application Resource Guide</u> and the links therein related to DOJ's requirements related to conferences/meetings/trainings.

18. Our authorized Byrne Discretionary project involves construction (including expansion, renovation, facility planning, site selection, site preparation, and security or facility upgrades) and/or chemicals (for forensics use). What should I know about OJP's requirements related to using grant funds for these projects?

Projects involving construction or chemicals may require additional approvals and actions to comply with the National Environmental Policy Act (NEPA). The <u>OJP NEPA web page</u> has additional information. Construction projects may also have to comply with "Buy American" laws and regulations and will have requirements for reporting on continuing use of the real property, in accordance with 2 C.F.R. 200.330.

19. Our authorized Byrne Discretionary project involves using funds to pay another entity for goods or services necessary for the project. Should this cost be classified as a subaward or a procurement contract in the budget?

See the <u>OJP Grant Application Resource Guide</u> and the links therein related to the important distinction between subawards and procurement contracts and the administrative requirements for each.

20. Are there any specific requirements for body-worn camera (BWC) purchases?

Yes, any agency that purchases BWCs must have BWC policies and procedures in place that, at a minimum, reinforce appropriate agency use-of-force policies and training and address technology usage, evidence acquisition, data storage and retention, as well as privacy issues, accountability, and discipline. While you are not required to submit these policies and procedures to OJP for review or approval, you must make them accessible and provide them upon request.

BJA offers a <u>Body-Worn Camera Toolkit</u> to serve as a comprehensive clearinghouse for criminal justice practitioners interested in planning and implementing a BWC program in an effort to improve officer and community safety.

21. Can Byrne Discretionary funds be used to purchase Rapid DNA instruments?

Byrne Discretionary funds can be utilized to support Rapid DNA projects only if they fall

within the scope of the authorized project. The award agreement will include conditions related to the appropriate usage of the Rapid DNA instrument, aligned with guidance from the FBI. These award conditions may involve the withholding of award funds until a Rapid DNA certification is obtained. Recipients of funding for Rapid DNA projects should consult with their OJP grant manager regarding any questions about the requirements for utilizing Rapid DNA before incurring costs.

22. Does the requirement for full and open competition for procurement contracts apply under Byrne Discretionary, and how do I request a sole source contract?

The competitive requirements outlined in the <u>DOJ Grants Financial Guide</u> and <u>2 C.F.R. 200.320</u> apply to Byrne Discretionary, except for states/territories, which must follow their own procurement policies. Noncompetitive (i.e., sole source) contracts above the simplified acquisition threshold, which is currently \$250,000, require prior approval by OJP before recipients (other than states/territories) may execute the contract. See the DOJ Grants Financial Guide for the required criteria and how to submit this request.

23. Are indirect costs allowable, and is there a limit on indirect costs charged to the grant?

Indirect costs are allowable if the recipient possesses a current negotiated indirect cost rate agreement approved by its cognizant federal agency or if the recipient is eligible for, and chooses to utilize, the "de minimis" indirect cost rate as outlined in <u>2 C.F.R. 200.414(f)</u>. The only limits on indirect costs charged to the grant would involve ensuring they do not surpass the approved or de minimis rate, or inaccurately applying them to the direct cost base.

24. Are there any limitations on direct administrative costs?

Generally, no, but all costs must be documented, reasonable and necessary for the performance of the federal award. See, e.g., 2 C.F.R. 200.403 of subpart E ("Cost Principles") of 2 C.F.R. Part 200, which will apply to all Byrne Discretionary community project awards.

25. Are matching funds required under the Byrne Discretionary program?

No, there is no match requirement under Byrne Discretionary. If applicants choose to include matching costs in their project budget voluntarily and OJP approves the budget, these matching costs will become mandatory and subject to audit. OJP advises against incorporating matching costs in the Byrne Discretionary application budget, although the proposal narrative can discuss any local funds that you plan to contribute toward the project.

26. What are "supplanting" and "comingling" and are they allowable under Byrne Discretionary?

Refer to the definitions of supplanting and comingling in the <u>DOJ Grants Financial Guide</u>, and the OJP supplanting <u>guidesheet</u>. Supplanting and comingling funds are strictly prohibited under Byrne Discretionary.

27. Can Byrne Discretionary funds be drawn down in advance without limitation?

No. Organizations should request funds based upon immediate disbursement/reimbursement requirements. Funds will not be paid in a lump sum, but rather disbursed over time as project costs are incurred or anticipated. Draw down requests should be timed to ensure that federal cash on hand is the minimum needed for disbursements/reimbursements to be made immediately or within 10 days. If not spent or disbursed within 10 days, funds must be returned to the awarding agency. See the DOJ Grants Financial Guide for full guidance on payments.

28. When OJP approves the budget for my Byrne Discretionary grant, does that mean all

costs, including those identified as requiring prior approval in the DOJ Grants Financial Guide, have received final approval?

No. In general, costs requiring prior approval must be approved in a separate process, and budget approval ("clearance") does not constitute approval of such costs even if they are listed in the budget. Requests for costs requiring prior approval must be submitted as a grant award modification (GAM) in the JustGrants system. For example, a request for a consultant rate agreement higher than the OJP established threshold requires a separate GAM approval prior to entering into an agreement. Similarly, a noncompetitive procurement contract ("sole source") over the simplified acquisition threshold must be approved by OJP before entering into the contract. The exception to this would be subaward(s) included in your application; for these, issuance of an award and approval of budget is considered approval of the subawards(s).

See the <u>DOJ Grants Financial Guide</u> for more information. The OJP grant manager assigned to your award will be able to provide additional guidance.

Post-Award Requirements

29. What are the reporting requirements for Byrne Discretionary grants?

Recipients are required to submit <u>quarterly federal financial reports (SF-425)</u> and <u>semi-annual performance reports</u> in JustGrants.

Recipients of Byrne Discretionary grants in the amount of \$30,000 or more must comply with applicable requirements to report first-tier subawards ("subgrants") of \$30,000 or more and, in certain circumstances, to report the names and total compensation of the recipient's five most highly compensated executives and first tier subrecipients (first tier "subgrantees") of award funds. The details of recipient obligations, which derive from the Federal Funding Accountability and Transparency Act of 2006 (FFATA), are posted under Award Condition: Reporting Subawards and Executive Compensation on the OJP website.

30. Are there training requirements for Byrne Discretionary grants?

Yes. The individuals assigned in JustGrants as the Grant Award Administrator and the Financial Manager for the grant award must have successfully completed an OJP financial management and grant administration training within 120 days after the date of the recipient's acceptance of the award. The assigned OJP grant manager for your award can provide additional information on this requirement.

31. Can I request changes to my Byrne Discretionary grant?

Yes, except for requests to change the purpose of the project or the project title as designated in the JES. Changes to the budget, project scope, and project period can be requested consistent with OJP's requirements and limitations detailed in the <u>DOJ Grants Financial Guide</u>. Recipients may also request a one-time no-cost project period extension of up to 12 months. **Most change** requests must be submitted via <u>grant award modification (GAM)</u> in JustGrants. The assigned OJP grant manager for your award can provide additional information.

32. What actions must I take when my Byrne Discretionary grant project is complete?

Upon completion of the grant project, the recipient must fulfill specific requirements during the closeout phase, as outlined in the <u>DOJ Grants Financial Guide</u> and JustGrants <u>closeout training</u> resources.
