FY 2022 Byrne Discretionary Community Project Funding/Byrne Discretionary Grants Program Frequently Asked Questions

April 29, 2022

This frequently asked questions (FAQs) document pertains to the FY 2022 Byrne Discretionary Community Project Funding/Byrne Discretionary Grants Program. The Office of Justice Programs (OJP) is issuing awards through the following four separate but identical solicitations, depending on which program office will administer the projects:

The information provided in these FAQs is relevant to all awards made under this program regardless of which program office will administer the award. Applicants/recipients should refer to the program office that sent you the Invitation to Apply for any questions not addressed in this document or the solicitation.

General Information

1. What is the purpose of the FY 2022 Byrne Discretionary Community Project Funding/Byrne Discretionary Grants Program (Byrne Discretionary)?

The purpose of the FY22 Byrne Discretionary program is to fund community projects specifically designated for funding in the <u>Consolidated Appropriations Act, 2022 (Public Law 117-103)</u> to improve the functioning of the criminal justice system, prevent or combat juvenile delinquency, and assist victims of crime (other than compensation). Funding shall be used for the projects, and in the amounts, specified under the heading "Byrne Discretionary Community Project Grants/Byrne Discretionary Grants" in the <u>Joint Explanatory Statement (JES) – Division B</u>, which is incorporated by reference into Public Law 117-103.

The explanatory statement regarding the <u>Consolidated Appropriations Act, 2022 (Public Law 117-103)</u> lists the designated projects, which the Act incorporates by reference, as stated in relevant part, below—

\$184,707,000 is for discretionary grants to improve the functioning of the criminal justice system, to prevent or combat juvenile delinquency, and to assist victims of crime (other than compensation), which shall be used for the projects, and in the amounts,

specified under the heading, "Byrne Discretionary Community Project Grants/Byrne Discretionary Grants", in the explanatory statement described in section 4 (in the matter preceding division A of this consolidated Act)[.] Pub. L. No. 117-103, div. B, title II (2022), 136 Stat 49, 125.

2. How much funding is available under the Byrne Discretionary program?

A total of \$184,707,000 is available, but grant awards will only be made in the amount designated for funding in the <u>Consolidated Appropriations Act, 2022 (Public Law 117-103)</u> for each authorized project.

Eligibility and Award Amounts

3. Who is eligible to apply for Byrne Discretionary funds?

Only those non-federal entities (NFEs) listed as recipients of funding under the "Byrne Discretionary Community Project Grants/Byrne Discretionary Grants" in the Joint Explanatory Statement (JES) —
Division B are eligible to apply for an award under this program. The list of 246 projects is provided in the appendix to this document along with each OJP office that will administer the grant.

The legal name (or "doing business as" name) associated with the applicant's unique entity identifier (UEI) as registered in the System of Award Management (SAM) must coincide with the recipient listed in the JES. See the Application Submission section in the solicitation for more information.

4. How were Byrne Discretionary award amounts determined?

JES designates a specific amount of funding for each project, and OJP will only issue grant awards for each project in the amount specified.

- 5. Our organization is not listed as a recipient in JES. Can we still apply for funding under this program?

 No. Under these solicitations, OJP will not issue awards to any NFE not specifically designated in JES.
- 6. Our organization is listed as a recipient in JES, but we would like to transfer the award to another organization (e.g., a project partner). Can our designated project partner or delegated organization apply for funding under this program instead of us?

No. Under these solicitations, OJP will not issue awards to any NFE not specifically designated in JES.

7. Our organization is listed as a recipient authorized by Congress, but we no longer have a need for funding the specific project listed. Can we apply for funding under this solicitation for a different project instead?

No. Under these solicitations, OJP will only issue awards for the projects and in the amounts specified in JES. Further, OJP will not be in a position to approve any changes to the purpose of the project.

Application Submission

8. When are Byrne Discretionary applications due?

The Grants.gov deadline to apply for funding is 8:59 p.m. eastern time on Monday, May 23, 2022, and the JustGrants deadline to apply is 8:59 p.m. eastern time on Thursday, May 26, 2022. A recipient should make sure to submit the application to the correct solicitation based on which OJP office will administer its award.

9. Will OJP be providing any extensions to the application deadlines?

OJP encourages all eligible applicants to submit their Byrne Discretionary applications as soon as possible, prior to the listed Grants.gov and JustGrants deadlines, to ensure timely awards. If certain project details are incomplete or only estimates, they can be noted in the proposal narrative or budget and OJP can obtain additional information post award. It is critical that you submit the application by the deadlines so that an award can be processed.

10. How do I apply for a Byrne Discretionary grant?

Please refer to, and carefully follow, the instructions for submitting an application detailed in the "FY 2022 Invited to Apply – Byrne Discretionary Community Project Grants/Byrne Discretionary Grants Program" solicitation, which was sent to you by BJA, OVC, OJJDP, or NIJ, depending on which OJP office will be administering your award. Use the links at the top of this FAQs document.

Note that application must be submitted in two steps:

<u>Step 1:</u> The applicant must submit by the Grants.gov deadline the required Application for Federal Assistance standard form (SF)-424 and a Disclosure of Lobbying Activities (SF-LLL) form when it registers in Grants.gov at https://www.grants.gov/web/grants/register.html. To register in Grants.gov, the applicant will need to ensure that its System for Award Management (SAM) registration is current.

<u>Step 2</u>: The applicant must then submit the <u>full application</u>, including attachments, in JustGrants at <u>JustGrants.usdoj.gov</u>. To be considered timely, the full application must be submitted in JustGrants by the JustGrants application deadline.

OJP encourages applicants to review the following resources:

In addition, applicants may wish to attend an upcoming <u>Application Mechanics: Submitting an Application training</u> to learn more about the application submission process. The Application Mechanics webinar takes place every Wednesday from 2:30–4:00 p.m. eastern time.

11. Can I use a different project title when I apply for a Byrne Discretionary grant?

No. Per the instructions in the solicitation, you must enter the project title in the SF-424 form and in JustGrants as it appears in JES. Further, you will not be permitted to change the project title after an award has been made.

12. What is the period of performance for Byrne Discretionary grants, and must I expend all funds by September 30, 2022?

There is no requirement to expend funds by September 30, 2022. OJP will issue the award with a project start day of March 15, 2022* unless you request a different start date in the SF-424 form and JustGrants application. If you request a different start date, the start date must be the first day of a month and cannot be later than October 1, 2022. Note that pre-award costs (costs incurred prior to the start date) are generally not allowable.

OJP will issue awards with 18-month project periods, but an applicant can request up to a 36-month project period. You can enter a project end date in the SF-424 and application to correspond to the start date and requested project period. OJP would then make an exception to

accept the 36-month project period if the recipient can provide justification in the application to support a longer project period, although it may not exceed 60 months.

An applicant that prefers to have a 12-month period can submit the final report and close out the award prior to the 18-month grant end date.

*Costs incurred on/after March 15, 2022, but prior to issuance of an award and approval of the project budget by OJP may be reimbursed, are incurred at the applicant's own risk, as authorized costs will be limited to those approved by OJP.

13. What is OJP's timeline for application processing and issuance of awards?

OJP will expedite the review and approval of Byrne Discretionary applications received under these solicitations. We anticipate issuing award notifications by September 30, 2022, but will prioritize issuing awards on a rolling basis as soon as possible.

14. Once awards are made, how quickly will funds be available for use by recipients?

Recipients will have access to grant funds upon the completion of <u>Award Acceptance in JustGrants</u>, completion of registering in the <u>Automated Standard Application for Payments (ASAP)</u> system, and providing additional documentation needed for any <u>award conditions</u> that may be withholding funds. Your assigned OJP grant manager can assist you with addressing any withholding conditions such as for budget approval.

15. Do any of the required OJP certifications not apply to FY 2022 Byrne Discretionary applicants?

As detailed in the OJP Grant Application Resource Guide "Administrative" section, all OJP applicants must execute the following two legal documents as part of the application process:

- Certifications Regarding Lobbying; Debarment, Suspension and Other Responsibility
 Matters; Drug-Free Workplace Requirements; Law Enforcement and Community Policing
- Certified Standard Assurances

Item 5 (the "Safe Policing Certification") in the document titled, "Certifications Regarding Lobbying; Debarment, Suspension and Other Responsibility Matters; Drug-Free Workplace Requirements; Law Enforcement and Community Policing," **does not** apply to FY 2022 "Byrne Discretionary" applicants. An FY 2022 "Byrne Discretionary" application does not meet the definition of a "discretionary award" for purposes of this particular certification and, therefore, that certification requirement would not apply to FY 2022 "Byrne Discretionary" awards.

Item 6 ("Coordination Required Under Public Safety and Community Policing Programs") in the certifications document titled, "Certifications Regarding Lobbying; Debarment, Suspension and Other Responsibility Matters; Drug-Free Workplace Requirements; Law Enforcement and Community Policing," **does not** apply to FY 2022 "Byrne Discretionary" applicants, as it applies only to applications for Office of Community Oriented Policing Services (COPS Office) awards and does not apply to applications for awards to be made by OJP.

Item (10) in the document titled, "Certified Standard Assurances" (regarding assurances required by 34 U.S.C. 10382), **does not** apply to FY 2022 "Byrne Discretionary" applicants, as it applies to applicants for COPS Office awards and does not apply to applications for awards to be made by OJP.

Item (11) in the document titled, "Certified Standard Assurances" (regarding DOJ awards under the STOP School Violence Act program), **does not** apply to FY 2022 "Byrne Discretionary" applicants; "Byrne Discretionary" applications are not applications for awards made "under the STOP School Violence Act program."

Allowable Costs and Related Administrative Requirements

16. Are Byrne Discretionary funds limited to only the projects approved by Congress?

Yes. As noted above, OJP will only issue awards to fund the specific projects identified in JES (incorporated by reference into the appropriation). Further, OJP will not be in a position to approve a change to the purpose of a grant or project title.

17. Are Byrne Discretionary funds limited to the specific costs in the budget I submitted to Congress when I requested the appropriation for our community project?

You are not necessarily limited to the specific costs or the budget you submitted to Congress, as the full details of your request to Congress were not incorporated into the public law. But the costs must support the project as appropriated in the law and cannot exceed the amount appropriated. Since the appropriation is administered as a grant, the costs must meet the rules for allowability for grants.

18. Can I use Byrne Discretionary grant funds for any costs I accrue for the project authorized by Congress?

No. As these awards will be made as Federal grants, the administrative requirements for grants in the <u>Uniform Requirements</u>, <u>Title 2 CFR Part 200</u> will apply. Further, you are also required to follow the <u>DOJ Grants Financial Guide</u>. This includes the requirements related to allowable costs. Accordingly, OJP must approve the project budget before grant funds can be expended or drawn down.

19. Are other costs unallowable under the Byrne Discretionary program in addition to the unallowable costs listed in the DOJ Grants Financial Guide and 2 CFR Part 200?

Yes. Per the solicitations:

No funds provided under this program may be used, directly or indirectly, to provide any security enhancements or any equipment to any nongovernmental entity that is not engaged in criminal justice or public safety.

Absent sufficiently specific authorization in the Consolidated Appropriations Act, 2022 (Public Law 117-103), the use of OJP grant funds for unmanned aircraft systems (UAS), including unmanned aircraft vehicles (UAV), and all accompanying accessories to support UAS or UAV, is unallowable.

In addition to the unallowable costs identified in the DOJ Grants Financial Guide, award funds may not be used for the following:

- Rewards, entertainment, prizes, trinkets, or any other monetary incentives
- Client/participant stipends
- Gift cards
- Food and beverage

20. What are some examples of allowable costs under the Byrne Discretionary program?

Given the wide variety of criminal justice projects authorized by law, specific costs for each project will vary. Depending on the nature of the project, grant funds could, by way of example and not limitation, be used for project staff salaries and fringe benefits; supplies or equipment purchases; travel costs; subawards to other agencies delegated to complete part of the project; and/or procurement contracts for goods or services needed for the project. This list of general costs is not exhaustive. Applicants should develop budgets consistent with their

project needs and within the guidelines of allowability discussed above. See the <u>OJP Grant</u> <u>Application Resource Guide</u> for instructions on the application budget.

- 21. Our authorized Byrne Discretionary project involves a research and/or evaluation component. What should I know about OJP's requirements related to research and evaluation?
 - At a minimum, you should consult the <u>OJP Grant Application Resource Guide</u> and the links therein related to DOJ's requirements related to research.
- 22. Our authorized Byrne Discretionary project involves a conference/meeting/training. What should I know about OJP's requirements related to using grant funds for these events?

 At a minimum, you should consult the OJP Grant Application Resource Guide and the links therein related to DOJ's requirements related to conferences/meetings/trainings.
- 23. Our authorized Byrne Discretionary project involves construction (including expansion, renovation, facility planning, site selection, site preparation, and security or facility upgrades) and/or chemicals (such as clandestine methamphetamine laboratory operations or forensics). What should I know about OJP's requirements related to using grant funds for these projects?
 Projects involving construction or chemicals may require additional approvals and actions to comply with the National Environmental Policy Act (NEPA). The OJP NEPA page has additional information. Construction projects may also have to comply with "Buy American" laws and regulations, and will have requirements for reporting on continuing use of the real property, in accordance with 2 C.F.R. 200.330.
- 24. Our authorized Byrne Discretionary project involves using funds to pay another entity for goods or services necessary for the project. Should this cost be classified as a subaward or a procurement contract in the budget?
 - See the <u>OJP Grant Application Resource Guide</u> and the links therein related to the important distinction between subawards and procurement contracts and the administrative requirements for each.
- 25. Are there any specific requirements for body-worn camera (BWC) purchases?
 - Yes, any agency that purchases BWCs must have BWC policies and procedures in place that, at a minimum, reinforce appropriate agency use-of-force policies and training and address technology usage, evidence acquisition, data storage and retention, as well as privacy issues, accountability, and discipline. You do not need to submit the policies and procedures to OJP for review or approval, but you must make them available upon request.
 - BJA offers a <u>Body-Worn Camera Toolkit</u> to serve as a comprehensive clearinghouse for criminal justice practitioners interested in planning and implementing a body-worn camera program in an effort to improve officer and community safety.
- 26. Can Byrne Discretionary funds be used to purchase Rapid DNA instruments?
 - If within the scope of the authorized project, Byrne Discretionary funds may be used to support Rapid DNA projects that meet the requirements for participation in Rapid DNA, including those involving the purchase of Rapid DNA instruments that have been approved for use by the FBI for use in the booking environment (see *National Rapid DNA Booking Operational Procedures Manual*).

27. Does the requirement for full and open competition for procurement contracts apply under the Byrne Discretionary program, and how do I request a sole source contract?

Yes. The competitive requirements outlined in the <u>DOJ Grants Financial Guide</u> and <u>2 CFR 200.320</u> apply to the Byrne Discretionary program. Non-competitive (i.e., sole source) contracts above the simplified acquisition threshold, which is currently \$250,000, require prior approval by OJP before recipients may execute the contract. See the DOJ Grants Financial Guide for the required criteria and how to submit this request.

28. Are indirect costs allowable, and is there a limit on indirect costs charged to the grant?

Indirect costs are allowable if the recipient has a current negotiated indirect cost rate agreement approved by its cognizant federal agency or if the recipient is eligible to use, and elects to use, the "de minimis" indirect cost rate as set out at 2 C.F.R. 200.414(f). The only limits on indirect costs charged to the grant would be not exceeding the approved or de minimis rate or incorrectly applying it to the direct cost base.

29. Are there any limitations on direct administrative costs?

No, but all costs must be reasonable and necessary for the performance of the federal award.

30. Are matching funds required under the Byrne Discretionary program?

No. There is no match requirement under the Byrne Discretionary program. If an applicant voluntarily includes matching costs in its budget and OJP approves the budget, the matching costs will be mandatory and subject to audit. OJP recommends not including any match costs in the Byrne Discretionary application budget; the proposal narrative can include discussion on local funds that you will be contributing.

31. What is supplanting and is it allowable under the Byrne Discretionary program?

See the definition of supplanting in the <u>DOJ Grants Financial Guide</u>. Supplanting is prohibited under the Byrne Discretionary program for all allowable costs.

32. Can Byrne Discretionary program funds be drawn down in advance without limitation?

No. Under this program, recipients must only draw down funds in advance for no more than 10 days of their cash needs as detailed in the <u>DOJ Grants Financial Guide</u>. There are no limitations for drawing down on a reimbursement basis (i.e., not in advance).

33. When OJP approves the budget for my Byrne Discretionary grant, does that mean all of the costs have received final approval including those costs identified as requiring prior approval in the Financial Guide?

No. In general, costs requiring prior approval must be approved in a separate process, and budget approval ("clearance") does not constitute approval of such costs even if they are listed in the budget. Requests for costs requiring prior approval must be submitted as a grant award modification (GAM) in JustGrants. For example, a request for a consultant rate agreement over the OJP established threshold requires separate GAM approval prior to entering into an agreement. Similarly, a non-competitive procurement contract ("sole source") over the simplified acquisition threshold must be approved by OJP before entering into the contract. The exception to this would be subaward(s) included in your application; for these, issuance of an award and approval of the budget are considered approval of the subawards(s).

See the <u>DOJ Grants Financial Guide</u> for more information. The assigned OJP grant manager for your award will be able to provide additional guidance.

Post-Award Requirements

34. What are the reporting requirements for Byrne Discretionary grants?

Recipients are required to submit <u>quarterly federal financial reports (SF-425)</u> and <u>semi-annual</u> performance reports in JustGrants.

Recipients of Byrne Discretionary grants in the amount of \$30,000 or more must comply with applicable requirements to report first-tier subawards ("subgrants") of \$30,000 or more and, in certain circumstances, to report the names and total compensation of the five most highly compensated executives of the recipient and first-tier subrecipients (first-tier "subgrantees") of award funds. The details of recipient obligations, which derive from the Federal Funding Accountability and Transparency Act of 2006 (FFATA), are posted on the OJP website at https://ojp.gov/funding/Explore/FFATA.htm (Award condition: Reporting Subawards and Executive Compensation).

35. Are there training requirements for Byrne Discretionary grants?

Yes. The individuals assigned in JustGrants as the Grant Award Administrator and the Financial Manager for the grant award must have successfully completed an "OJP financial management and grant administration training" no later than 120 days after the date of the recipient's acceptance of the award. The assigned OJP grant manager for your award can provide additional information on this requirement.

36. Can I request changes to my Byrne Discretionary grant?

Yes, with the exception of requests to change the purpose of the project or the project title as designated in JES. Changes to the budget, project scope, and project period can be requested consistent with OJP's requirements and limitations detailed in the DOJ Grants Financial Guide. Recipients may request a one-time project period extension of up to 12-months. Requests for most changes must be submitted via grant award modification (GAM) in JustGrants. The assigned OJP grant manager for your award can provide additional information.

37. What actions must I take when my Byrne Discretionary grant project is complete?

When a grant project is complete, the recipient has certain requirements for the Closeout phase, which are detailed in the DOJ Grants Financial Guide and JustGrants closeout training resources.
