# FY 2023 Bureau of Justice Assistance Body-Worn Camera Policy and Implementation Program Partnership Application Screening Form For Any Agency Applying as Primary Grant Applicant on Behalf of Itself and One or More Law Enforcement Agencies

**Purpose:** This screening form serves three purposes. First, it allows a prospective Bureau of Justice Assistance (BJA) Body-Worn Camera Policy and Implementation Program (BWCPIP) applicant that is seeking to engage in a multi-agency partnership to determine its eligibility. A partnership applicant is (i) any entity applying for BWCPIP funding on behalf of itself and one or more other law enforcement agencies (LEAs) or (ii) an entity that is a duly authorized representative of law enforcement agencies (e.g., state administrating agency or a state or regional law enforcement consortia) that intends to procure body-worn cameras (BWCs) on behalf of constituent agencies. Second, the form serves as a self-assessment to determine whether the lead agency and its potential partners are sufficiently capable and committed to fulfill the grant's administrative and programmatic requirements. Third, for those agencies that do decide to apply, it is recommended that this form be submitted as an attachment in support of the agency's full application.

**Limits on this form's applicability:** This screening form should be used only by an organization applying on behalf of two or more recipients. Any applicant that is seeking to apply only on behalf of itself should fill out the **FY 2022 BJA BWCPIP Single Application Screening Form.** 

This form should only be used for agencies applying under Category 1 – Site-based Awards to Law Enforcement Agencies or Category 2 – Site-based Awards to State Correctional Agencies

**Note to Applicants:** If the applicant opts to apply, this form will help clarify the scope of the applicant's BWC PIP program for processing by BJA. As a gauge for assessing eligibility and program commitment this screening form should also assist an applicant in organizing and completing its full program narrative and budget detail for the FY 2022 BWC PIP solicitation. It is suggested that a copy of this screening form be included as an attachment to an agency's FY 2022 BJA BWC PIP grant application package.
