\*Each district's FY 2023 funding allocation amount consists of an initial \$50,000 de minimis amount with 50 percent of the remaining post-de minimis funds allocated proportionate to the size of the district's population and the other 50 percent allocated based on the district's share of the most recent 3-year average number of part 1 violent statistics as reported by the Federal Bureau of Investigation's (FBI's) Uniform Crime Reporting (UCR) Program. For the 2023 PSN calculations, the most recent years of crime data available covered the period between 2019 and 2021. The populations for each of the judicial districts, including the District of Columbia and U.S. territories, were determined based on the 2022 mid-year population estimates published by the U.S. Census Bureau.
