Who May Apply:

National Public Safety Partnership (PSP) police department, local prosecutorial agency, or other governmental agency acting as fiscal agent that completed 2 years of the program and/or completed the program within the last year

Why Apply:

Receive funding for state/local prosecutors and local law enforcement agencies that have participated in the National PSP to secure resources they identified in their PSP program assessments that will help reduce crime and increase public safety and trust in the criminal justice system.

Maximum per Award:

Up to \$500,000 per award

How to apply and when:

Submit a two-step application.

- (1) Register in <u>Grants.gov</u> and follow the prompts to submit two forms by June 5, 2023.
- (2) Then complete the full application in <u>JustGrants.usdoj.gov</u> by June 12, 2023. The application's major elements are:
- (a) The **proposal abstract** that summarizes the problem you wish to address with your project (no more than 400 words).
 - (b) The proposal narrative that describes your project's strategies, activities, and major deliverables as well as your capacity to address the problem.
 - (c) The **web-based budget** form that details how you will allocate the grant funds by task, date, and responsible person.
