Who May Apply:

States; Units of local government (including federally recognized Indian tribal governments); Nonprofit and for-profit organizations (including tribal nonprofit or for-profit organizations); Faith-based and community organizations; Institutions of higher education (including tribal institutions of higher education); Consortiums with experience providing national and local-level training and technical assistance

Why Apply:

Receive funding to improve state and local jurisdictions' capacities to respond to violent crime and the functioning of the criminal justice system through the investigation and prosecution of cases resulting from sexual assault kit (SAK) evidence and the collection of lawfully owed DNA from convicted offenders.

Maximum per Award:

- **Purpose Area 1:** Up to \$3,000,000
- **Purpose Area 2:** Up to \$4,000,000

BJA encourages the following entities to apply:

- Agencies that have not received BJA funding before.
- Convening or governing bodies that can apply on behalf of one or more entities.

Examples of strategies/ activities that can be funded:

- Host training and educational sessions developed and conducted by relevant subject matter experts.
- Support the SAKI sits to engage in multidisciplinary coordination, investigation, and victim advocacy.
- Provide on-site and remote assistance for investigation and prosecution of sexually motivated crimes and other cold cases.
- Lend forensic support to existing SAKI sites to resolve sexually motivated homicides.

How to apply and when:

Submit a two-step application.

- (1) Register in [Grants.gov](https://grants.gov) and follow the prompts to submit two forms by June 5, 2023.
- (2) Then complete the full application in JustGrants.usdoj.gov by June 12, 2023. The application's major elements are:
 - (a) The **proposal abstract** that summarizes the problem you wish to address with your project (no more than 400 words).
 - (b) The **proposal narrative** that describes your project's strategies, activities, and major deliverables as well as your capacity to address the problem.
 - (c) The **web-based budget** form that details how you will allocate the grant funds by task, date, and responsible person.
