Who May Apply:	State, local, and tribal law enforcement agencies, as well as governmental non-law enforcement agencies
Why Apply:	Receive funding to establish Crime Gun Intelligence Centers, in collaboration with the Bureau of Alcohol, Tobacco, Firearms and Explosives, to utilize intelligence, technology, and community engagement to identify crime guns and their sources, and then prosecute the perpetrators.
Maximum per Award:	Up to \$300,000 to expand an existing site; up to \$700,000 to implement a new site, including no-cost training and technical assistance
BJA encourages the following entities to apply:	 Agencies that have not previously received BJA funding. Convening or governing bodies that can apply on behalf of one or more entities.
Examples of strategies/ activities that can be funded:	 Lead development New tools or technology A collaborative working group Staff training Access to GunStat and eTrace Policy development Testing innovative approaches Investigation and prosecution efforts

How to apply and when:	Submit a two-step application.
	(1)Register in <u>Grants.gov</u> and follow the prompts to submit two forms by July 17, 2024.
	(2) Then complete the full application in <u>JustGrants.usdoj.gov</u> by July 24, 2024. The application's major elements are:
	(a) The proposal abstract that summarizes the problem you wish to address with your project (no more than 400 words).
	(b) The proposal narrative that describes your project's strategies, activities, and major deliverables as well as your capacity to address the problem.
	(c) The web-based budget form that details how you will allocate the grant funds by task, date, and responsible person.
