Who May Apply:	Nonprofits having a 501(c)(3) status with the IRS, other than institutions of higher education			
Why Apply:	Receive funding to serve as financial intermediaries to community-based reentry programs (subawardees) and to provide support via an incubator model in order to increase capability and capacity within the subawardees' organizations.			
Maximum per Award:	Up to \$4,000,000 per award			
BJA encourages the following entities to apply:	 Agencies that have not previously received BJA funding. Convening or governing bodies that can apply on behalf of one or more entities 			
Examples of strategies/ activities that can be funded:	 Design and administer a competitive incubator initiative for community- and faith-based reentry providers. Pass through subawards. Build the administrative, operational, and organizational capacity of subawardees to serve people leaving incarceration. Provide training and technical assistance to improve collaboration between subawardees and corrections, 	 parole, probation, local reentry coalitions, other local reentry providers, and stakeholders. Provide content to the National Reentry Resource Center to post online for subawardees and other interested parties. Elevate the voices of justice-impacted leaders to build awareness and educate policymakers on specific challenges and needs.

How to apply and when:	Submit a two-step application.			
	(1)Register in <u>Grants.gov</u> and follow the prompts to submit two forms by July 8, 2024.			
	(2) Then complete the full application in <u>JustGrants.usdoj.gov</u> by July 15, 2024. The application's major elements are:			
	(a) The proposal abstract that summarizes the problem you wish to address with your project (no more than 400 words).			
	(b) The proposal narrative that describes your project's strategies, activities, and major deliverables as well as your capacity to address the problem.			
	(c) The web-based budget form that details how you will allocate the grant funds by task, date, and responsible person.
