Who May Apply:	City, township, county, state, or federally recognized tribal governments; Native American tribal organizations (other than federally recognized tribal governments); nonprofits having a 501(c)(3) status with the IRS, other than institutions of higher education; nonprofits that do not have a 501(c)(3) status with the IRS, other than institutions of higher education; for profit organizations other than small businesses; small businesses; public, private, and state-controlled institutions of higher education; and public housing authorities/Indian housing authorities	
Why Apply:	Receive funding to invest in current and future leaders in the criminal justice field and bring talent and expertise from the field to BJA to inform policy and practice.	
Maximum per Award:	Category 1: Up to \$350,000Category 2: Up to \$500,000	
BJA encourages the following entities to apply:	 People with lived experience to bring knowledge and perspective to BJA and the field. Agencies that have not previously received BJA funding.

How to apply and when:	Submit a two-step application.
	(1)Register in <u>Grants.gov</u> and follow the prompts to submit two forms by July 24, 2024
	(2)Then complete the full application in <u>JustGrants.usdoj.gov</u> by July 31, 2024. The application's major elements are:
	(a) The proposal abstract that summarizes the problem you wish to address with your project (no more than 400 words).
	(b) The proposal narrative that describes your project's strategies, activities, and major deliverables as well as your capacity to address the problem.
	(c) The web-based budget form that details how you will allocate the grant funds by task, date, and responsible person.
