Who May Apply:	Public, private, and state-controlled institutions of higher education	
Why Apply:	Receive funding to provide training and technical assistance (TTA) to state, local, territorial, and tribal law enforcement officials; intelligence analysts; prosecutors; judges; fusion center staff; and other criminal justice entities who prevent, investigate, and respond to crimes using wireless devices. The focus is on systems of interrelated, internet-connected objects that are able to collect and transfer data over a wireless network without human intervention.

Examples of strategies/ activities that can be funded:	 Deliver training to state, local, territorial, and tribal law enforcement agencies so they can provide awareness education to their communities. Provide educational materials about the Internet of Things to be used by jurisdictions for their communities. Manage these items for the BJA- supported Law Enforcement Cyber Resource Center. 	 Collect data on the capabilities of Internet of Things devices, maintain database, and share as directed by BJA. Increase the ability of criminal justice agencies to solve problems and modify policies or practices related to preventing, investigating, and responding to the Internet of Things. Evaluate the effectiveness and impact of implemented strategies for this program.

How to apply and when:	Submit a two-step application.		
	(1)Register in <u>Grants.gov</u> and follow the prompts to submit two forms by May 15, 2024.		
	(2)Then complete the full application in <u>JustGrants.usdoj.gov</u> by May 22, 2024. The application's major elements are:		
	(a) The proposal abstract that summarizes the problem you wish to address with your project (no more than 400 words).		
	(b) The proposal narrative that describes your project's strategies, activities, and major deliverables as well as your capacity to address the problem.		
	(c) The web-based budget form that details how you will allocate the grant funds by task, date, and responsible person.
