Why Apply:

Receive funding for state/local prosecutors and local law enforcement agencies that have participated in the National PSP to secure resources they identified in their PSP program assessments that will help reduce crime and increase public safety and trust in the criminal justice system.

Maximum per Award:

Up to \$500,000 per award

BJA encourages the following entities to apply:

 Any PSP cities that are entering the third year of the program or have completed the program and that did not receive Capacity Building funding last year.

Examples of strategies/ activities that can be funded:

- Enhance current programs and/or establish new ones.
- Hire new law enforcement and prosecutorial personnel.
- Invest in technology to analyze intelligence and data to

identify case leads and violent criminal activity.

- Focus resources on the people and places associated with high concentrations of crime.
- Expand programming to strengthen the role of communities as co-producers of public safety.

How to apply and when:

Submit a two-step application.

- (1) Register in <u>Grants.gov</u> and follow the prompts to submit two forms by July 17, 2024.
- (2) Then complete the full application in <u>JustGrants.usdoj.gov</u> by July 24, 2024. The application's major elements are:
 - (a) The **proposal abstract** that summarizes the problem you wish to address with your project (no more than 400 words).
 - (b) The **proposal narrative** that describes your project's strategies, activities, and major deliverables as well as your capacity to address the problem.
 - (c) The **web-based budget** form that details how you will allocate the grant funds by task, date, and responsible person.
