Nonprofit organizations with or without 501(c)(3) status that provide legal services to tribal members and Indian tribes, other than institutions of higher education.

Why Apply:

Receive funding to enhance the operations of tribal justice systems and improve access to those systems by tribal citizens and other eligible individuals. Training and technical assistance (TTA) funding will strengthen and improve the representation of indigent defendants in criminal cases and indigent respondents in civil cause of action under jurisdiction of Indian tribes.

Maximum per Award:

Up to \$1,139,107

BJA encourages the following entities to apply:

- Agencies that have not received BJA funding before.
- Convening or governing bodies that can apply on behalf of one or more entities.

Examples of strategies/ activities that can be funded:

- Expand and improve civil legal assistance for eligible tribal members, other eligible individuals, federally recognized Indian tribes, and tribal justice systems.
- Enhance tribes' capacity, operations, or legal infrastructure.
- Improve the quality of criminal defense representation for tribes and other eligible individuals.
- Coordinate and collaborate at the local and national level to effectively utilize resources and engage the tribal justice system community.
- Partner with Indian tribes to provide legal or technical assistance for the development of intergovernmental agreements, law enforcement training, and more.

How to apply and when:

Submit a two-step application.

- (1) Register in <u>Grants.gov</u> and follow the prompts to submit two forms by August 5, 2024.
- (2) Then complete the full application in <u>JustGrants.usdoj.gov</u> by August 12, 2024. The application's major elements are:
 - (a) The **proposal abstract** that summarizes the problem you wish to address with your project (no more than 400 words).
 - (b) The **proposal narrative** that describes your project's strategies, activities, and major deliverables as well as your capacity to address the problem.
 - (c) The **web-based budget** form that details how you will allocate the grant funds by task, date, and responsible person.
