As required under this program, beneficiaries may not receive more than \$10,000 per year and no more than \$60,000 cumulatively in JRJ funding. Beneficiaries also must remain in an eligible position for 36 months after their first signed service agreement. For this reason, all grantees must submit comprehensive JRJ verification forms to document all beneficiaries' total award amounts to ensure adequate tracking of grant funds, while also ensuring beneficiaries do not receive more than \$10,000 per year and more than \$60,000 in overall benefits. The service agreements demonstrate the beneficiaries' annual fulfillment of their commitment until their time commitment has been met. Remember to submit your comprehensive JRJ verification form and supporting service agreements for all beneficiaries who are still within the required time commitment and attach it to this performance report.
