Public Safety Officers' Benefits Program: 180-Day Report as of April 24, 2025

The U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance's (BJA) Public Safety Officers' Benefits (PSOB) Program provides death and education benefits to survivors of fallen law enforcement officers, firefighters and other first responders, and disability benefits to officers catastrophically injured in the line of duty.

In the six-month period from October 27, 2024 to April 24, 2025, a total of 703 claims were decided, 683 at the PSOB Office level and 20 on appeal.

Of the 265 death and disability claims decided at the PSOB Office level, 171 (65%) were approvals, with 148 death claim approvals and 23 disability claim approvals; 94 (35%) were denials, with 24 death claim denials and 70 disability claim denials.

Of the 14 Hearing Officer appeals decided, 3 (21%) were approvals, with 3 death appeal approvals and 0 disability appeal approvals; 11 (79%) were denials, with 5 death appeal denials and 6 disability appeal denials.

Of the 6 BJA Director appeals decided, 4 (67%) were approvals, with 4 death appeal approvals and 0 disability appeal approvals; 2 (33%) were denials, with 1 death appeal denial and 1 disability appeal denial.

Of the 418 education claims decided, all (100%) were approvals.

Of the 1,342 claims that were pending at the conclusion of the reporting period, 968 were PSOB Office level death and disability claims, 112 were education claims, and 262 were appeals. Of these 1,342 claims, 882 (66%) have been pending for one year or more. For the 1,080 PSOB Office level claims pending at the conclusion of the reporting period, 726 (67%) have been pending for one year or more. For the 262 appeals pending at the conclusion of the reporting period, 156 (60%) have been pending for one year or more.

During this reporting period technical enhancements to PSOB's online system were initiated, with required data elements identified for automated weekly and 180-day reporting.
