

## Public Safety Officers' Benefits Program: 180-Day Report as of April 29, 2024

The U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance's (BJA) Public Safety Officers' Benefits (PSOB) Program provides death and education benefits to survivors of fallen law enforcement officers, firefighters and other first responders, and disability benefits to officers catastrophically injured in the line of duty.

In the six-month period ending April 29, 2024, a total of 747 claims were decided, 729 at the PSOB Office level and another 18 on appeal. Of the 307 death and disability claims decided at the PSOB Office level, 252 (82%) were approvals and 55 (18%) were denials. Of the 12 Hearing Officer appeals decided, 6 (50%) were approvals and 6 (50%) were denials. Of the 6 BJA Director appeals decided, 3 (50%) were approvals and 3 (50%) were denials. Of the 422 education claims decided, all (100%) were approvals.

Of the 1,411 claims that were pending at the conclusion of the reporting period, 1,194 were PSOB Office level claims<sup>1</sup> and 217 were appeals. Of these 1,411 claims, 763 (54%) have been pending for one year or more. For the 1,194 PSOB Office level claims pending at the conclusion of the reporting period, 603 (51%) have been pending for one year or more. For the 217 appeals pending at the conclusion of the reporting period, 160 (74%) have been pending for one year or more. PSOB staffing levels remain a priority for the Program.

The new features include quality checks to ensure the accuracy of information provided in these reports, including data regarding September 11<sup>th</sup> exposure claims. System dashboards generate lists of pending applications and claims, and determined claims, and PSOB obligations and payments are also captured in the system.
