Public Safety Officers' Benefits Program: 180-Day Report as of October 26, 2024

The U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance's (BJA) Public Safety Officers' Benefits (PSOB) Program provides death and education benefits to survivors of fallen law enforcement officers, firefighters and other first responders, and disability benefits to officers catastrophically injured in the line of duty.

In the six-month period from April 30, 2024 to October 26, 2024, a total of 538 claims were decided, 520 at the PSOB Office level and 18 on appeal.

Of the 267 death and disability claims decided at the PSOB Office level, 173 (65%) were approvals, with 159 death claim approvals and 14 disability claim approvals; 94 (35%) were denials, with 37 death claim denials and 57 disability claim denials.

Of the 13 Hearing Officer appeals decided, 3 (23%) were approvals, with 3 death appeal approvals and 0 disability appeal approvals; 10 (77%) were denials, with 6 death appeal denials and 4 disability appeal denials.

Of the 5 BJA Director appeals decided, 2 (40%) were approvals, with 1 death appeal approval and 1 disability appeal approval; 3 (60%) were denials, with 3 death appeal denials and 0 disability appeal denials.

Of the 253 education claims decided, all (100%) were approvals.

Of the 1,607 claims that were pending at the conclusion of the reporting period, 1,189 were PSOB Office level death and disability claims, 172 were education claims, and 246 were appeals. Of these 1,607 claims, 833 (52%) have been pending for one year or more. For the 1,361 PSOB Office level claims pending at the conclusion of the reporting period, 672 (49%) have been pending for one year or more. For the 246 appeals pending at the conclusion of the reporting period, 161 (65%) have been pending for one year or more.
