

Public Safety Officers' Benefits Program: 180-Day Report as of October 21, 2025

The U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance's (BJA) Public Safety Officers' Benefits (PSOB) Program provides death and education benefits to survivors of fallen law enforcement officers, firefighters and other first responders, and disability benefits to officers catastrophically injured in the line of duty.

In the six-month period from April 25, 2025 to October 21, 2025, a total of 755 claims were decided, 739 at the PSOB Office level and 16 on appeal.

Of the 522 death and disability claims decided at the PSOB Office level, 321 (61.5%) were approvals, with 247 death claim approvals and 74 disability claim approvals; 201 (38.5%) were denials, with 46 death claim denials and 155 disability claim denials.

Of the 12 Hearing Officer appeals decided, 4 (33.3%) were approvals, with 3 death appeal approvals and 1 disability appeal approval; 8 (66.7%) were denials, with 5 death appeal denials and 3 disability appeal denials.

Of the 4 BJA Director appeals decided, 4 (100%) were approvals, with 3 death appeal approvals and 1 disability appeal approval.

Of the 217 education claims decided, all (100%) were approvals.

Of the 1,177 claims that were pending at the conclusion of the reporting period, 772 were PSOB Office level death and disability claims, 76 were education claims, and 329 were appeals. Of these 1,177 claims, 705 (59.9%) have been pending for one year or more. For the 848 PSOB Office level claims pending at the conclusion of the reporting period, 511 (60.3%) have been pending for one year or more. For the 329 appeals pending at the conclusion of the reporting period, 194 (59%) have been pending for one year or more.

During this reporting period technical enhancements to PSOB's online system were continued, with required data elements identified for automated weekly and 180-day reporting.

In addition to all the operational aspects of the program, for each completed death, disability, or education claim determined at the PSOB Office level, at a minimum, BJA received the initial application, conducted outreach to survivors and agencies for pending evidence, reviewed the application for factual and legal complexity, assigned a claim number, analyzed the evidence, packaged records and sent for medical review as indicated, prepared a draft determinations, reviewed and signed off on the draft as factually and legally sufficient, requested commitment of funds for approvals, and provided notifications throughout the review process. Because different staff perform different functions to produce a completed determination approving or denying every claim for benefits, the most meaningful indicator of claims processing is the number of determinations issued in the reporting period.
