

## Public Safety Officers' Benefits Program: 180-Day Report as of November 1, 2023

The U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance's (BJA) Public Safety Officers' Benefits (PSOB) Program provides death and education benefits to survivors of fallen law enforcement officers, firefighters and other first responders, and disability benefits to officers catastrophically injured in the line of duty.

In the six-month period ending November 1, 2023, a total of 747 claims were decided, 729 at the PSOB Office level and another 18 on appeal. Of the 466 death and disability claims decided at the PSOB Office level, 408 (88%) were approvals and 58 (12%) were denials. Of the 11 Hearing Officer appeals decided, 3 (27%) were approvals and 8 (73%) were denials. Of the 7 BJA Director appeals decided, 4 (57%) were approvals and 3 (43%) were denials. Of the 263 education claims decided, all (100%) were approvals.

Of the 1,456 claims that were pending at the conclusion of the reporting period, 1,252 were PSOB Office level claims<sup>1</sup> and 204 were appeals. Of these 1,456 claims, 622 (43%) have been pending for one year or more. For the 1,252 PSOB Office level claims pending at the conclusion of the reporting period, 462 (37%) have been pending for one year or more. For the 204 appeals pending at the conclusion of the reporting period, 160 (78%) have been pending for one year or more. PSOB staffing levels remain a priority for the Program.

<sup>2</sup> The data reporting feature for the PSOB online portal and case management system (PSOB 2.0) has been developed and is in use. The new features include quality checks to ensure the accuracy of information provided in these reports, including data regarding September 11<sup>th</sup> exposure claims. System dashboards generate lists of pending applications and claims, and determined claims, and PSOB obligations and payments are also captured in the system.
