## Public Safety Officers' Benefits Program: 180-Day Report as of November 29, 2017

The U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance's (BJA) Public Safety Officers' Benefits (PSOB) Program provides death and education benefits to survivors of fallen law enforcement officers, firefighters and other first responders, and disability benefits to officers catastrophically injured in the line of duty.

In the six-month period ending November 29, 2017, a total of 655 claims were decided, 621 at the PSOB Office level and another 34 on appeal.

Of the 821 claims that remained pending at the conclusion of the reporting period, many claims were pending the submission of basic required documents. Fewer than half of these claims have been pending for more than one year. Of the 821 claims pending, 148 are for exposure due to rescue, recovery and clean-up efforts following the September 11, 2001, terrorist attacks.
