

Public Safety Officers' Benefits Program: 180-Day Report as of November 6, 2022

The U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance's (BJA) Public Safety Officers' Benefits (PSOB) Program provides death and education benefits to survivors of fallen law enforcement officers, firefighters and other first responders, and disability benefits to officers catastrophically injured in the line of duty.

In the six-month period ending November 6, 2022, a total of 549 claims were decided, 530 at the PSOB Office level and another 19 on appeal. Of the 315 death and disability claims decided at the PSOB Office level, 280 (89%) were approvals and 35 (11%) were denials. Of the 13 Hearing Officer appeals decided, 5 (38%) were approvals and 8 (62%) were denials. Of the 6 BJA Director appeals decided, 3 (50%) were approvals and 3 (50%) were denials. Of the 215 education claims decided, 214 (99.5%) were approvals and 1 (0.5%) was a denial.

Of the 1,222 claims that were pending at the conclusion of the reporting period, 1,018 were PSOB Office level claims¹ and 204 were appeals. Of these 1,222 claims, 560 (46%) have been pending for one year or more. For the 1,018 PSOB Office level claims pending at the conclusion of the reporting period, 402 (39%) have been pending for one year or more. For the 204 appeals pending at the conclusion of the reporting period, 158 (77%) have been pending for one year or more. Restoring PSOB staffing levels remains a priority in 2023.

² The data reporting feature for the PSOB online portal and case management system (PSOB 2.0) has been developed and is in use. The new features include quality checks to ensure the accuracy of information provided in these reports, including data regarding September 11th exposure claims. System dashboards generate lists of pending applications and claims, and determined claims, and PSOB obligation and payment amounts are also captured in the system.
