Public Safety Officers' Benefits Program: 180-Day Report as of May 5, 2023

The U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance's (BJA) Public Safety Officers' Benefits (PSOB) Program provides death and education benefits to survivors of fallen law enforcement officers, firefighters and other first responders, and disability benefits to officers catastrophically injured in the line of duty.

In the six-month period ending May 5, 2023, a total of 613 claims were decided, 591 at the PSOB Office level and another 22 on appeal. Of the 285 death and disability claims decided at the PSOB Office level, 249 (87%) were approvals and 36 (13%) were denials. Of the 14 Hearing Officer appeals decided, 1 (7%) was an approval and 13 (93%) were denials. Of the 8 BJA Director appeals decided, 7 (88%) were approvals and 1 (12%) was a denial. Of the 306 education claims decided, all (100%) were approvals.

Of the 1,391 claims that were pending at the conclusion of the reporting period, 1,189 were PSOB Office level claims¹ and 202 were appeals. Of these 1,391 claims, 599 (43%) have been pending for one year or more. For the 1,189 PSOB Office level claims pending at the conclusion of the reporting period, 438 (37%) have been pending for one year or more. For the 202 appeals pending at the conclusion of the reporting period, 161 (80%) have been pending for one year or more. PSOB staffing levels remain a priority in 2023.
