

## Public Safety Officers' Benefits Program: 180-Day Report as of November 11, 2021

The U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance's (BJA) Public Safety Officers' Benefits (PSOB) Program provides death and education benefits to survivors of fallen law enforcement officers, firefighters and other first responders, and disability benefits to officers catastrophically injured in the line of duty.

In the six-month period ending November 11, 2021, a total of 493 claims were decided, 478 at the PSOB Office level and another 15 on appeal. Of the 192 death and disability claims decided at the PSOB Office level, 170 (89%) were approvals and 22 (11%) were denials. Of the 12 Hearing Officer appeals decided, 3 (25%) were approvals and 9 (75%) were denials. Of the 3 BJA Director appeals decided, 1 (33%) was an approval and 2 (67%) were denials. Of the 286 education claims decided, all (100%) were approvals.

Of the 922 claims that were pending at the conclusion of the reporting period, 712 were PSOB Office level claims<sup>1</sup> and 210 were appeals. Of these 922 claims, 458 (50%) have been pending for one year or more. For the 712 PSOB Office level claims pending at the conclusion of the reporting period, 289 (41%) have been pending for one year or more. For the 210 appeals pending at the conclusion of the reporting period, 169 (81%) have been pending for one year or more. The continued loss of staff impacted the claims determined in this reporting period. Restoring PSOB staffing levels remains a priority in 2022.

<sup>2</sup> The data reporting feature for the PSOB online portal and case management system (PSOB 2.0) has been developed and is in use. The new features include quality checks to ensure the accuracy of information provided in these reports, including data regarding September 11<sup>th</sup> exposure claims. System dashboards generate lists of pending applications and claims, and determined claims, and PSOB obligation and payment amounts are also captured in the system.
