

**Public Safety Officers' Benefits Program: 180-Day Report as of May 26, 2019**

The U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance's (BJA) Public Safety Officers' Benefits (PSOB) Program provides death and education benefits to survivors of fallen law enforcement officers, firefighters and other first responders, and disability benefits to officers catastrophically injured in the line of duty.

In the six-month period ending May 26, 2019, a total of 593 claims were decided, 563 at the PSOB Office level and another 30 on appeal.

Of the 553 claims that were pending at the conclusion of the reporting period, 331 were PSOB Office level claims and 222 were appeals. Of these 553 claims, 284 (51%) have been pending for more than one year.
