

## Public Safety Officers' Benefits Program: 180-Day Report as of May 10, 2022

The U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance's (BJA) Public Safety Officers' Benefits (PSOB) Program provides death and education benefits to survivors of fallen law enforcement officers, firefighters and other first responders, and disability benefits to officers catastrophically injured in the line of duty.

In the six-month period ending May 10, 2022, a total of 602 claims were decided, 586 at the PSOB Office level and another 16 on appeal. Of the 247 death and disability claims decided at the PSOB Office level, 203 (82%) were approvals and 44 (18%) were denials. Of the 13 Hearing Officer appeals decided, 3 (23%) were approvals and 10 (77%) were denials. Of the 3 BJA Director appeals decided, 2 (67%) were approvals and 1 (33%) was a denial. Of the 339 education claims decided, all (100%) were approvals.

Of the 1,009 claims that were pending at the conclusion of the reporting period, 806 were PSOB Office level claims<sup>1</sup> and 203 were appeals. Of these 1,009 claims, 492 (49%) have been pending for one year or more. For the 806 PSOB Office level claims pending at the conclusion of the reporting period, 337 (42%) have been pending for one year or more. For the 203 appeals pending at the conclusion of the reporting period, 155 (76%) have been pending for one year or more. The continued loss of staff impacted the claims determined in this reporting period. Restoring PSOB staffing levels remains a priority in 2022.

<sup>2</sup> The data reporting feature for the PSOB online portal and case management system (PSOB 2.0) has been developed and is in use. The new features include quality checks to ensure the accuracy of information provided in these reports, including data regarding September 11<sup>th</sup> exposure claims. System dashboards generate lists of pending applications and claims, and determined claims, and PSOB obligation and payment amounts are also captured in the system.
