## Public Safety Officers' Benefits Program: 180-Day Report as of November 22, 2019

The U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance's (BJA) Public Safety Officers' Benefits (PSOB) Program provides death and education benefits to survivors of fallen law enforcement officers, firefighters and other first responders, and disability benefits to officers catastrophically injured in the line of duty.

In the six-month period ending November 22, 2019, a total of 574 claims were decided, 541 at the PSOB Office level and another 33 on appeal.

Of the 575 claims that were pending at the conclusion of the reporting period, 347 were PSOB Office level claims and 228 were appeals. Of these 575 claims, 266 (46%) have been pending for more than one year.
