# Program Description

## Overview

This funding supports law enforcement efforts to combat crime and maintain public safety through State and local law enforcement agencies called upon to assist on three designated U.S. military installations temporarily housing Afghan refugees as a part of Operation Allies Welcome.

**Statutory Authority:** This program is authorized by Title I of Pub. L. No. 90-351, including subpart 1 of part E; see also 28 U.S.C. 530C(a).

## Specific Information

Funds will be awarded, subject to compliance with the requirements in this solicitation, to the Indiana Criminal Justice Institute, New Mexico Department of Public Safety, and Virginia Department of Criminal Justice Services. The recipients will use funding to reimburse State and/or local law enforcement agencies that provide onsite support to three designated U.S. military installations that are temporarily housing Afghan refugees as a part of Operation Allies Welcome (Fort Pickett, Virginia; Holloman Air Force Base, New Mexico; and Camp Atterbury, Indiana). An agency's allowable costs may include any combination of the following: deployed law enforcement officers' salary and benefits, deployed officers' overtime costs and/or backfill costs associated with deployed officers. Actual award amounts and allowable costs may depend on the specific needs of each individual participating agency, but in any event, BJA will not reimburse in an amount that exceeds the participating agency's standard overtime costs of two full-time equivalent law enforcement officer positions deployed on-site twenty-four hours per day/seven days per week during the time that this funding remains available. To qualify, the participating agency must maintain an on-base presence on the relevant U.S. military installations equal to or more than 80 hours per week, and must coordinate with U.S. Department of Defense and any other federal law enforcement authorities that are providing law enforcement services on base regarding this on-base presence.

## Goals, Objectives, Deliverables, and Timeline

### Goals

The goal of this program is to mitigate the unexpected costs incurred by State and/or local law enforcement agencies in providing criminal justice support to three designated U.S. military installations that are temporarily housing Afghan refugees as a part of Operation Allies Welcome. The application should include a description of the goal and activities related to the stated purpose of this funding, including coordination efforts with federal and other law enforcement.
