#### Overview

The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>Bureau of Justice Assistance</u> seeks applications for funding to create a regional drug data research center that promotes the collection, analysis, and dissemination of information critical in response to the overdose crisis and impacts of opioids, stimulants, and other substances. This program furthers the DOJ's mission by providing resources to an accredited institution of higher education that promotes the collection, analysis, research, and dissemination of information to reduce fatal and nonfatal overdoses, promote public safety, and support prevention, harm reduction, treatment, and recovery services.

This solicitation incorporates guidance provided in the <u>OJP Grant Application Resource Guide</u> which provides additional information for applicants to prepare and submit applications to OJP for funding. If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.

### **Eligible Applicants:**

Private institutions of higher education, Public and State controlled institutions of higher education

BJA will consider applications under which two or more entities would carry out the federal award; however, only one entity may be the applicant. Any others must be proposed as subrecipients (subgrantees). For additional information on subawards, see the OJP Grant Application Resource Guide.

BJA may elect to fund applications submitted under this FY 2023 solicitation in future fiscal years, dependent on, among other considerations, the merit of the applications and the availability of appropriations.

# **Program Description**

### Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

With this solicitation, BJA seeks to continue developing a network of drug data research centers to combat the overdose crisis, building on the first award made in 2022. BJA anticipates making up to two awards to two accredited institutions of higher learning to support expanding an existing statewide drug data repository into a regional drug data research center ("regional data center") that will promote the collection, analysis, research, and dissemination of information to help combat the surge in fatal and nonfatal overdoses from opioids, stimulants, and other substances. Institutions awarded under this solicitation and their respective data research centers will work with the FY 2022 Drug Data Research Centers to Combat the Overdose Crisis (DDRC)-funded center at the University of Alabama and will serve as both a model and technical advisors to translate this model to other regions in the United States.

### **Statutory Authority**

Department of Justice Appropriations Act, 2023 (Pub. L. No. 117-328; 136 Stat. 4459, 4535).

### **Specific Information**

The nation's overdose and substance use disorder crises threaten the health and wellbeing of individuals who misuse drugs and their families and impact the safety of communities. Provisional data from the Centers for Disease Control and Prevention's National Center for Health Statistics indicate that there were nearly 108,000 drug overdose deaths in the United States during 2022, surpassing all prior years. Data from across multiple sectors and systems are critical to develop, monitor, and evaluate effective strategies to combat the overdose crisis, as well as the rising number of deaths related to misuse of opioids, stimulants, and other substances. To that end, this solicitation seeks to expand an existing statewide drug data repository into a regional data center. In order to establish and be considered a regional data center, the expansion must include multiple contiguous states.

The core data that BJA requires be collected from each participating state to expand the regional data center include: overdose deaths, prescription drug monitoring program data, drug-related emergency medical services (EMS) encounters, drug-related emergency department visits, and drug arrests. To help policymakers and practitioners respond quickly to emergent patterns, the expansion may also include, but are not limited to, additional data such as treatment provision, toxicology test results, and court disposition data.

To enhance capacity to collect, analyze, research, and disseminate drug data in other regions across the United States, the additional data centers awarded through this solicitation will

expand the regional data center network and serve as models for other data centers to develop similar approaches for data sharing and creation of additional regional drug data research centers across the United States.

### Goals, Objectives, and Deliverables

### Goals

The goal of this program is to promote the research, collection, analysis, and dissemination of overdose-related information to reduce fatal and nonfatal overdoses, promote public safety, and support prevention, harm reduction, treatment, and recovery services, creating a network of regional drug data research centers that serves as a model for other regions in the United States.

### **Objectives**

An applicant should address all the Goals, Objectives, Deliverables in the time task plan attached to the application.

Objectives of this program are to:

Expand the existing statewide drug data repository into a regional data center to produce and disseminate web-based, real-time, actionable multisector drug data.

Enhance the capacity to utilize, as applicable, the open-source, regional drug data research center architecture developed by the University of Alabama.

Facilitate electronic information sharing across multiple agencies across state lines that must include, but not be limited to, data on overdose deaths, drug-related EMS encounters, prescription drug monitoring program data, drug arrests, and drug-related emergency department visits. This effort should be complementary to, not duplicative of, other information sharing.

Encourage the sharing of additional information from law enforcement, prosecutions, jail stays, corrections (institutional and community), public health, treatment provision, and/ or courts/pretrial services across states.

Support collaboration among public health, behavioral health, criminal justice, and first responder agencies to use these data to inform strategies and coordinate efforts.

Expand research to enhance knowledge to more effectively address the overdose crisis, particularly in populations who have been historically underserved, marginalized, and adversely affected by persistent poverty and inequality.

### **Deliverables**

Create a regional drug data research center that facilitates web-based, real-time, multisector data dissemination across multiple agencies across state lines.

Document utilization of regional drug data for policy and strategy development.

Develop or enhance the regional data center's capacity to provide unsolicited reports to authorized individuals or entities.

Pilot and provide feedback, including written documentation, on the regional data center's architecture as well as the training and technical assistance resources developed by the University of Alabama, the FY 2022 DDRC award recipient.

Work collaboratively with the University of Alabama and assist in building knowledge and capacity for the field in the area of regional drug data research centers.

The Goals, Objectives, and Deliverables are directly related to the performance measures that show the completed work's results, as discussed in the "Application and Submission Information" section.

BJA anticipates one national Comprehensive Opioid, Stimulant, and Substance Use Program convening will occur annually for which DDRC applicants must budget for travel expenses (airfare, hotel, per diem, and ground transportation). Additionally, all applicants should budget for a minimum of two staff to attend two face-to-face meetings during the award period. Each meeting should be budgeted for 3 days each in Washington, D.C. BJA wants to ensure that grantees have the opportunity to present their work and collaborate with their peers and other national and federal stakeholder groups.

### **Digital Trust**

Technological devices, artificial intelligence, predictive analytics, and other data-driven solutions ("Technological Enhancements") are increasingly used to augment crime reduction strategies and efforts. Care must be taken to assess and address any potential harm that could be activated by these solutions to ensure privacy, civil rights, and civil liberties are protected. Applicants proposing to utilize grant funds to support technological enhancements directly or via

training and technical assistance should address the tenants of digital trust such as:

How the technology will be carefully implemented through training of personnel and the setting and enforcement of policies governing its use to ensure that it contributes to positive outcomes for public safety, the community, and/or the criminal justice system.

How the applicant will safeguard privacy, civil rights, and civil liberties throughout the duration of the project period.

- Timeline/Project Plan

If OJP determines that an application does not include these elements, it will neither proceed to peer review, nor receive further consideration.

# Information to Complete the Application for Federal Assistance (SF-424) in Grants.gov

The SF-424 must be submitted in Grants.gov. It is a required standard form used as a cover sheet for submission of pre-applications, applications, and related information. See the <u>OJP</u> Grant Application Resource Guide for additional information on completing the SF-424.

### Standard Applicant Information (JustGrants 424 and General Agency Information)

The "Standard Applicant Information" section of the JustGrants application is pre-populated with the SF-424 data submitted in Grants.gov. The applicant will need to review the Standard Applicant Information in JustGrants and make edits as needed. Within this section, the applicant will need to add ZIP codes for areas affected by the project; confirm their Authorized Representative; and verify and confirm the organization's unique entity identifier, legal name, and address.

### **Proposal Abstract**

A Proposal Abstract (no more than 400 words) summarizing the proposed project — including its purpose, primary activities, expected outcomes, the service area, intended beneficiaries, and subrecipients (if known) — must be completed in the JustGrants web-based form. This abstract should be in paragraph form without bullets or tables, written in the third person, and exclude personally identifiable information. Abstracts will be made publicly available on the OJP and USASpending.gov websites if the project is awarded. See the OJP Grant Application Resource Guide for an example of a proposal abstract. Proposal abstracts should be: single-spaced, using a standard 12-point Times New Roman font with 1-inch margins and include geographic focus, states included, key partners, and any subawards.

### **Proposal Narrative**

The Proposal Narrative should be submitted as an attachment in JustGrants. The attached document should be double-spaced, using a standard 12-point font; have no less than 1-inch margins; and should not exceed 20 numbered pages. If the Proposal Narrative fails to comply with these length restrictions, [Insert PO] may consider such noncompliance in peer review and in final award decision.

The Proposal Narrative must include the following sections:

### a. Statement of the Problem

Describe the challenges faced in the applicant region related to overdose and drug-related crime and public safety. Describe the need to expand from a statewide to regional drug data center and outline the issues that a regional data center will address.

Document the impact of opioids, stimulants, and other substances in the area proposed to be supported by the regional data center. The applicant must provide verified data sources to support the statement of the problem.

Identify any specific challenges motivating the applicant's interest to apply for this grant.

Explain the applicant's inability to fund the proposed project without federal assistance; describe any existing funding or resources that will be leveraged to support the proposed project.

### b. Project Design and Implementation

Describe the strategy that will address the "Statement of the Problem," including describing in detail the proposed expansion to a regional drug data research center.

List the activities and describe how they relate to the stated objectives. Activities are the specific actions to be undertaken to fulfill the program's objectives and reach the program's goal.

Provide a detailed description of the method(s) to be used to carry out each activity.

Address in detail how the applicant proposes to develop the deliverables and dedicated resources to support this project.

Describe any potential barriers to implementing the project and the strategies that will be used to overcome those barriers.

Include a timeline/project plan that identifies the major tasks and deliverables of the proposed project, expected completion dates, and who is responsible for each activity. The timeline/project plan should be clearly linked to the project's design.

### c. Capabilities and Competencies

Describe the applicant's capabilities and competencies to accomplish the project's goal and objectives. Include demonstrated knowledge and expertise with multisector data and development of data architecture.

Describe the management structure and staffing, specifically identifying the key person (or people) responsible for carrying out the project activities.

Identify each core data source that has demonstrated commitment to this effort via an interagency agreement, letter of commitment or memorandum of understanding. Discuss any previous collaboration that occurred that will help to achieve the objectives. Explain existing data sharing agreements.

### d. Plan for Collecting the Data Required for this Solicitation's Performance Measures

For each objective, identify the criteria that will determine how and if it was successfully met, as well as one or more specific measurable outcome(s) and the data sources that will be used to determine whether or not the outcome was accomplished. All applicants must indicate their willingness and ability to collect and report performance and outcome data through BJA's reporting tools (no personally identifiable information will be collected).

Describe the process for measuring project performance. Identify who will collect the data, who is responsible for performance measurements, and how the information will be used to guide and evaluate the project's impact.

Note: An applicant is **not** required to submit performance data with the application. Rather, performance measure information is included as a notification that award recipients will be required to submit performance data as part of each award's reporting requirements. Some measures are presented as examples, while others are the exact measures that every recipient will be expected to address.

- 3. Capabilities and Competencies (25%) evaluate the applicant's administrative and technical capacity to successfully accomplish the goals and objectives.
- 4. Plan for Collecting the Data Required for this Solicitation's Performance Measures (10%) evaluate the applicant's understanding of the performance data reporting requirements and the plan for collecting the required data.
- 5. Budget (10%) evaluate for completeness, cost effectiveness, and allowability (e.g., reasonable, allocable, and necessary for project activities).

### Other Review Criteria/Factors

Other important considerations for BJA include geographic diversity, strategic priorities ( specifically including, but not limited to, those priority areas already mentioned, if applicable), available funding, past performance, and the extent to which the Budget Web-Based form accurately explains project costs that are reasonable, necessary, and otherwise allowable under federal law and applicable federal cost principles.

### **Review Process**
