Patrick Leahy Bulletproof Vest Partnership (BVP) Program

Through the BVP Program, government units can apply for funding to purchase bullet-resistant body armor for their sworn law enforcement officers. A jurisdiction's chief executive is required to provide general oversight and approval of key transactions between the BVP Program and the jurisdiction's participating law enforcement agencies. BVP recipients are reimbursed up to 50 percent of the cost of each unit of eligible body armor purchased.
