I. Introduction

An intelligence fusion center is an effective and efficient mechanism to exchange information and intelligence, maximize resources, streamline operations, and improve the ability to fight crime and terrorism by analyzing data from a variety of sources. Today's increased security needs not only dictate enhanced information sharing but also highlight the need to balance the sharing of information with the rights of persons in the United States. Ethical and legal obligations compel personnel, authorized users, and participating entities to protect constitutional rights, including privacy and other civil liberties, and civil rights throughout the information sharing process. To accomplish this, appropriate privacy, civil rights, and civil liberties protection policies must be in place. This document was therefore developed to provide a template and supporting information to help fusion center policy personnel develop and update policies for their respective centers.

A. What Is a Privacy, Civil Rights, and Civil Liberties (P/CRCL) Policy?

A privacy, civil rights, and civil liberties policy (P/CRCL policy) is a written, published statement that articulates the fusion center's position on how it handles the personally identifiable information (PII) and other personal, sensitive information it seeks, receives, or uses in the normal course of business (see the definition of "personally identifiable information" in Appendix A, Terms and Definitions). Civil rights and civil liberties protections are clearly expressed in the P/CRCL policy (see the definitions of "civil rights" and "civil liberties" in Appendix A, Terms and Definitions). The purpose of a P/CRCL policy is to articulate within the center, to external agencies that access and share information with the center, to other entities, and publicly that the center will adhere to legal requirements and policy and procedural provisions that enable gathering and sharing of information to occur in a manner that protects constitutional rights, including personal privacy and other civil liberties, and civil rights.

Privacy, civil rights, and civil liberties protections should be formulated in the planning and development stages of a justice information sharing system and must be fully implemented. As systems are designed, a Privacy Impact Assessment (PIA) or analysis should be conducted, and protections should be developed for PII and other personal, sensitive information to ensure that such information is properly collected, maintained, or distributed.

1. How does a PIA inform a P/CRCL Policy?

A PIA is a process by which an entity can examine the P/CRCL risks in the entity's information system and sharing activities. In general, a PIA evaluates the process through which PII is collected, stored, protected, shared, managed, and purged. By completing a PIA, entities are able to identify P/CRCL vulnerabilities and to address and mitigate them through the design and implementation of policies.

Ideally, PIAs are performed when information systems are created, and the results are used to inform the development of system P/CRCL policies. However, PIAs may also be completed when existing systems are significantly modified or at any time a system change creates P/CRCL risks. If the system is already operational, a PIA may still be conducted. For more information, a variety of state, local, tribal, and territorial (SLTT) and federal PIA guidance and resources are available at <https://it.ojp.gov/privacy/>.

2. How does a P/CRCL policy differ from a security policy?

Although security policies complement privacy policies, their main function is to protect organizational assets, including information technology and data. As such, security policies may not focus on potential harm to an individual, and they also do not typically address the purpose for gathering or collecting PII in the first place, address data quality, specify how information and intelligence should be used and with whom it should be shared, or establish policy on retention. A comprehensive P/CRCL policy will address both security and privacy, including key privacy, civil rights, and civil liberties protection issues.

B. Benefits of a P/CRCL Policy

A strong P/CRCL policy is good public policy, because it is responsive to widely held public expectations about the collection and use of information about individuals and the fair and open operation of a democratic government. A well-developed P/CRCL policy mitigates potential liability risks to the center and external agencies that access and share information with the center and protects and promotes public trust in information sharing. A comprehensive policy that is properly enforced will also result in more effective and efficient use of public resources.

C. Template Purposes

Existing federal and state constitutional provisions, statutes, rules, and regulations forbid certain conduct and prescribe what and how information can be collected, used, maintained (including storage, review, and validation/purge), and shared. However, there may be gaps in these provisions—areas in which centers and individuals can exercise discretion in deciding how to proceed. Centers are encouraged to adopt policies and practices based on the exercise of this discretion in a manner that leads to more comprehensive protection of privacy, civil rights, and civil liberties. This template was developed for new fusion centers that do not have comprehensive P/CRCL policies. The template is designed to assist each center's personnel with the task of developing a P/CRCL policy related to the information that the center collects, receives, maintains, archives, accesses, and discloses to center personnel, governmental agencies, Information Sharing Environment (ISE) participants, and other participating criminal justice and public safety agencies, as well as to private contractors and the general public. The provisions suggested in this template are intended to be incorporated into the center's general operational policies and day-to-day operations and to provide explicit and detailed privacy protection guidance to center personnel and other authorized source and user agencies. Each section is a fundamental component of a comprehensive policy that includes baseline provisions on information collection, data quality, collation and analysis, merging records, information access and disclosure, redress, security safeguards, retention and destruction, accountability and enforcement, and training.

For fusion centers that already have approved, comprehensive P/CRCL policies, this template will assist personnel in identifying potential policy areas that may require updates to reflect changes in law and implementation experience related to the information those centers collect, receive, maintain, archive, access, and disclose.

D. How to Use This Template

Chapter II of this template groups P/CRCL policy concepts into related sections. Each section contains pertinent policy questions that are shown in **bold** type, followed by useful policy sample language. To assist centers that have completed a draft policy but need to add Information Sharing Environment (ISE) or suspicious activity reporting (SAR) provisions, sections containing ISE components are **boxed** and sections containing provisions relating to SAR are **shaded**. For more information on the ISE, refer to Section I.F, The Information Sharing Environment, and Section I.G, The ISE and Fusion Centers.

Frequently, fusion centers have existing privacy-related policies and practices described in broader policy documents (e.g., concept of operations, standard operating procedures, user agreements, and employee handbooks). There may also be cross-over between the provisions in this template and other policies. In accordance with template Section C, Governance and Oversight, the center's designated privacy oversight committee or team is charged with reviewing and updating the center's P/CRCL policy in response to changes in law or implementation experience. This updated template is intended to assist with that process.

In addition, in accordance with template Sections N, Accountability and Enforcement, and N.1, Information System Transparency, each agency is strongly encouraged to make its updated P/CRCL policy available to the public, even if the other existing policies are not made publicly available. As such, consolidating existing policies into one P/CRCL policy is highly recommended. Centers are cautioned, however, against

simply providing a cross-reference to other policies in effect.¹ Cross-referencing, without excerpting the applicable policy language, should be done only if those policies are also available to the public; otherwise, centers should restate the applicable language in their P/CRCL policies.

E. Template Modifications

1. Customizing Your Center's P/CRCL Policy

It is important to note that this updated P/CRCL policy development template in Chapter II is **not** intended to be used **as is**, without modification. Nor is it intended to create inconsistencies with applicable laws and regulations. Each section represents the foundational components of an effective P/CRCL policy but does not cover all concepts particular to your center, its unique processes and procedures, or the specific constitutional provisions, laws, ordinances, or regulations applicable within your state. Further, certain concepts or questions may not be applicable. The updated template represents a **starting point** for new centers seeking to establish minimum baseline privacy, civil rights, and civil liberties protections and identifies the minimum updates for those fusion centers with comprehensive P/CRCL policies already in place. Centers are encouraged to complete as many of the template questions as are applicable; to update and enhance sections to reflect changes to applicable statutes, rules, standards, or policies; and to provide additional sections for provisions that are not addressed.

To facilitate this process, the following appendices have been developed for fusion center review and customization, as appropriate, and should be incorporated by reference in the center's P/CRCL policy:

- Appendix A—Terms and Definitions
- Appendix B—Federal and SLTT Laws, Regulations, and Guidance Relevant to Seeking, Retaining, and Disseminating Justice Information
- Appendix C—Fair Information Practice Principles (FIPPs)

While it is important for entities to review each of the questions contained in the policy template, the sample policy language, without policy questions, has been provided in Appendix D ("Sample Fusion Center P/CRCL Policy") for ease of customization.

2. Supplementing Your Center's P/CRCL Policy With Your Center's Technology-Related Policies

In order to promote transparency and public trust, each center is also encouraged to attach to its P/CRCL policy any publicly available **technology-related** P/CRCL policies adopted by its fusion center (e.g., policies governing the use of automated license plate readers, real-time and open source analysis, face recognition). See Appendix E ("Technology-Related P/CRCL Policy or Policies of the **[name of center]**"). Each technology-related policy should be a separate appendix, including any new technology-related P/CRCL policies once they are adopted by the center and made publicly available.

In addition, centers may leverage technology-related P/CRCL policy templates that were developed under the auspices of the Criminal Intelligence Coordinating Council (CICC), Global Justice Information Sharing Initiative, and supported by the Bureau of Justice Assistance, Office of Justice Programs, U.S. Department of Justice, in collaboration with the U.S. Department of Homeland Security. Appendix F provides resources that may be helpful to review and includes references to templates that were designed to assist law enforcement entities and fusion centers in developing technology-related P/CRCL policies (e.g., real-time and open source analysis, license plate readers).

¹ Providing a cross-reference to a numbered section (e.g., "policy number 201.56-B, section 6.a.") within a non-publicly available policy, without excerpting the relevant text, will not properly inform the reader of the substance of the cited provision. For this reason, it is better to excerpt (or restate) the actual language of the specific policy provision the center wants to emphasize within the P/CRCL policy.

F. The Information Sharing Environment (ISE)

In accordance with Section 1016 of the Intelligence Reform and Terrorism Prevention Act of 2004 (IRTPA), as amended, the ISE is a conceptual framework composed of the policies, procedures, and technologies linking the resources (people, systems, databases, and information) of SLTT agencies, federal agencies, and the private sector to facilitate terrorism-related information sharing, access, and collaboration. Consistent with Presidential Guideline 5,² the U.S. Attorney General, the U.S. Department of Justice (DOJ), and the Office of the Director of National Intelligence (ODNI)—in coordination with the Program Manager for the ISE (PM-ISE)³ and the heads of federal departments and agencies that possess or use intelligence or other terrorism-related information—developed privacy guidelines for the ISE, titled *Guidelines to Ensure That the Information Privacy and Other Legal Rights of Americans Are Protected in the Development and Use of the Information Sharing Environment* (ISE Privacy Guidelines). The ISE Privacy Guidelines describe the means by which federal departments and agencies participating in the ISE will protect privacy and civil liberties in the development and operation of the ISE.

G. The ISE and Fusion Centers

According to the ISE Privacy Guidelines, “Protected information” [see **Appendix A, Terms and Definitions**] “should be shared through the ISE only if it is terrorism information, homeland security information, or law enforcement information related to terrorism (terrorism-related information).” Fusion centers serve as the primary points of contact within states or regions for further dissemination of terrorism-related information consistent with DOJ’s *Fusion Center Guidelines* and applicable SLTT laws and regulations. As the ISE develops, fusion centers and possibly other SLTT agencies receiving or sharing terrorism-related information will be required to adopt policies that parallel the requirements articulated in the ISE Privacy Guidelines in order to be eligible to access and use federal agency terrorism-related information. The ISE Privacy Guidelines stipulate “that such non-federal entities develop and implement appropriate policies and procedures that provide protections (for terrorism-related information) that are **at least as comprehensive** as those contained in these Guidelines.” To facilitate centers in meeting this requirement, this P/CRCL policy template has incorporated the primary components of the ISE Privacy Guidelines. Throughout the template, sections expressly referencing ISE components are boxed for emphasis. These enhanced protections for terrorism-related information are not required for the collection and sharing of other types of information and intelligence, nor do they, in any manner, restrict fusion centers from collecting and sharing “all crimes—all hazards” information.

⁴ The Implementation Report is included as a reference for historical and foundational purposes, although some key developments should be noted. Following the issuance of the Implementation Report in 2008 federal, state, and local partners developed a pilot program known as the ISE-SAR Evaluation Environment (ISE-SAR EE) to determine whether the national standard (the SAR Functional Standard) for reporting and evaluating suspicious activity could facilitate the identification of patterns of criminal activity with a potential nexus to terrorism. A comprehensive privacy, civil rights, and civil liberties protection framework for identifying and sharing ISE-SARs was developed, tested, and validated through the ISE-SAR EE and integrated into policies, business processes, and activities of the participating sites. In addition, since the issuance of the Implementation Report in 2008, the ISE-SAR Functional Standard has been twice revised and currently defines a SAR as “official documentation of observed behavior that is reasonably indicative of pre-operational planning associated with terrorism or other criminal activity.” Finally, the FBI’s eGuardian currently hosts the Nationwide Suspicious Activity Reporting (SAR) Initiative (NSI) SAR Data Repository and serves as the system for receiving, tracking, and sharing ISE-SARs in the NSI.

II. Policy Development Template

A. Purpose Statement

- 1. What is the purpose of establishing a privacy, civil rights, and civil liberties protection policy (i.e., what does the center hope to accomplish in adopting this policy)? Provide a succinct, comprehensive statement of purpose.**

The mission of the **[name of center]** is to collect, evaluate, analyze, and disseminate information and intelligence data (records) regarding criminal and terrorist activity in the **[region or state]** while protecting privacy, civil rights, civil liberties, and other protected interests. This includes implementing appropriate privacy and civil liberties safeguards as outlined in the principles of the Privacy Act of 1974, as amended, to ensure that the information privacy and other legal rights of individuals and organizations are protected (**see definitions of “Fair Information Practice Principles” [FIPPs] and “Protected Information” in [insert policy definitions section (see Appendix A, Terms and Definitions)]**).

The purpose of this privacy, civil rights, and civil liberties (P/CRCL) protection policy is to promote **[name of center]** and user conduct that complies with applicable federal, state, local, tribal, and territorial law **[cite to policy definitions section (see Appendix A, Terms and Definitions)]** and assists the center and its users in:

- Increasing public safety and improving national security.

- Minimizing the threat and risk of damage to real or personal property.
- Protecting individual privacy, civil rights, civil liberties, and other protected interests.
- Protecting the integrity of the criminal investigatory, criminal intelligence, and justice system processes and information.
- Minimizing the reluctance of individuals or groups to use or cooperate with the justice system.
- Supporting the role of the justice system in society.
- Promoting governmental legitimacy and accountability.
- Not unduly burdening the ongoing business of the justice system.
- Making the most effective use of public resources allocated to public safety agencies.

B. Policy Applicability and Legal Compliance

- 1. Who is subject to the P/CRCL policy?**

Identify who must comply with the policy; for example, center personnel, participating agencies, and private contractors.

All **[name of center]** personnel, participating agency personnel, personnel providing information technology services to the center, staff members in other public agencies, private contractors providing services to the center, and other authorized users who are not employed by the center or a contractor will comply with the center's P/CRCL policy. participating justice and public safety agencies, as well as to private contractors, private entities, and the general public.

2. **How is the center's policy made available to personnel, participating agencies, and individual users (in print, online, etc.), and are acknowledgment of receipt and agreement to comply with this policy required in writing?**

The **[name of center]** will provide a printed or electronic copy of this policy to all center personnel, non-center personnel who provide services to the center, and to participating agencies and individual users. 3. **Does the center require *personnel and participating information-originating and user agencies* to be in compliance with all applicable constitutional and statutory laws protecting privacy, civil rights, and civil liberties in the gathering and collection, use, analysis, retention, destruction, sharing, disclosure, and dissemination of information?**

3. **Is there a designated and trained Privacy Officer who will handle reported errors and violations; oversee the implementation of privacy, civil rights, and civil liberties protections; and ensure that the center adheres to the provisions of the ISE Privacy Guidelines and other requirements for participation in the ISE?**

The **[name of center]**'s privacy committee is guided by a trained Privacy Officer **[who is the (position) of the center and]** who is appointed by the Director of the center. The Privacy Officer receives reports regarding alleged errors and violations of the provisions of this policy, receives and coordinates complaint resolution under the center's redress policy, and serves as the liaison for the center (and for the Information Sharing Environment), ensuring that privacy, civil rights, and civil liberties protections are implemented through efforts such as training, business process changes, and system designs that incorporate privacy-enhancing technologies. The Privacy Officer can be contacted at the following address: **[insert mailing address or e-mail address]**.

4. Who is responsible for ensuring that enforcement procedures and sanctions for noncompliance with the P/CRCL policy are adequate and enforced?

The [name of center]'s Privacy Officer ensures that enforcement procedures and sanctions outlined in [insert section number of policy (see Section N.3, Enforcement)] are adequate and enforced.

D. Definitions

1. What key words or phrases are regularly used in the policy for which the center wants to specify particular meanings?

This may include terms that are not commonly known or have multiple meanings that may need to be clarified to indicate which one applies to the P/CRCL policy. There may be legal definitions for terms in the statutes governing the operation of the justice information system. E. Information

1. Identify what information *may be* sought, retained, shared, disclosed, or disseminated by the center.

There may be different policy provisions for different types of information, such as tips and leads, including SARs, and ISE-SARs; criminal intelligence information; and fact-based information databases, such as criminal history records, case management information, deconfliction, wants and warrants, drivers' records, identification, and commercial databases.

Best Practice: It is suggested that center policies include information that details the different types of information databases/records that the center maintains or accesses and uses.

The [name of center] will seek or retain information (including "protected attributes") subject to conditions articulated in Section E.2., that:

- Is based on a possible threat to public safety or the enforcement of criminal law, or
- Is based on reasonable suspicion that an identifiable individual or organization has committed a criminal offense or is involved in or planning criminal (including terrorist) conduct or activity that presents a threat to any individual, the community, or the nation and that the information is relevant to the criminal (including terrorist) conduct or activity, or
- Is relevant to the investigation and prosecution of suspected criminal (including terrorist) incidents; the resulting justice system response; the enforcement of sanctions, orders, or sentences; or the prevention of crime, or
- Is useful in crime analysis or in the administration of criminal justice and public safety (including topical searches), and
- The source of the information is reliable and verifiable or limitations on the quality of the information are identified, and
- The information was collected in a fair and lawful manner, with the knowledge and consent of the individual, if appropriate.

The center may retain protected information that is based on a level of suspicion that is less than “reasonable suspicion,” such as tips and leads (including suspicious activity report [SAR] information) subject to the policies and procedures specified in this policy.

2. **Identify what information *may not* be sought, retained, shared, or disclosed by the center.**

This may include federal or state constitutional prohibitions or prohibitions in federal, state, local, tribal, or territorial laws.

In accordance with applicable laws, guidance, and regulations, the [name of center] will not seek or retain and will inform information-originating agencies not to submit information about individuals or organizations solely on the basis of their religious, political, or social views or activities; their participation in a particular noncriminal organization or lawful event; or their races, ethnicities, citizenship, national origin, ages, disabilities, genders, gender identities, or sexual orientations.

When participating on a federal law enforcement task force⁵ or when documenting a SAR or an ISE-SAR in the Nationwide Suspicious Activity Reporting (SAR) Initiative (NSI),⁶ race, ethnicity, gender, national origin, religion, sexual orientation, or gender identity must not be considered as factors creating suspicion. However, those attributes may be documented in specific suspect descriptions for identification purposes.

3. **Does your center apply labels to information (or ensure that the originating agency has applied labels) that indicate to the authorized user that:**

- **The information is protected information as defined in the ISE Privacy Guidelines or as defined to include PII on any individual regardless of citizenship or U.S. residency status? (Note: This definition may depend on state laws applicable to the collection and sharing of the information. See the definitions of “protected information” and “personally identifiable information” in Appendix A.) To what extent are organizations protected by the policy?**
- **The information is subject to specific information privacy or other similar restrictions on access, use, or disclosure, and, if so, what is the nature of such restrictions? There may be laws that restrict who can access information, how information can be used, and limitations on the retention or disclosure of certain types of information; for example, the identity of a sexual assault victim.**

The [name of center] applies labels to center-originated information (or ensures that the originating agency has applied labels) to indicate to the accessing authorized user that:

- The information is protected information (as defined by the ISE Privacy Guidelines) **[or] (as defined by the center to include PII on any individual) [cite applicable authority, if any, and cite to center’s definitions of “protected information” and “personally identifiable information,” in Appendix A of policy]**, and, to the extent expressly provided in this policy, includes organizational entities.
- The information is subject to **[local, state or federal]** laws restricting access, use, or disclosure.

4. **Does your center categorize information (or ensure that the originating agency has categorized information) based on its nature (for example, tips and leads [including suspicious activity reports], criminal history, intelligence information, case records, conditions of supervision, case progress), usability, and quality?**

The purpose of categorizing information is to assist users in:

- **Determining the quality and accuracy of the information.**
- **Making the most effective use of the information.**
- **Knowing whether and with whom the information can be appropriately shared.**

The **[name of center]** personnel will, upon receipt of information, assess the information to determine or review its nature, usability, and quality. Personnel will assign categories to the information (or ensure that the originating agency has assigned categories to the information) to reflect the assessment, such as:

- Whether the information consists of tips and leads (including SAR data), criminal history, intelligence information, case records, conditions of supervision, case progress, or other information category.
- The nature of the source as it affects veracity (for example, anonymous tip, trained interviewer or investigator, public record, private sector).
- The reliability of the source (for example, reliable, usually reliable, unreliable, unknown).
- The validity of the content (for example, confirmed, probable, doubtful, cannot be judged).

5. **When information is gathered or collected and/or retained by the center, is it labeled (by record, data set, or system of records), and are limitations assigned to identify who is allowed to see (access) and use the information (for example, credentialed, role-based levels of access)?**

At the time a decision is made by the **[name of center]** to retain information, it will be labeled (by record, data set, or system of records), to the maximum extent feasible, pursuant to applicable limitations on access and sensitivity of disclosure to:

- Protect confidential sources and police undercover techniques and methods.
- Not interfere with or compromise pending criminal investigations.
- Protect an individual's right of privacy and his or her civil rights and civil liberties.
- Provide legally required protections based on the individual's status as a child, sexual abuse victim, resident of a substance abuse treatment program, resident of a mental health treatment program, or resident of a domestic abuse shelter.

6. **What conditions prompt the labels assigned in Section E.5 to be reevaluated?**

The labels assigned to existing information under **[insert section number of policy (see Section E.5 above)]** will be reevaluated whenever:

- New information is added that has an impact on access limitations or the sensitivity of disclosure of the information.
- There is a change in the use of the information affecting access or disclosure limitations; for example, the information becomes part of court proceedings for which there are different public access laws.

7. If your center receives or collects *tips and leads* (including SAR information—information received or collected based on a level of suspicion that may be less than “reasonable suspicion”), does your center maintain and adhere to policies and procedures for:

- **Receipt and collection (information acquisition)**—How the information is originally gathered, collected, observed, or submitted?
- **Assessment of credibility and value (organizational processing)**—The series of manual and automated steps and decision points followed by the center to evaluate the SAR information?
- **Storage (integration and consolidation)**—The point at which SAR information is placed into a SAR database, using a standard submission format, for purposes of permitting access by authorized personnel and agencies?
- **Access and dissemination (data retrieval and dissemination)**—The process of making the information available to other agencies and obtaining feedback on investigative outcomes?
- **Retention and security of the information?**

Note: Some centers, based on state law or policy, use the “reasonable suspicion” standard as the threshold for sharing any information and intelligence containing PII. If that is the case, the policy should so indicate.

[Best Practice: State the retention period for nonvalidated tips and leads.]

[Name of center] personnel are required to adhere to the following practices and procedures for the receipt, collection, assessment, storage, access, dissemination, retention, and security of tips and leads (including SAR information). Center personnel will:

- Prior to allowing access to or dissemination of the information, ensure that attempts to validate or refute the information have taken place and that the information has been assessed for sensitivity and confidence by subjecting it to an evaluation or screening process to determine its credibility and value and categorize the information as unsubstantiated or uncorroborated if attempts to validate or determine the reliability of the information have been unsuccessful. The center will use a standard reporting format and data collection codes for SAR information.
- Store the information using the same storage method used for data which rises to the level of reasonable suspicion and which includes an audit and inspection process, supporting documentation, and labeling of the data to delineate it from other information.
- Allow access to or disseminate the information using the same (or a more restrictive) access or dissemination standard that is used for data that rises to the level of reasonable suspicion (for example, “need-to-know” and “right-to-know” access or dissemination for PII).
- Regularly provide access to or disseminate the information in response to an interagency inquiry for law enforcement, homeland security, or public safety and analytical purposes or provide an assessment of the information to any agency, entity, individual, or the public when credible information indicates potential imminent danger to life or property.
- Retain information for [insert retention period] in order to work an unvalidated⁷ tip or lead to determine its credibility and value or assign a “disposition” label (for example, undetermined or unresolved, cleared or unfounded, verified, or under

⁷ SAR information is a subset of tips and leads. Retention and use of a tip or a lead will be affected by whether it has been validated. See the definitions of “unvalidated information,” “validated information,” and nonvalidated information” in Appendix A, Terms and Definitions.

active investigation) so that a subsequently authorized user knows the status and purpose for the retention and will retain the information based on the retention period associated with the disposition label.

- Adhere to and follow the center's physical, administrative, and technical security measures to ensure the protection and security of tips, leads, and SAR information. Tips, leads, and SAR information will be secured in a system that is the same as or similar to the system that secures data that rises to the level of reasonable suspicion.

8. Does your center incorporate the gathering, processing, reporting, analyzing, and sharing of terrorism-related suspicious activities and incidents (SAR process) into existing processes and systems used to manage other crime-related information and criminal intelligence?

The [name of center] incorporates the gathering, processing, reporting, analyzing, and sharing of terrorism-related suspicious activities and incidents (SAR process) into existing processes and systems used to manage other crime-related information and criminal intelligence, thus leveraging existing policies and protocols utilized to protect the information, as well as information privacy, civil rights, and civil liberties.

9. For purposes of sharing terrorism-related information through the ISE, has your center identified its data holdings that contain protected information (information about U.S. citizens or lawful permanent residents or all individuals) to be shared through the ISE? [ISE information refers to terrorism-related information, which includes terrorism information, homeland security information, and law enforcement information related to terrorism.] Further, has your center put in place notice mechanisms, such as metadata or data field labels, for enabling ISE authorized users to determine the nature of the protected information that the center is making available in the ISE, such that participants can handle the information in accordance with applicable legal requirements?

Refer to Appendix A for a definition of "metadata."

The [name of center] will identify and review protected information that may be accessed from or disseminated by the center prior to sharing that information through the Information Sharing Environment. Further, the center will provide notice mechanisms, including but not limited to metadata or data field labels, to enable ISE authorized users to determine the nature of the protected information and how to handle the information in accordance with applicable legal requirements.

Note: The latter question needs to be addressed when a center opts **not** to provide notice mechanisms for all PII such that users are able to determine the nature of the information and handle it in accordance with applicable legal requirements.

10. Does your center require certain basic descriptive information (metadata tags or labels) to be entered and associated with each record, data set, or system of records containing personally identifiable information that will be accessed, used, and disclosed, including terrorism-related information shared through the ISE?

Basic information may include, where relevant and appropriate:

- The name of the originating center or agency, department, component, and subcomponent (where applicable).

- If applicable, the name of the center's justice information system from which the information is disseminated.
- The date the information was collected (submitted) and, when feasible, the date its accuracy was last verified.
- The title and contact information for the person to whom questions regarding the information, including its accuracy, should be directed.

The [name of center] requires certain basic descriptive information (metadata tags or labels) to be entered and electronically associated with data (or content) for which there are special laws, rules, or policies regarding access, use, and disclosure, including terrorism-related information shared through the ISE. The types of information include:

- The name of the originating center, department or agency, component, and subcomponent.
- The name of the center's justice information system from which the information is disseminated.
- The date the information was collected and, when feasible, the date its accuracy was last verified.
- The title and contact information for the person to whom questions regarding the information should be directed.

11. **Does your center attach (or ensure that the originating agency has attached) specific labels and descriptive information (metadata) to the information it collects and retains that clearly indicate legal restrictions on sharing of information based on information sensitivity or classification?**

The [name of center] will attach (or ensure that the originating agency has attached) specific labels and descriptive metadata to information that will be used, accessed, or disseminated to clearly indicate any legal restrictions on information sharing based on information sensitivity or classification.

12. **Does your center maintain a record of the source of the information sought and collected?**

The [name of center] will keep a record of the source of all information sought and collected by the center.

F. Acquiring and Receiving Information

1. **Are there applicable state and federal constitutional provisions and statutes that govern or specify the techniques and methods the center may employ when seeking and receiving information?**

Identify and list these laws and provisions in the policy. Refer to Appendix B for a partial listing of applicable state privacy laws as well as primary federal laws relevant to seeking, retaining, or disseminating information at the federal level.

Information-gathering (acquisition) and access and investigative techniques used by the [name of center] and information-originating agencies will remain in compliance with and will adhere to applicable laws and guidance, including, but not limited to:

- 28 CFR Part 23⁸ regarding “criminal intelligence information,” as applicable.
- The FIPPs; see **[refer to Appendix C, “Fair Information Practice Principles”]** but note that under certain circumstances, the FIPPs may be superseded by authorities paralleling those provided in the federal Privacy Act; state, local, tribal, or territorial law; or center policy).
- Criminal intelligence guidelines established under the U.S. Department of Justice’s (DOJ) *National Criminal Intelligence Sharing Plan* (NCISP) (Ver. 2).
- Constitutional provisions; **[state]** code, Section **[insert number]**; and administrative rules, as well as regulations and policies that apply to multijurisdictional intelligence and information databases.

2. Does your center’s SAR process provide for human review and vetting to ensure that information is both gathered in an authorized and lawful manner and, when applicable, determined to have a potential terrorism nexus? Are law enforcement officers and appropriate center and participating agency staff trained to recognize those behaviors and incidents that are indicative of criminal activity associated with terrorism?

The **[name of center]**’s SAR process provides for human review and vetting to ensure that information is both **gathered in an authorized and lawful manner** and, when applicable, determined to have a potential terrorism nexus. Law enforcement officers and appropriate center and participating agency staff members will be trained to recognize those behaviors and incidents that are indicative of criminal activity associated with terrorism.

3. Does your center’s SAR process include safeguards to ensure, to the greatest degree possible, that only information regarding individuals involved in activities that have been determined to be consistent with criminal activities associated with terrorism will be documented and shared through the ISE?

The **[name of center]**’s SAR process includes safeguards to ensure, to the greatest degree possible, that only information regarding individuals involved in activities that have been determined to be consistent with criminal activities associated with terrorism will be documented and shared through the ISE. These safeguards are intended to ensure that information that could violate civil rights (race, ethnicity, national origin, religion, etc.) and civil liberties (speech, assembly, association, religious exercise, etc.) will not be intentionally or inadvertently gathered, documented, processed, and shared. **[Refer to policy (see Sections E.2 and F.2 of this template).]**

4. Does the center (if an operational agency conducting investigations) adhere to a policy regarding the investigative techniques the center will follow when acquiring information (for example, an intrusion-level statement)?

Information-gathering and investigative techniques used by the **[name of center]** will and those used by originating agencies should be the least intrusive means necessary in the particular circumstances to gather information it is authorized to seek or retain.

5. Are agencies that access your center's information and/or share information with your center required to adhere to applicable law and policy?

External agencies that access the **[name of center]**'s information or share information with the center are governed by the laws and rules governing those individual agencies, including applicable federal and state laws.

6. If the center contracts with commercial databases, how does the center ensure that the commercial database entity is in legal compliance in its information-gathering techniques?

The **[name of center]** will contract only with commercial database entities that provide an assurance that their methods for gathering PII comply with applicable local, state, tribal, territorial, and federal laws, statutes, and regulations and that these methods are not based on misleading information-gathering practices.

7. What are the types of information sources (nongovernmental, commercial, or private entities or institutions or classes of individuals) from which the center will not receive, seek, accept, or retain information?

The **[name of center]** will not directly or indirectly receive, seek, accept, or retain information from:

- An individual who or nongovernmental entity that may receive a fee or benefit for providing the information, except as expressly authorized by law or center policy.
- An individual who or information provider that is legally prohibited from obtaining or disclosing the information.

G. Data Quality Assurance

1. Does your center have established procedures and processes (manual and electronic) to ensure the quality (for example, accurate, complete, current, verifiable, and reliable) of the information it collects and maintains?

The **[name of center]** will make every reasonable effort to ensure that information sought or retained is derived from dependable and trustworthy sources; accurate; current; complete, including the relevant context in which it was sought or received and other related information; and merged with other information about the same individual or organization only when the applicable **standard [refer to Section I, Merging Records, or appropriate policy section]** has been met.

2. Does your center provide for additional fact development during the vetting process?

The **[name of center]** will put in place a process for additional fact development during the vetting process where a SAR includes PII and is based on behaviors that are not inherently criminal. The **[name of center]** will articulate additional facts or circumstances to support the determination that the behavior observed is not innocent but rather reasonably indicative of preoperational planning associated with terrorism.

3. **Does your center apply labels (or ensure that the originating agency has applied labels) to the information regarding its level of quality (for example, accurate, complete, current, verifiable, and reliable)?**

At the time of retention in the system, the information will be labeled regarding its level of quality (accuracy, completeness, currency, and confidence [verifiability and reliability]).

4. **Does your center research alleged or suspected errors and deficiencies (or refer them to the originating agency)? How does your center respond to confirmed errors or deficiencies?**

The [name of center] investigates, in a timely manner, alleged errors and deficiencies (or refers them to the originating agency) and corrects, deletes, or refrains from using protected information found to be erroneous or deficient.

5. **Does your center reevaluate (or ensure that the originating agency reevaluates) the labeling of information when new information is gathered that has an impact on the confidence (source reliability and content validity) in the information previously obtained?**

The labeling of retained information will be reevaluated by the [name of center] or the originating agency when new information is gathered that has an impact on confidence (source reliability and content validity) in previously retained information.

6. **When the center reviews the quality of the information it originates and identifies data that may be inaccurate or incomplete, includes incorrectly merged information, is out of date, cannot be verified, has a questionable source, or lacks adequate context such that the rights of the individual may be affected, what is the center's procedure for correction or destruction?**

The [name of center] will conduct periodic data quality reviews of information it originates and make every reasonable effort to ensure that the information will be corrected, deleted from the system, or not used when the center identifies information that is erroneous, misleading, obsolete, or otherwise unreliable; the center did not have authority to gather the information or to provide the information to another agency; or the center used prohibited means to gather the information (except when the center's information source did not act as the agent of the center in gathering the information).

7. **When the center reviews the quality of the information it has received from an originating agency and identifies data that may be inaccurate or incomplete, includes incorrectly merged information, is out of date, cannot be verified, has a questionable source, or lacks adequate context such that the rights of the individual may be affected, does the center notify the originating agency or the originating agency's Privacy Officer? What method is used to notify the agency (written, telephone, or electronic notification)?**

Originating agencies external to the [name of center] are responsible for reviewing the quality and accuracy of the data provided to the center. The center will review the quality of information it has received from an originating agency and advise the appropriate contact person in the originating agency, in writing or electronically, if its data is alleged, suspected, or found to be inaccurate, incomplete, out of date, or unverifiable.

8. **When the center reviews the quality of the information it has provided to an external agency and identifies data that may be inaccurate or incomplete, includes incorrectly merged information, is out of date, cannot be verified, has a questionable source, or**

lacks adequate context such that the rights of the individual may be affected, does the center notify the external agency? What method is used to notify the agency (written, telephone, or electronic notification)?

The **[name of center]** will use written or electronic notification to inform recipient agencies when information previously provided to the recipient agency is deleted or changed by the center because the information is determined to be erroneous, includes incorrectly merged information, is out of date, cannot be verified, or lacks adequate context such that the rights of the individual may be affected.

H. Collation and Analysis

- 1. Who is authorized (position/title, credentials, clearance level[s], etc.) to analyze information acquired or accessed by the center?**

Information acquired or received by the **[name of center]** or accessed from other sources will be analyzed only by qualified and properly trained individuals who have successfully completed a background check and possess the appropriate security clearance.

- 2. What information is analyzed?**

Information subject to collation and analysis is information as defined and identified in **[refer to Section E, Information, or appropriate policy section]**.

- 3. For what purpose(s) is the information analyzed?**

Best Practice: Does the center's Privacy Officer or privacy oversight committee review [and approve] all analytical products prior to dissemination or sharing by the center?

Information acquired or received by the **[name of center]** or accessed from other sources is analyzed according to priorities and needs and will be analyzed only to:

- Further crime prevention (including terrorism), law enforcement, public safety, force deployment, or prosecution objectives and priorities established by the center.
- Provide tactical and/or strategic intelligence on the existence, identification, and capability of individuals and organizations suspected of having engaged in or engaging in criminal (including terrorist) activities.

Best Practice Sample Language: The **[name of center]** requires that all analytical products be reviewed **[and approved]** by the Privacy Officer **[or privacy oversight committee]** to ensure that they provide appropriate privacy, civil rights, and civil liberties protections prior to dissemination or sharing by the center.

I. Merging Records

- 1. Who is authorized (position/title, credentials, clearance level[s], etc.) to merge records?**

Information will be merged only by qualified individuals who have successfully completed a background check and possess the appropriate security clearance, if applicable, and have been selected, approved, and trained accordingly.

- 2. What matching criteria does your center require when attempting to merge information from multiple records allegedly about the same individual? In other**

words, when two records are compared for possible merger, are there certain attributes (name, fingerprint-based corrections number, date of birth, etc.) that must match, or is there a minimum number of attributes (for example, two out of five) that must match to link the two records as relating to the same person?

Example 1:

Records about an individual or an organization from two or more sources will not be merged by the **[name of center]** unless there is sufficient identifying information to clearly establish that the information is about the same individual or organization. The set of identifiers sufficient to allow merging will consist of all available attributes that can contribute to a higher accuracy of match.

Example 2:

The set of identifying information sufficient to allow merging by the **[name of center]** may include the name (full or partial) and, in most cases, one or more of the following: date of birth; law enforcement or corrections system identification number; individual identifiers, such as fingerprints, photographs, physical description, height, weight, eye and hair color, race, ethnicity, tattoos, or scars; social security number; driver's license number; or other biometrics, such as DNA, retinal scan, or facial recognition. The identifiers or characteristics that, when combined, could clearly establish that the information from multiple records is about the same organization may include the name, federal or state tax ID number, office address, and telephone number.

3. If the criteria specified in Section I.2 are not met, does the center have a procedure for associating records?

If the matching requirements are not fully met but there is reason to believe the records are about the same individual, the information may be associated by the **[name of center]** if accompanied by a clear statement that it has not been adequately established that the information relates to the same individual or organization.

J. Sharing and Disclosure

1. What types of user actions and permissions are controlled by the center's access limitations?

Note: User actions and permissions are often used to (1) identify agencies and individuals with a need to know and right to know particular information or intelligence, access case management information, or access non- PII only or (2) identify who is authorized to submit or modify particular records or record sets, to have read-only access, to add/modify/delete records, or to grant privileges.

Best Practice: It is suggested that centers specify their method for identifying user actions and permissions in their P/CRCL policies.

Credentialed, role-based access criteria will be used by the **[name of center]**, as appropriate, to control:

- The information to which a particular group or class of users can have access based on the group or class.
- The information a class of users can add, change, delete, or print.
- To whom, individually, the information can be disclosed and under what circumstances.

2. For suspicious activity report information, does your center use a standard reporting format and commonly accepted data collection codes, and does the center's SAR information sharing process comply with the ISE Functional Standard for suspicious activity reporting?

Refer to Section I.H, Reference List, within the Introduction to this template for a listing of SAR information resources, such as DOJ's *Findings and Recommendations of the Suspicious Activity Report (SAR) Support and Implementation Project*⁹ and Office of the Program Manager, ISE, *Information Sharing Environment (ISE) Functional Standard (FS) Suspicious Activity Reporting (SAR)*, Version 1.5.5.

The [name of center] adheres to the current version of the ISE-SAR Functional Standard for its suspicious activity reporting (SAR) process, including the use of a standard reporting format and commonly accepted data collection codes and a sharing process that complies with the ISE-SAR Functional Standard for suspicious activity potentially associated with terrorism.

3. Describe the conditions and credentials by which access to and disclosure of records retained by the center will be provided *within the center or in other governmental agencies*. Is an audit trail kept of access to and disclosure of information retained by the center (e.g., dissemination logs, algorithms)?

Refer to N.2, Accountability, for more information on audit logs.

Access to or disclosure of records retained by the [name of center] will be provided only **to persons within the center or in other governmental agencies** who are authorized to have access and only for legitimate law enforcement, public protection, public prosecution, public health, or justice purposes and only for the performance of official duties in accordance with law and procedures applicable to the agency for which the person is working. An audit trail sufficient to allow the identification of each individual who accessed information retained by the center and the nature of the information accessed will be kept by the center.

4. Are participating agencies that access information from your center required to obtain approval from the originator of the information prior to further dissemination or to follow the disclosure law applicable to the originating agency?

Agencies external to the [name of center] may not disseminate information accessed or disseminated from the center without approval from the center or other originator of the information.

5. Describe the conditions under which access to and disclosure of records retained by the center will be provided *to those responsible for public protection, public safety, or public health*. Is an audit trail kept of access to and disclosure of information retained by the center (e.g., dissemination logs, algorithms)?

Refer to N.2, Accountability, for more information on audit logs.

Records retained by the [name of center] may be accessed by or disseminated **to those responsible for public protection, public safety, or public health** only for public protection, public safety, or public health purposes and only in the performance of official duties in accordance with applicable laws and procedures. An audit trail sufficient to allow

the identification of each individual who accessed or received information retained by the center and the nature of the information accessed will be kept by the center.

6. **If release of information may be made only under specific conditions (e.g., for *specific purposes* or to specific persons), are those conditions described? Is an audit trail kept?**

Refer to N.2, Accountability, for more information on audit logs.

Information gathered or collected and records retained by the [name of center] may be accessed or disseminated **for specific purposes** upon request by persons authorized by law to have such access and only for those uses and purposes specified in the law. An audit trail sufficient to allow the identification of each individual who requested, accessed, or received information retained by the center; the nature of the information requested, accessed, or received; and the specific purpose will be kept for a minimum of [specify the retention period for your jurisdiction for this type of request] by the center.

7. **Under what circumstances and what legal authority [citation to applicable law] will access to and disclosure of a record be provided to a member of the public in response to an information request, and are these circumstances described in your center's redress policy? Is an audit trail kept of disclosure of information retained by the center (e.g., dissemination logs, algorithms)?**

Refer to N.2, Accountability, for more information on audit logs.

Note: This issue does not apply to circumstances in which a center chooses to provide nonsensitive information to the public or to provide sensitive information in accordance with center policy in response to an emergency.

Information gathered or collected and records retained by the [name of center] may be accessed or disclosed to a **member of the public** only if the information is defined by law [citation to applicable law] to be a public record or otherwise appropriate for release to further the center's mission and is not exempt from disclosure by law. Such information may be disclosed only in accordance with the law and procedures applicable to the center for this type of information. An audit trail sufficient to allow the identification of each individual member of the public who accessed or received information retained by the center and the nature of the information accessed will be kept by the center. **[Refer to Section J.9 for the categories of records that will ordinarily not be provided to the public pursuant to applicable legal authority.]**

8. **Under what circumstances and to whom will the center *not disclose* records and information?**

Information gathered or collected and records retained by the [name of center] **will not** be:

- Sold, published, exchanged, or disclosed for commercial purposes.
- Disclosed or published without prior notice to the originating agency that such information is subject to disclosure or publication, unless disclosure is agreed to as part of the normal operations of the agency or specifically authorized by the originating agency.
- Disseminated to persons not authorized to access or use the information.

9. What are the categories of records that will ordinarily *not be provided* to the public pursuant to applicable legal authority?

Note: The policy must cite applicable legal authority for each category of records.

There are several categories of records that will ordinarily *not be provided* to the public:

- Records required to be kept confidential by law are exempted from disclosure requirements under **[cite public records act and applicable section]**.
- Information determined by the federal government to meet the definition of “classified information” as defined in the National Security Act, Public Law 235, Section 606, and in accordance with Executive Order 13549, Classified National Security Information Program for State, Local, Tribal, and Private Sector Entities, August 18, 2010.
- Investigatory records of law enforcement agencies that are exempted from disclosure requirements under **[cite public records act and applicable section]**. However, certain law enforcement records must be made available for inspection and copying under **[cite public records act and applicable section]**.
- A record or part of a record the public disclosure of which would have a reasonable likelihood of threatening public safety by exposing a vulnerability to terrorist attack is exempted from disclosure requirements under **[cite public records act and applicable section]**. By way of example, this *may include* a record assembled, prepared, or maintained to prevent, mitigate, or respond to an act of terrorism under **[cite public records act and applicable section]** or an act of agricultural terrorism under **[cite public records act and applicable section]**, vulnerability assessments, risk planning documents, needs assessments, and threat assessments.
- Protected federal, state, local, tribal, or territorial records, which may include records originated and controlled by another agency that cannot, under **[cite applicable law]**, be shared without permission.
- A record, or part of a record that constitutes trade secrets or information that is commercial, financial, or otherwise subject to a nondisclosure agreement that was obtained from a person and is privileged and confidential **[cite applicable law]**.

10. State the center’s policy on confirming the existence or nonexistence of information to persons or agencies that are not eligible to receive the information.

The **[name of center]** shall not confirm the existence or nonexistence of information to any person or agency that would not be eligible to receive the information unless otherwise required by law.

K. Redress

K.1 Disclosure

1. If required by state statute, what are the conditions under which the center will disclose information to an individual about whom information has been gathered? Is a record kept of all requests and of what information is disclosed to an individual?

Note: If the state public (open) records act provides procedures for disclosure, corrections, appeals, and handling of complaints when information is not subject to disclosure, these procedures should be summarized in the policy in lieu of using the sample language provided.

Upon satisfactory verification (fingerprints, driver's license, or other specified identifying documentation) of his or her identity and subject to the conditions specified in 2., below, an individual is entitled to know the existence of and to review the information about him or her that has been gathered and retained by the **[name of center]**. The individual may obtain a copy of the information for the purpose of challenging the accuracy or completeness of the information (correction). The center's response to the request for information will be made within a reasonable time and in a form that is readily intelligible to the individual. A record will be kept of all requests and of what information is disclosed to an individual.

2. What are the conditions under which the center will not disclose information to an individual about whom information has been gathered? Does the center refer the individual to the agency originating the information?

The existence, content, and source of the information will not be made available by the **[name of center]** to an individual when **[the policy must cite applicable legal authority for each stated basis for denial]**. Examples may include:

- Disclosure would interfere with, compromise, or delay an ongoing investigation or prosecution.
- Disclosure would endanger the health or safety of an individual, organization, or community.
- The information is in a criminal intelligence information system subject to 28 CFR Part 23 [see 28 CFR § 23.20(e)].
- The information relates to **[title, regulation, code, etc.]**.
- The information source does not reside with the center.
- The center did not originate and does not have a right to disclose the information.
- Other **authorized** basis for denial.

If the information does not originate with the center, the requestor will be referred to the originating agency, if appropriate or required, or the center will notify the source agency of the request and its determination that disclosure **by the center** or referral **of the requestor** to the source agency was neither required nor appropriate under applicable law.

K.2 Corrections

1. What is the center's procedure for handling individuals' requests for correction involving *information the center has disclosed and can change because it originated the information*? Is a record kept of requests for corrections?

If an individual requests correction of information **originating with the [name of center]** that has been disclosed, the center's Privacy Officer or designee will inform the individual of the procedure for requesting and considering requested corrections, including appeal rights if requests are denied in whole or in part. A record will be kept of all requests for corrections and the resulting action, if any.

K.3 Appeals

1. If requests for disclosure or corrections are denied, what is the center's procedure for appeal?

The individual who has requested disclosure or to whom information has been disclosed will be given reasons if disclosure or requests for corrections are denied by the **[name of center]** or the originating agency. The individual will also be informed of the procedure for appeal when the center or originating agency has cited an exemption for the type of information

requested or has declined to correct challenged information to the satisfaction of the individual to whom the information relates.

K.4 Complaints

1. **For terrorism-related protected information that may be accessed or shared through the ISE, what is the center's process for handling individuals' complaints and objections with regard to information received, maintained, disclosed, or disseminated by the center? Is the center's ISE Privacy Officer or designee or other individual responsible for handling complaints? Is a record kept of complaints and requests for corrections?**

Best Practice: Centers are encouraged to make the complaint procedure applicable to all requests for information and intelligence held by the center. If an individual has a complaint with regard to the accuracy or completeness of terrorism-related protected information that:

- (a) Is exempt from disclosure.
- (b) Has been or may be shared through the ISE.

(1) Is held by the [name of center] and

(2) Allegedly has resulted in demonstrable harm to the complainant,

The center will inform the individual of the procedure for submitting (if needed) and resolving such complaints. Complaints will be received by the center's Privacy Officer **or [insert title of designee or other individual]** at the following address: **[insert mailing address, e-mail address, and/or link to page if complaints can be submitted electronically]**. The Privacy Officer **[or insert title of designee or other individual]** will acknowledge the complaint and state that it will be reviewed but will not confirm the existence or nonexistence of the information to the complainant unless otherwise required by law. If the information did not originate with the center, the Privacy Officer or **[insert title of designee or other individual]** will notify the originating agency in writing or electronically within 10 days and, upon request, assist such agency to correct any identified data/record deficiencies, purge the information, or verify that the record is accurate. All information held by the center that is the subject of a complaint will be reviewed within 30 days and confirmed or corrected/purged if determined to be inaccurate or incomplete, to include incorrectly merged information, or to be out of date. If there is no resolution within 30 days, the center will not share the information until such time as the complaint has been resolved. A record will be kept by the center of all complaints and the resulting action taken in response to the complaint.

2. **How does the center determine which complaints involve information that is specifically protected information shared through the ISE?**

Note: This question needs to be addressed when a center does not have a procedure applicable to all protected information under Section K.4, 1.

To delineate protected information shared through the ISE from other data, the **[name of center]** maintains records of agencies sharing terrorism-related information and employs system mechanisms to identify the originating agency when the information is shared.

L. Security Safeguards

1. Does your center have a designated security officer? Is training provided for the security officer?

If the role is a component of another position, identify the title of the position upholding security officer responsibilities.

2. What are your center's physical, procedural, and technical safeguards for ensuring the security of center data?

Describe how the center will protect the information from unauthorized access, modification, theft, or sabotage (whether internal or external) resulting from natural or human-caused disasters or intrusions with, for example, procedures, practices, system protocols, use of software, information technology tools, and physical security measures.

Best Practice: Reference generally accepted industry or other applicable standard(s) for security with which the center complies.

The center will comply with generally accepted industry or other applicable standards for security, in accordance with [insert the name of the center security policy or reference applicable standard(s)]. Security safeguards will cover any type of medium (printed and electronic) or technology (e.g., physical servers, virtual machines, and mobile devices) used in a work-related [name of center] activity.

The [name of center] will operate in a secure facility protected from external intrusion. The center will utilize secure internal and external safeguards against network intrusions. Access to the center's databases from outside the facility will be allowed only over secure networks.

3. Does your center utilize a separate repository system for tips, leads, and SAR information?

The [name of center] will secure tips, leads, and SAR information in a separate repository system using security procedures and policies that are the same as or similar to those used for a system that secures data rising to the level of reasonable suspicion under 28 CFR Part 23.

4. What requirements exist to ensure that the information will be stored in a secure format and a secure environment?

The [name of center] will store information in a manner that ensures it cannot be added to, modified, accessed, destroyed, or purged except by personnel authorized to take such actions.

5. What are the required credentials of center personnel authorized to have access to center information?

Access to [name of center] information will be granted only to center personnel whose positions and job duties require such access; who have successfully completed a background check and possess an appropriate security clearance, if applicable; and who have been selected, approved, and trained accordingly.

6. Does electronic access to center data identify the user?

Queries made to the [name of center]'s data applications will be logged into the data system identifying the user initiating the query.

7. Is a log kept of accessed and disseminated center data, and is an audit trail maintained? Refer to N.2, Accountability, for more information on audit logs.

The [name of center] will utilize watch logs to maintain audit trails of requested and disseminated information.

8. Are risk and vulnerability assessments (if maintained) stored separately from publicly available data?

To prevent public records disclosure, risk and vulnerability assessments will not be stored with publicly available data.

9. What are the center's procedures for adhering to data breach notification laws or policies?

All individuals with access to [name of center]'s information or information systems will report a suspected or confirmed breach to the Privacy Officer as soon as possible and without unreasonable delay, consistent with applicable laws, regulations, policies, and procedures. This includes a breach in any medium or form, including paper, oral, and electronic.

Best Practice: Provide prompt notification to originating agencies when PII they provided to the center has been the subject of a suspected or confirmed data breach.

[To the extent allowed by existing data breach notification law] Following assessment of the suspected or confirmed breach and as soon as practicable, the [name of center] will notify the originating agency from which the center received PII of the nature and scope of a suspected or confirmed breach of such information.

[In addition to the above, the center should identify any existing law or policy governing its breach response procedures and, in accordance with these laws and policies, provide specific guidance on breach response procedures, including notification to individuals affected by the breach. [Where no applicable state, local, tribal, or territorial law exists, or where centers choose to supplement existing law or policy, M-17-12 may be used as a guide. Centers do not need to adopt OMB M-17-12 in full. Rather, a center should review OMB M-17-12 to determine which provisions are applicable and may adapt those provisions to the specific needs of the center.]

The [name of center] will adhere to breach procedures established by Office Management and Budget (OMB) Memorandum M-17-12 (January 13, 2017). The provisions adopted by the [name of center] are cited below. The Privacy Officer, in coordination with the breach response team, when applicable, will assess the risk of harm to individuals potentially affected by a breach (e.g., the nature and sensitivity of the PII potentially compromised by the breach, the likelihood of access and use of PII, and the type of breach involved), evaluate how the center may best mitigate the identified risks, and provide recommendations to the Director on suggested countermeasures, guidance, or other actions.

The Director will determine whether a data breach requires notification to an affected individual, in accordance with applicable laws, regulations, policies, and procedures. If required, the **[name of center]** will notify an individual about whom PII was or is reasonably believed to have been breached and access to which threatens physical, reputational, or financial harm to the person. If notice to the individual is required, it will be made promptly and without unreasonable delay following discovery of the breach. Notice will be provided consistent with the legitimate needs of law enforcement to investigate the breach or any measures necessary to determine the scope of the breach and, if necessary, to reasonably restore the integrity of any information system affected by the breach.

The Privacy Officer is responsible for developing and updating the center's data breach response plan on an annual basis and in accordance with any changes in law, guidance, standards, agency policy, procedures, staffing, and/or technology, for maintaining documentation about each data breach reported to the center and the center's response, and for keeping the center's administrators informed of the status of an ongoing response. The Director will determine when the response to a breach is concluded, based on input from the Privacy Officer.

M. Information Retention and Destruction

- 1. What is your center's review schedule for validating or purging information? Specify periodic basis and/or reference the applicable law.**

Note: Retention and destruction policy should be provided for all information and intelligence databases/records held by the center.

All criminal intelligence information, as that term is defined in 28 CFR § 23.3,¹⁰ will be reviewed for record retention (validation or purge) by [name of center] at least every five (5) years, in accordance with 28 CFR Part 23. For other information or intelligence, the record retention will be established by state law or local ordinance, or in accordance with a retention schedule established by the **[name of center]**. **[Identify each data set and its retention schedule or cite to a publicly available retention schedule covering the data sets.]**

Only those criminal intelligence records that meet the reasonable suspicion criteria and the other 28 CFR Part 23 operating principles and are shared between agencies by an intelligence project are subject to the regulation. Fact-based or uncorroborated information (case investigative files, case management systems, incident/offense reports, field interview cards or contact files, criminal history records, arrest blotters, records management system [RMS] data, tips and leads, suspicious activity reports [SARs], etc.) and other types of information or intelligence gathered/collected and shared by state, local, tribal, or territorial law enforcement and intelligence agencies are not subject to 28 CFR Part 23.

2. **Does your center have a retention and destruction policy? Reference laws, if applicable.**

When information has no further value or meets the criteria for removal according to the **[name of center]**'s retention and destruction policy or according to applicable law, it will be purged, destroyed, and deleted or returned to the submitting (originating) agency.

3. **What methods are employed by the center to remove or destroy information?**

The **[name of center]** will delete information or return it to the originating agency once its retention period has expired as provided by this policy or as otherwise agreed upon with the originating agency in a participation or membership agreement.

4. **Is approval needed prior to removal or destruction of information? Specify the law, statute, regulation, or policy, if applicable, requiring that permission must be obtained before destroying information or specify that no approval will be required.**

Option 1:

The procedure contained in **[cite law, statute, regulation, or policy]** will be followed by **[name of center]** for notification of appropriate parties, including the originating agency, before information is deleted or returned in accordance with this policy or as otherwise agreed upon with the originating agency in a participation or membership agreement.

5. **Is the source of the information notified prior to removal or destruction?**

6. **Is a record kept of dates when information is to be removed (purged) if not validated prior to the end of its period? Is notification given prior to removal (for example, an auto-generated system prompt to center personnel that a record is due for review and validation or purge)?**

A record of information to be reviewed for retention will be maintained by the **[name of center]** and, for an appropriate system(s), notice will be given to the submitter at least 30 days prior to the required review and validation/purge date.

7. **Is a confirmation of the deletion required?**

A printed or electronic confirmation of the deletion will be provided to the originating agency when required under law or if pursuant to the terms of a preestablished agreement with the agency.

N. Accountability and Enforcement

N.1 Information System Transparency

Best Practice: Most fusion centers post their P/CRCL policies on the Internet. Posting the P/CRCL policy is an effective means of informing the public about the privacy practices of the center and helps establish trust between the center and the community.

1. Is your center's P/CRCL policy available to the public?

The [name of center] will be open with the public in regard to information and intelligence collection practices. The center's P/CRCL policy will be provided to the public for review, made available upon request, and posted on the center's website [or web page] at [insert web address].

2. Does your center have a point of contact for handling inquiries or complaints?

N.2 Accountability

1. Does electronic access (portal) to the center's data identify the user? Is the identity of the user retained in the audit log?

The audit log of queries made to the [name of center] will identify the user initiating the query.

2. Is a log kept of accessed and disseminated center-held data, and is an audit trail maintained?

The [name of center] will maintain an audit trail of accessed, requested, or disseminated information. An audit trail will be kept for a minimum of [specify the retention period for your jurisdiction/center for this type of request] of requests for access to information for specific purposes and of what information is disseminated to each person in response to the request.

3. What procedures and practices does your center follow to enable evaluation of user compliance with system requirements, the center's P/CRCL policy, and applicable law?

The [name of center] will adopt and follow procedures and practices by which it can ensure and evaluate the compliance of users with system requirements and with the provisions of this policy and applicable law. This will include logging access to these systems and periodic auditing of these systems, so as to not establish a pattern of the audits. These audits will be mandated at least [quarterly, semiannually, annually, or some other time period], and a record of the audits will be maintained by the [Privacy Officer or title of designee] of the center. Audits may be completed by an independent third party or a designated representative of the [name of entity].

Appropriate elements of this audit process and key audit outcomes will be compiled into a report and may be provided to command staff and oversight entities or governance boards.

The **[name of center]** will annually conduct an audit and inspection of the information and intelligence contained in its information system(s) and may include any type of medium (printed and electronic) or technology (e.g., physical servers, virtual machines, and mobile devices) used in a work-related **[name of center]** activity.

The audit will be conducted by the center's **[designate audit committee, office, or position]** (or) **[a designated independent panel]**. This **[committee/office/position]** (or) **[independent panel]** has the option of conducting a random audit, without announcement, at any time and without prior notice to staff of the center. The audit will be conducted in such a manner as to protect the confidentiality, sensitivity, and privacy of the center's information and intelligence system(s).

6. **How often do you review and update the provisions contained within this P/CRCL policy (for example, annually)?**

The **[name of center]**'s privacy committee, guided by the appointed and trained Privacy Officer, will review and update the provisions protecting privacy, civil rights, and civil liberties contained in this policy **annually** and will make appropriate changes in response to changes in applicable law, technology, the purpose and use of the information systems, and public expectations.

N.3 Enforcement

1. **What are your procedures for enforcement if center personnel, a participating agency, or an authorized user is suspected of being or has been found to be in noncompliance with the provisions of this policy?**

If center personnel, a participating agency, or an authorized user is found to be in noncompliance with the provisions of this policy regarding the gathering, collection, use, retention, destruction, sharing, classification, or disclosure of information, the **[title of the Director]** of the **[name of center]** will:

- Suspend or discontinue access to information by the center personnel, the participating agency, or the authorized user.
- Suspend, demote, transfer, or terminate center personnel, as permitted by applicable personnel policies.
- Apply administrative actions or sanctions as provided by **[state agency or center]** rules and regulations or as provided in agency/center personnel policies.
- If the authorized user is from an agency external to the agency/center, request that the user's employer enforce the policy's provisions.
- Refer the matter to appropriate authorities for criminal prosecution, as necessary, to effectuate the purposes of the policy.

2. What is the center's policy with regard to the qualifications and number of participating agency personnel authorized to access center information and intelligence, and what additional sanctions are available for violations of the center's P/CRCL policy?

The **[name of center]** reserves the right to restrict the qualifications and number of personnel having access to center information and to suspend or withhold service and deny access to any participating agency or participating agency personnel violating the center's P/CRCL policy.

O. Training

1. What personnel does your center require to participate in training programs regarding implementation of and adherence to this P/CRCL policy?

The **[name of center]** will require the following individuals to participate in training programs regarding implementation of and adherence to the privacy, civil rights, and civil liberties policy:

- All center personnel.
- Participating agency personnel.
- Personnel providing information technology services to the center.
- Staff members in other public agencies or private contractors providing services to the center.
- Authorized users who are not employed by the center or a contractor.

2. Do you provide training to personnel authorized to share protected information through the ISE?

The **[name of center]** will provide special training regarding the center's requirements and policies for collection, use, and disclosure of protected information to personnel authorized to share protected information through the Information Sharing Environment.

3. What is covered by your training program (for example, purpose of the policy, substance and intent of the provisions of the policy, impact of infractions, and possible penalties for violations)?

The **[name of center]**'s P/CRCL policy training program will cover:

- Purposes of the P/CRCL protection policy.
- Substance and intent of the provisions of the policy relating to collection, use, analysis, retention, destruction, sharing, and disclosure of information retained by the center.

- Originating and participating agency responsibilities and obligations under applicable law and policy.
- How to implement the policy in the day-to-day work of the user, whether a paper or systems user.
- The potential impact of violations of the agency's P/CRCL policy.
- Mechanisms for reporting violations of center P/CRCL protection policies and procedures
- How to identify, report, and respond to a suspected or confirmed breach of PII.
- The nature and possible penalties for policy violations, including possible transfer, dismissal, criminal liability, and immunity, if any.
- Updates to the P/CRCL policy, if any, in response to changes in law and implementation experience. **[Refer to Section C addressing Governance and Oversight.]**
- ISE Core Awareness Training, available at ise.gov.

Appendix A

Terms and Definitions

The following is a list of primary terms and definitions used throughout this template. These terms may also be useful in drafting the definitions section of the center's privacy, civil rights, and civil liberties (P/CRCL) policy.

Access—Information access is being able to get to (usually having permission to use) particular information on a computer. Web access means having a connection to the Internet through an access provider or an online service provider.

With regard to the Information Sharing Environment (ISE), access refers to the business rules, means, and processes by and through which ISE participants obtain terrorism-related information, to include homeland security information, terrorism information, and law enforcement information acquired in the first instance by another ISE participant.

Access Control—The mechanisms for limiting access to certain information based on a user's identity and membership in various predefined groups. Access control can be mandatory, discretionary, or role-based.

Acquisition—The means by which an ISE participant obtains information through the exercise of its authorities; for example, through human intelligence collection or from a foreign partner. For the purposes of this definition, acquisition does not refer to the obtaining of information widely available to other ISE participants through, for example, news reports or to the obtaining of information shared with them by another ISE participant who originally acquired the information.

Agency—See Originating Agency, Owning Agency, Participating Agency, Source Agency, Submitting Agency.

Analysis (law enforcement)—The review of information and its comparison to other information to determine the meaning of the data in reference to a criminal investigation or assessment.

Audit Trail—A generic term for recording (logging) a sequence of activities. In computer and network contexts, an audit trail tracks the sequence of activities on a system, such as user log-ins and log-outs. More expansive audit trail mechanisms would record each user's activity in detail—what commands were issued to the system, what records and files were accessed or modified, etc.

Audit trails are a fundamental part of computer security used to trace (albeit usually retrospectively) unauthorized users and uses. They can also be used to assist with information recovery in the event of a system failure.

Authentication—The process of validating the credentials of a person, computer process, or device. Authentication requires that the person, process, or device making the request provide a credential that proves it is what or who it says it is. Common forms of credentials are digital certificates, digital signatures, smart cards, biometrics data, and a combination of usernames and passwords. See Biometrics.

Authorization—The process of granting a person, a computer process, or a device access to certain information, services, or functionality. Authorization is derived from the identity of the person, the computer process, or the device requesting access, which is verified through authentication. See Authentication.

Biometrics—A general term used alternatively to describe a characteristic or a process. (1) As a characteristic: a measureable biological (anatomical and physiological) and behavioral characteristic that can be used for automated recognition. (2) As a process: automated methods of recognizing an individual based on measureable biological (anatomical and physiological) and behavioral characteristics. See

Glossary, Facial Identification Scientific Working Group (FISWG), Version 1.1, February 2, 2012, https://www.fiswg.org/FISWG_Glossary_v1.1_2012_02_02.pdf.

Center—Refers to the [name of fusion center] and all participating state agencies of the [name of fusion center].

Civil Liberties—According to the U.S. Department of Justice's Global Justice Information Sharing Initiative, the term "civil liberties" refers to fundamental individual rights, such as freedom of speech, press, or religion; due process of law; and other limitations on the power of the government to restrain or dictate the actions of individuals.¹¹ They are the freedoms that are guaranteed by the Bill of Rights—the first ten amendments to the Constitution of the United States. Civil liberties offer protection to individuals from improper government action and arbitrary governmental interference.

Civil Rights—The term "civil rights" refers to those rights and privileges of equal protection that government entities must afford to all individuals in the United States regardless of race, ethnicity, gender, national origin, religion, sexual orientation, gender identity, or other characteristics unrelated to the worth of the individual. Protection of civil rights means that government entities will take action to ensure that individuals are not discriminated against on the basis of any federally or state protected characteristic. For example, a state may have constitutional or statutory language regarding parental status. Generally, the term "civil rights" involves positive (or affirmative) government action to protect against infringement, while the term "civil liberties" involves restrictions on government.¹²

Collect—For purposes of this document, "gather" and "collect" mean the same thing.

Computer Security—The protection of information technology assets through the use of technology, processes, and training.

Confidentiality—Refers to the obligations of individuals and institutions to appropriately use information and data under their control once they have been disclosed to them and in accordance with applicable data security laws and policies.

Credentials—Information that includes identification and proof of identification that is used to gain access to local and network resources. Examples of credentials are usernames, passwords, smart cards, and certificates.

Criminal Activity—A behavior, an action, or an omission that is punishable by criminal law.

Criminal Intelligence Information—Information deemed relevant to the identification of and the criminal activity engaged in by an individual who or organization that is reasonably suspected of involvement in criminal activity. Criminal intelligence records are maintained in a criminal intelligence system per 28 CFR Part 23.

Data—Inert symbols, signs, descriptions, or measures; elements of information.

Data Breach—The loss of control, compromise, unauthorized disclosure, unauthorized acquisition, or any similar occurrence where (1) a person other than an authorized user accesses or potentially accesses PII

or (2) an authorized user accesses or potentially accesses PII for a purpose other than the authorized purpose.

The center's response to a data breach may be addressed in state law or agency policy. This may include incidents such as:

- Theft or loss of digital media—including computer tapes, hard drives, or laptop computers containing such media—upon which such information is stored unencrypted; posting such information on the Internet.
- Unauthorized employee access to certain information.
- Moving such information to computer otherwise accessible from the Internet without proper information security precautions.
- Intentional or unintentional transfer of such information to a system that is not completely open but is not appropriately or formally accredited for security at the approved level, such as unencrypted e-mail.
- Transfer of such information to the information systems of a possibly hostile agency or an environment where it may be exposed to more intensive decryption techniques.

Data Protection—Encompasses the range of legal, regulatory, and institutional mechanisms that guide the collection, receipt, use, dissemination, retention, purging, and protection of information.

Data Quality—Refers to various aspects of the information: the accuracy and validity of the actual values of the data, information structure, and database/information repository design. Traditionally, the basic elements of data quality have been identified as accuracy, completeness, currency, reliability, and context/meaning. Today, data quality is being more fully described in multidimensional models, expanding conventional views of the topic to include considerations of accessibility, security, and privacy. This concept is also addressed as one of the Fair Information Practice Principles (FIPPs), Data Quality/Integrity. See Appendix C for further background on the FIPPs.

Disclosure—The release, transfer, provision of access to, sharing, publication, or divulging of PII in any manner—electronic, verbal, or in writing—to an individual, agency, or an organization outside the agency that collected it. Disclosure is an aspect of privacy, focusing on information which may be available only to certain people for certain purposes but which is not available to everyone.

Electronically Maintained—Information stored by a computer or on any electronic medium from which the information may be retrieved by a computer, such as electronic memory chips, magnetic tape, magnetic disk, compact disc optical media, or cloud technologies.

Electronically Transmitted—Information exchanged with a computer using electronic media, such as the movement of information from one location to another by magnetic or optical media, or transmission over the Internet, intranet, extranet, leased lines, dial-up lines, private networks, telephone voice response, or faxback systems. It does not include faxes, telephone calls, video teleconferencing, or messages left on voice mail.

Evaluation—An assessment of the reliability of the source and accuracy of the raw data.

Fair Information Practice Principles (FIPPs)—FIPPs are a set of internationally recognized principles that inform information privacy policies both within government and the private sector. Although specific articulations of the FIPPs vary and have evolved since their genesis in the 1970s, core elements are consistent among nations, states, and economic sectors. These core elements are incorporated into information privacy laws, policies, and governance documents around the world. They provide a straightforward description of underlying privacy and information exchange principles and a simple framework for the legal use that needs to be done with regard to privacy in integrated justice systems. Because of operational necessity, it may not always be possible to apply all of the principles equally. For example, the Individual Participation Principle (#8) may be of limited applicability in intelligence operations,

as fusion centers do not generally engage with individuals. That said, fusion centers and all other integrated justice systems should endeavor to apply the FIPPs where practicable.

The eight principles are:

1. Purpose Specification
2. Data Quality/Integrity (see definition)
3. Collection Limitation/Data Minimization
4. Use Limitation
5. Security Safeguards (see definition)
6. Accountability/Audit
7. Openness/Transparency
8. Individual Participation

See Appendix C for further background on the FIPPs.

Firewall—A security solution that segregates one portion of a network from another portion, allowing only authorized network traffic to pass through according to traffic-filtering rules.

Fusion Center—Defined in the ISE-SAR Functional Standard, Version 1.5.5 as “[a] collaborative effort of two or more Federal, State, local, tribal, or territorial (SLTT) government agencies that combines resources, expertise, or information with the goal of maximizing the ability of such agencies to detect, prevent, investigate, apprehend, and respond to criminal or terrorist activity.” (Source: Section 511 of the 9/11 Commission Act). State and major urban area fusion centers serve as focal points within the State and local environment for the receipt, analysis, gathering, and sharing of threat-related information between the federal government and SLTT and private sector partners.

General Information or Data—Information that may include records, documents, or files pertaining to law enforcement operations, such as computer-aided dispatch (CAD) data, incident data, and management information. Information that is maintained in a records management system, CAD system, etc., for statistical/retrieval purposes. Information may be either resolved or unresolved. The record is maintained per statute, rule, or policy.

Homeland Security Information—As defined in Section 892(f)(1) of the Homeland Security Act of 2002 and codified at 6 U.S.C. § 482(f)(1), homeland security information means any information possessed by a federal, state, or local agency that (a) relates to a threat of terrorist activity; (b) relates to the ability to prevent, interdict, or disrupt terrorist activity; (c) would improve the identification or investigation of a suspected terrorist or terrorist organization; or (d) would improve the response to a terrorist act.

Identification—A process whereby a real-world entity is recognized and its identity established. Identity is operationalized in the abstract world of information systems as a set of information about an entity that uniquely differentiates it from other similar entities. The set of information may be as small as a single code, specifically designed as an identifier, or a collection of data, such as a given and family name, date of birth, and address. An organization’s identification process consists of the acquisition of the relevant identifying information.

Individual Responsibility—Because a privacy notice is not self-implementing, an individual within an organization’s structure must also be assigned responsibility for enacting and implementing the notice.

Information—Includes any data about people, organizations, events, incidents, or objects, regardless of the medium in which it exists. Information received by law enforcement agencies can be categorized into three general areas: general data, including investigative information; tips and leads data (including suspicious activity reports); and criminal intelligence information.

Information Sharing Environment (ISE)—In accordance with Section 1016 of the Intelligence Reform and Terrorism Prevention Act of 2004 (IRTPA), as amended, the ISE is a conceptual framework composed of the policies, procedures, and technologies linking the resources (people, systems, databases, and information) of SLTT agencies; federal agencies; and the private sector to facilitate terrorism-related information sharing, access, and collaboration.

Information Sharing Environment (ISE) Suspicious Activity Report (SAR) (ISE-SAR)—An ISE-SAR is a SAR that has been determined, pursuant to a two-step process established in the ISE-SAR Functional Standard, to have a potential terrorism nexus (i.e., to be reasonably indicative of criminal activity associated with terrorism).

Intelligence-Led Policing (ILP)—A process for enhancing law enforcement agency effectiveness toward reducing crimes, protecting community assets, and preparing for responses. ILP provides law enforcement agencies with an organizational framework to gather and use multisource information and intelligence to make timely and targeted strategic, operational, and tactical decisions.

Invasion of Privacy—Intrusion on one's solitude or into one's private affairs, public disclosure of embarrassing private information, publicity that puts one in a false light to the public, or appropriation of one's name or picture for personal or commercial advantage. See also Right to Privacy.

Joint Terrorism Task Forces (JTTFs)—The Federal Bureau of Investigation's (FBI) JTTFs are interagency task forces designed to enhance communication, coordination, and cooperation in countering terrorist threats. They combine the resources, talents, skills, and knowledge of federal, state, territorial, tribal, and local law enforcement and homeland security agencies, as well as the Intelligence Community, into a single team that investigates and/or responds to terrorist threats. The JTTFs execute the FBI's lead federal agency responsibility for investigating terrorist acts or terrorist threats against the United States.

Law—As used by this policy, law includes any local, state, or federal constitution, statute, ordinance, regulation, Executive Order, policy, or court rule, decision, or order as construed by appropriate local, state, or federal officials or agencies.

Law Enforcement Information—For purposes of the ISE, law enforcement information means any information obtained by or of interest to a law enforcement agency or official that is both (a) related to terrorism or the security of our homeland and (b) relevant to a law enforcement mission, including but not limited to information pertaining to an actual or potential criminal, civil, or administrative investigation or a foreign intelligence, counterintelligence, or counterterrorism investigation; assessment of or response to criminal threats and vulnerabilities; the existence, organization, capabilities, plans, intentions, vulnerabilities, means, methods, or activities of individuals or groups involved or suspected of involvement in criminal or unlawful conduct or assisting or associated with criminal or unlawful conduct; the existence, identification, detection, prevention, interdiction, or disruption of or response to criminal acts and violations of the law; identification, apprehension, prosecution, release, detention, adjudication, supervision, or rehabilitation of accused persons or criminal offenders; and victim/witness assistance.

Lawful Permanent Resident—A foreign national who has been granted the privilege of permanently living and working in the United States.

Least Privilege Administration—A recommended security practice in which every user is provided with only the minimum privileges needed to accomplish the tasks he or she is authorized to perform.

Logs—A necessary part of an adequate security system because they are needed to ensure that data is properly tracked and that only authorized individuals are getting access to the data. See also Audit Trail.

Maintenance of Information—Applies to all forms of information storage. This includes electronic systems (for example, databases) and nonelectronic storage systems (for example, filing cabinets). To meet access

requirements, an organization is not required to create new systems to maintain information or to maintain information beyond a time when it no longer serves an organization's purpose.

Metadata—In its simplest form, metadata is information (data) about information, more specifically, information about a particular aspect of the collected information. An item of metadata may describe an individual content item or a collection of content items. Metadata is used to facilitate the understanding, use, and management of information. The metadata required for this will vary based on the type of information and the context of use.

Nationwide Suspicious Activity Reporting (SAR) Initiative (NSI)—The NSI establishes standardized processes and policies that provide the capability for federal, SLTT, campus, and railroad law enforcement and homeland security agencies to share timely, relevant ISE-SARs through a distributed information sharing system that protects privacy, civil rights, and civil liberties.

Nationwide SAR Initiative (NSI) SAR Data Repository (SDR)—The NSI SDR consists of a single data repository, built to respect and support originator control and local stewardship of data, which incorporates federal, state, and local retention policies. Within the SDR, hosted data enclaves extend this approach to information management and safeguarding practices by ensuring a separation of data across participating agencies.

Need to Know—As a result of jurisdictional, organizational, or operational necessities, access to sensitive information or intelligence is necessary for the conduct of an individual's official duties as part of an organization that has a right to know the information to perform or assist in a law enforcement, homeland security, or counterterrorism activity or other lawful and authorized government activity, such as to further an investigation or meet another law enforcement requirement.

Nonrepudiation—A technique used to ensure that someone performing an action on a computer cannot falsely deny that he or she performed that action. Nonrepudiation provides undeniable proof that a user took a specific action, such as transferring money, authorizing a purchase, or sending a message.

Nonvalidated Information—A tips or lead (including a SAR) received by the center that has been determined to be false or inaccurate or otherwise determined to not warrant additional action and/or maintenance.

Originating Agency—The agency or organizational entity that documents information or data, including source agencies that document SAR (and, when authorized, ISE-SAR) information that is collected by a fusion center.

Owning Agency/Organization—The organization that owns the target associated with the suspicious activity.

Participating Agency—An organizational entity that is authorized to access or receive and use center information and/or intelligence databases and resources for lawful purposes through its authorized individual users.

Permissions—Authorization to perform operations associated with a specific shared resource, such as a file, a directory, or a printer. Permissions must be granted by the system administrator to individual user accounts or administrative groups.

Personally Identifiable Information—Information that can be used to distinguish or trace an individual's identity, either alone or when combined with other information that is linked or linkable to a specific individual.”¹³

Preoperational Planning—As defined in ISE-SAR Functional Standard, Version 1.5.5, “preoperational planning describes activities associated with a known or particular planned criminal operation or with terrorist operations generally.”

Privacy—Refers to individuals' interests in preventing the inappropriate collection, use, and release of PII. Privacy interests include privacy of personal behavior, privacy of personal communications, and privacy of personal data. Other definitions of privacy include the capacity to be physically left alone (solitude); to be free from physical interference, threat, or unwanted touching (assault, battery); and to avoid being seen or overheard in particular contexts.

Privacy, Civil Rights, and Civil Liberties (P/CRCL) Policy—A printed, published statement that articulates the policy position of an organization on how it handles the PII that it maintains and uses in the normal course of business. The policy should include information relating to the processes of information collection, receipt, access, use, dissemination, retention, and purging. It is likely to be informed by the Fair Information Practice Principles (FIPPs). The purpose of the P/CRCL policy is to articulate that the center will adhere to those legal requirements and center policy determinations that enable collection, receipt, access, use, dissemination, retention, and purging of information to occur in a manner that protects personal privacy interests. A well-developed and implemented P/CRCL policy uses justice entity resources wisely and effectively; protects the center, the individual, and the public; and promotes public trust.

Privacy Protection—A process of maximizing the protection of privacy, civil rights, and civil liberties when collecting and sharing information in the process of protecting public safety and public health.

Protected Information—For the nonintelligence community, protected information is information about United States citizens and lawful permanent residents that is subject to information privacy or other legal protections under the Constitution and laws of the United States.

For the (federal) intelligence community, protected information includes information about “United States persons” as defined in Executive Order 12333. Protected information may also include other information that the U.S. government expressly determines by Executive Order, international agreement, policy, or other similar instrument should be covered.

For state, local, tribal, and territorial governments, protected information may include information about individuals and organizations that is subject to information privacy or other legal protections by law, including the U.S. Constitution; applicable federal statutes and regulations, such as civil rights laws and 28 CFR Part 23; applicable state and tribal constitutions; and applicable state, local, tribal, and territorial laws, ordinances, and codes. Protection may be extended to other individuals and organizations by fusion center or other state, local, tribal, or territorial agency policy or regulation.

Public—Public includes:

- Any individual and any for-profit or nonprofit entity, organization, or association.
- Any governmental entity for which there is no existing specific law authorizing access to the center's information.

- Media organizations.
- Entities that seek, receive, or disseminate information for whatever reason, regardless of whether it is done with the intent of making a profit, and without distinction as to the nature or intent of those requesting information from the center or participating agency.

Public does not include:

- Any employees of the center or participating entity.
- People or entities, private or governmental, who assist the center in the operation of the justice information system.
- Public agencies whose authority to access information gathered and retained by the center is specified in law.

Public Access—Relates to what information can be seen by the public; that is, information whose availability is not subject to privacy interests or rights.

Purge—A term that is commonly used to describe methods that render data unrecoverable in a storage space or to destroy data in a manner that it cannot be reconstituted. There are many different strategies and techniques for data purging, which is often contrasted with data deletion (e.g., made inaccessible except to system administrators or other privileged users.)

Reasonably Indicative—This operational concept for documenting and sharing suspicious activity takes into account the circumstances in which that observation is made which creates in the mind of the reasonable observer, including a law enforcement officer, an articulable concern that the behavior may indicate preoperational planning associated with terrorism or other criminal activity. It also takes into account the training and experience of a reasonable law enforcement officer, in cases in which an officer is the observer or documenter of the observed behavior reported to a law enforcement agency.

Record—Any item, collection, or grouping of information that includes PII and is collected, received, accessed, used, disseminated, retained, and purged by or for the collecting agency or organization.

Redress—Laws, policies, and procedures that address public agency responsibilities with regard to access/disclosure and correction of information and the handling of complaints from persons regarding *protected information* about them which is under the center's control and which is exempt from disclosure and not disclosed to the individual to whom the information pertains.

Repudiation—The ability of a user to deny having performed an action that other parties cannot prove otherwise. For example, a user who deleted a file can successfully deny doing so if no mechanism (such as audit files) can contradict that claim.

Retention—Refer to Storage.

Right to Information Privacy—The right to be left alone, in the absence of some reasonable public interest in collecting, accessing, retaining, and disseminating information about an individual's activities. Invasion of the right to privacy can be the basis for a lawsuit for damages against the individual or entity violating an individual's privacy.

Right to Know—A requirement for access to specific information to perform or assist in a lawful and authorized governmental function. Right to know is determined by the mission and functions of a law enforcement, homeland security, counterterrorism, or other lawful and authorized government activity or the roles and responsibilities of particular personnel in the course of their official duties.

Role-Based Access—A type of access authorization that uses roles to determine access rights and privileges. A role is a symbolic category of users that share the same security privilege.

Security—Refers to the range of administrative, technical, and physical business practices and mechanisms that aim to preserve privacy and confidentiality by restricting information access to authorized users for authorized purposes. Computer and communications security efforts also have the goal of ensuring the accuracy and timely availability of information for the legitimate user set, as well as promoting failure resistance in the electronic systems overall.

Source Agency/Organization—Defined in the ISE-SAR Functional Standard, Version 1.5.5, source agency refers to the agency or entity that originates the SAR (examples include a local police department, a private security firm handling security for a power plant, and a security force at a military installation). The source organization will not change throughout the life of the SAR.

Storage—In a computer, storage is the place where data is held in an electromagnetic or optical form for access by a computer processor. There are two general usages:

- Storage is frequently used to mean the devices and data connected to the computer through input/output operations—that is, hard disk and tape systems and other forms of storage that do not include computer memory and other in-computer storage. This is probably the most common meaning in the IT industry.
- In a more formal usage, storage has been divided into (1) primary storage, which holds data in memory (sometimes called random access memory, or RAM) and other “built-in” devices, such as the processor’s L1 cache, and (2) secondary storage, which holds data on hard disks, tapes, and other devices requiring input/output operations. Primary storage is much faster to access than secondary storage because of the proximity of the storage to the processor or because of the nature of the storage devices. On the other hand, secondary storage can hold much more data than primary storage.

With regard to the ISE, storage (or retention) refers to the storage and safeguarding of terrorism-related information—including homeland security information, terrorism information, and law enforcement information relating to terrorism or the security of our homeland—by both the originator of the information and any recipient of the information.

Submitting Agency/Organization—The organization that actuates the push of the ISE-SAR to the NSI community. The submitting organization and the source organization may be the same.

Suspicious Activity—Defined in the ISE-SAR Functional Standard, Version 1.5.5 as “[o]bserved behavior reasonably indicative of preoperational planning associated with terrorism or other criminal activity.” Examples of suspicious activity include surveillance, photography of sensitive infrastructure facilities, site breach or physical intrusion, cyberattacks, testing of security, etc.

Suspicious Activity Report (SAR)—Defined in the ISE-SAR Functional Standard, Version 1.5.5 as “[o]fficial documentation of observed behavior reasonably indicative of preoperational planning associated with terrorism or other criminal activity.” Suspicious activity report (SAR) information offers a standardized means for feeding information repositories or data analysis tools. Patterns identified during SAR information analysis may be investigated in coordination with the reporting agency and, if applicable, a state or regional fusion center. SAR information is not intended to be used to track or record ongoing enforcement, intelligence, or investigatory activities, nor is it designed to support interagency calls for service.

Terrorism Information—Consistent with Section 1016(a)(4) of the Intelligence Reform and Terrorism Prevention Act of 2004 (IRTPA), all information relating to (a) the existence, organization, capabilities, plans, intentions, vulnerabilities, means of finance or materials support, or activities of foreign or international terrorist groups or individuals or of domestic groups or individuals involved in transnational

terrorism; (b) threats posed by such groups or individuals to the United States, United States persons, or United States interests or to those interests of other nations; (c) communications of or by such groups or individuals; or (d) other groups or individuals reasonably believed to be assisting or associated with such groups or individuals.

Weapons of Mass Destruction (WMD) information was defined and included in the definition of “terrorism information” by P.L. 110-53.

Terrorism-Related Information—In accordance with the Intelligence Reform and Terrorism Prevention Act of 2004 (IRTPA), as amended by the 9/11 Commission Act (August 3, 2007, P.L. 110-53), the ISE facilitates the sharing of terrorism and homeland security information, as defined in IRTPA Section 1016(a)(5) and the Homeland Security Act 892(f)(1) (6 U.S.C. § 482(f)(1)). See also *Information Sharing Environment Implementation Plan* (November 2006) and Presidential Guidelines 2 and 3 (the ISE will facilitate the sharing of “terrorism information,” as defined in the IRTPA, as well as the following categories of information to the extent that they do not otherwise constitute “terrorism information”: (1) homeland security information as defined in Section 892(f)(1) of the Homeland Security Act of 2002 (6 U.S.C. § 482(f)(1)); and (2) law enforcement information relating to terrorism or the security of our homeland). Such additional information may include intelligence information.

Tips and Leads Information or Data—Generally uncorroborated reports or information generated from inside or outside a law enforcement agency that allege or indicate some form of possible criminal activity. Tips and leads are sometimes referred to as suspicious incident report (SIR), suspicious activity report (SAR), and/or field interview report (FIR) information. However, SAR information should be viewed, at most, as a subcategory of tip or lead data. Tips and leads information does not include incidents that do not have a criminal offense attached or indicated, criminal history records, or CAD data. Tips and leads information should be maintained in a secure system, similar to data that rises to the level of reasonable suspicion.

A tip or lead can come from a variety of sources, including, but not limited to, the public, field interview reports, and anonymous or confidential sources. This information may be based on mere suspicion or on a level of suspicion that is less than “reasonable suspicion” and, without further information or analysis, it is unknown whether the information is accurate or useful. Tips and leads information falls between being of little or no use to law enforcement and being extremely valuable depending on the availability of time and resources to determine its meaning.

Unvalidated information—A tip or lead (including a SAR) received by the center that has not yet been reviewed to determine further action or maintenance.

U.S. Person—Executive Order 12333 states that a “United States person” means a United States citizen, an alien known by the intelligence element concerned to be a permanent resident alien, an unincorporated association substantially composed of United States citizens or permanent resident aliens, or a corporation incorporated in the United States, except for a corporation directed and controlled by a foreign government or governments.

User—An individual representing a participating agency who is authorized to access or receive and use a center’s information and intelligence databases and resources for lawful purposes.

Validated Information—A tip or lead (including a SAR) that has been reviewed and, when appropriate, combined with other information or further vetted and is determined to warrant additional action, such as investigation or dissemination, and/or maintenance as per the applicable record retention policy.

Appendix B

Federal and SLTT Laws, Regulations, and Guidance Relevant to Seeking, Retaining, and Disseminating Justice Information

The U.S. Constitution is the primary authority that applies to federal as well as state, local, tribal, and territorial (SLTT) agencies. State constitutions cannot provide fewer privacy and other civil liberties protections than the U.S. Constitution, but states can broaden constitutional rights guaranteed by their own constitutions.

Civil liberties protections are primarily founded in the Bill of Rights. They include the basic freedoms, such as free speech, assembly, and religion; freedom from unreasonable search and seizure; due process; etc.¹⁴

In addition, statutory civil rights protections in the U.S. Constitution may directly govern state action. These include the Civil Rights Act of 1964, as amended; the Rehabilitation Act of 1973; the Equal Educational Opportunities Act of 1974; the Americans with Disabilities Act; the Fair Housing Act; the Voting Rights Act of 1965; and the Civil Rights of Institutionalized Persons Act.

Federal laws, Executive Orders, regulations, and policies directly affect agencies'/centers' P/CRCL policies. While SLTT agencies may not be generally bound directly by most statutory federal privacy and other civil liberties protection laws in the information collection and sharing context, compliance may be required **indirectly** by funding conditions (e.g., Title VI of the Civil Rights Act of 1964; 28 CFR Parts 20, 22, and 23); operation of the Commerce Clause of the U.S. Constitution (e.g., Electronic Communications Privacy Act of 1986); or a binding agreement between a federal agency and an SLTT agency (e.g., a memorandum of agreement or memorandum of understanding). When relevant or possibly relevant, agencies/centers are advised to list these laws, regulations, and policies within their privacy, civil rights, and civil liberties (P/CRCL) policies, noting those that may potentially affect the sharing of information, including sharing terrorism-related information in the Information Sharing Environment (ISE).

The development of a privacy, civil rights, and civil liberties policy is primarily designed for center personnel and authorized users to ensure that they are aware of the legal and privacy framework within which they and the center must operate. If the applicability and requirements of various laws, regulations, or sharing agreements are not spelled out or referenced in a center P/CRCL policy, staff and user accountability is greatly diminished; mistakes are made; privacy, civil rights, and civil liberties violations occur; and the public's (and other agencies') confidence in the ability of the center to protect information and intelligence is compromised. When staff members know the rules through sound policy and procedure communicated through ongoing training activity, information sharing is enhanced.

It is important to note that federal laws may use different terminology to describe information that identifies an individual (e.g., personal data, personal information, information in identifiable form). Different laws may have different statutory definitions for the terminology used. Personnel who are charged with developing or updating their center's P/CRCL policy should refer to the applicable statutory definition, in order to ensure that the scope of the terminology used is properly understood and implemented.

A. Federal Laws, Regulations, and Guidance

Following are synopses of federal laws, regulations, and guidance that a center should review and, when appropriate, cite within the policy when developing a P/CRCL policy for a justice information system. The list is arranged in alphabetical order by popular name.

1. **Brady Handgun Violence Prevention Act, 18 U.S.C. §§ 921, 922, 924, and 925A, United States Code, Title 18, Part I, Chapter 44, §§ 921, 922, 924, and 925A**—The Brady Act, passed in 1993, requires background checks for purchases of firearms from federally licensed sellers. Because the act prohibits transfer of a firearm to a person who is prohibited by law from possessing a firearm, the transmission of personal data is an integral part of the regulation.
2. **Computer Matching and Privacy Act of 1988, 5 U.S.C. § 552a(a), United States Code, Title 5, Part I, Chapter 5, Subchapter II, § 552a(a); see also Office of Management and Budget (OMB), Memorandum M-01-05, “Guidance on Interagency Sharing of Personal Data—Protecting Personal Privacy,” December 20, 2000**—The Computer Matching and Privacy Act of 1988 (Matching Act) amended the Privacy Act of 1974 to require that data-matching activities or programs of federal agencies that are designed to establish or verify eligibility for federal benefit programs or for recouping payments for debts under covered programs protect personal information. This is accomplished through a computer matching agreement and publication of a notice in the *Federal Register*. The OMB guidance requires that interagency data sharing provide protection, including provisions for notice, consent (as appropriate), redisclosure limitations, accuracy, security controls, minimization, accountability, and use of Privacy Impact Assessments. Although not directly a requirement of state, local, tribal, and territorial (SLTT) agencies, the guidance is a useful source of information on the types of protections that should be considered for all interagency data sharing programs.
3. **Confidentiality of Alcohol and Drug Abuse Patient Records, 42 CFR Part 2, Code of Federal Regulations, Title 42: Public Health, Part 2**—42 CFR Part 2 establishes minimum standards to govern the sharing of substance abuse treatment records (patient history information) in programs that are federally assisted. Generally, the sharing of such information is limited to the minimum necessary for the allowed purpose and requires consent of the patient except in specific emergency situations, pursuant to a court order or as otherwise specified. State law should also be consulted to determine whether there are additional limitations or sharing requirements.
4. **Confidentiality of Identifiable Research and Statistical Information, 28 CFR Part 22, Code of Federal Regulations, Title 28, Chapter I, Part 22**—28 CFR Part 22 is designed to protect the privacy of individuals whose personal information is made available for use in a research or statistical program funded under the Omnibus Crime Control and Safe Streets Act of 1968, the Juvenile Justice and Delinquency Prevention Act of 1974, or the Victim of Crimes Act. The regulation, which may apply to SLTT agencies that conduct research or statistical programs, limits the use of such information to research or statistical purposes; limits its revelation to a need-to-know basis; provides for final disposition, transfer, and notice to/consent of data subjects; and identifies sanctions for violations. It provides useful guidance for SLTT agencies that wish to make data containing personal information available for research or statistical purposes.
5. **Crime Identification Technology, 42 U.S.C. § 14601, United States Code, Title 42, Chapter 140, Subchapter I, § 14601**—This statute authorizes the Office of Justice Programs (OJP), U.S. Department of Justice (DOJ), to support technological advances by states directed at a variety of criminal justice purposes, such as identification of certain categories of offenders, conducting background checks, and determining eligibility for firearms possession. The act defines broad categories of purposes for which funds may be used by OJP and sets forth certain eligibility criteria and assurances and other protocols that must be followed.
6. **Criminal History Records Exchanged for Noncriminal Justice Purposes, 42 U.S.C. § 14611, United States Code, Title 42, Chapter 140, Subchapter II, § 14611**—This statute provides a

general overview of the Interstate Identification Index System (IIIS), an information sharing system that contains state and federal criminal history records that are also used for non-criminal justice purposes, such as governmental licensing and employment background checks. Congress recommends the creation of interstate and federal-state agreements to ensure that uniform policies are in place for records exchanges for non-criminal justice purposes and to prevent unauthorized use and disclosure of personal information due to variances in authorized users' policies. This statute is applicable to multijurisdictional information sharing systems that allow non-criminal justice-related exchanges.

7. **Criminal Intelligence Systems Operating Policies, 28 CFR Part 23, Code of Federal Regulations, Title 28, Chapter 1, Part 23**—This is a guideline for law enforcement agencies that operate federally funded multijurisdictional criminal intelligence systems. The operating principles of 28 CFR Part 23 provide guidance to law enforcement regarding how to operate criminal intelligence information systems effectively while safeguarding privacy, civil rights, and civil liberties during the collection, storage, and dissemination of criminal intelligence information. The regulation governs the intelligence information systems' process, which includes information submission or collection, secure storage, inquiry and search capability, controlled dissemination, and review and purge processes.
8. **Criminal Justice Information Systems, 28 CFR Part 20, Code of Federal Regulations, Title 28, Chapter 1, Part 20**—This applies to all state and local agencies and individuals collecting, storing, or disseminating criminal history record information processed by manual or automated operations and funded by the Omnibus Crime Control and Safe Streets Act of 1968, codified at 42 U.S.C. § 3789D. The regulation requires those criminal justice information systems to submit a criminal history information plan and provides guidance on specific areas that should have a set of operational procedures. These areas include completeness and accuracy of criminal history records and limitations on dissemination, including general policies on use and dissemination, juvenile records, audits, security, and access and review.
9. **Disposal of Consumer Report Information and Records, 16 CFR Part 682, Code of Federal Regulations, Title 16, Chapter I, Part 682**—16 CFR Part 682 applies to information systems that maintain or possess consumer information for business purposes. The regulation provides guidance on proper disposal procedures for consumer information records to help protect against unauthorized use or access.
10. **Driver's Privacy Protection Act of 1994, 18 U.S.C. § 2721**—Prohibition on Release and Use of Certain Personal Information from State Motor Vehicle Records—Collected License Plate Reader (LPR) information contains no PII that may be used to connect a license plate detection to an individual. It is only with permissible purpose that law enforcement may make this connect (using other systems), and this access is governed by the Driver's Privacy Protection Act of 1994. www.gpo.gov/fdsys/granule/USCODE-2011-title18/USCODE-2011-title18-partI-chap123-sec2721/content-detail.html
11. **E-Government Act of 2002, Pub. L. No. 107-347, 208, 116 Stat. 2899 (2002); OMB (03-22, OMB Memorandum, M-03-22, OMB Guidance for Implementing the Privacy Provisions of the E-Government Act of 2002)**—OMB implementing guidance for this act requires federal agencies to perform Privacy Impact Assessments (PIA) for new information technologies that develop or procure new information technology involving the collection, maintenance, or dissemination of information in identifiable form or that make significant changes to existing information technology that manages information in identifiable form. A PIA is an evaluation of how information in identifiable form is collected, stored, protected, shared, and managed. The purpose of a PIA is to demonstrate that system owners and developers have incorporated privacy, civil rights, and civil liberties protections throughout the entire life cycle of a system. The act requires an agency to make PIAs publicly available, except when an agency in its discretion determines publication of the PIA would raise security concerns or reveal classified (i.e., national security) information or sensitive. Although this act does not apply to SLTT partners, this tool is useful for identifying and mitigating

privacy risks and for notifying the public what PII the SLTT agency is collecting, why PII is being collected, and how the PII will be collected, used, accessed, shared, safeguarded, and stored.

- 12. Electronic Communications Privacy Act of 1986, 18 U.S.C. §§ 2510–2522, 2701–2709, United States Code, Title 18, Part I, Chapter 119, §§ 2510–2522, 2701–2709, and 3121–3125, Public Law 99-508**—This set of statutes prohibits a person from intentionally intercepting, trying to intercept, or asking another person to intercept or try to intercept any wire, oral, or electronic communication or trying to use information obtained in this manner. From another perspective, the law describes what law enforcement may do to intercept communications and how an organization may draft its acceptable use policies and monitor communications. Although it is a federal statute, the act does apply to state and local agencies and officials.
- 13. Fair Credit Reporting Act, 15 U.S.C. § 1681, United States Code, Title 15, Chapter 41, Subchapter III, § 1681**—The Fair Credit Reporting Act regulates the collection, dissemination, and use of consumer information, including consumer credit information by consumer reporting agencies. Consumer reporting agencies include specialty agencies, such as agencies that sell information about employment history, insurance claims, check-writing histories, medical records, and rental history records, as well as credit bureaus. The law primarily deals with the rights of people about whom information has been gathered by consumer reporting agencies and the obligations of the agencies. Government agencies may obtain information from these reporting agencies and should be aware of the nature and limitations of the information, in terms of collection, retention, and error correction.
- 14. Federal Civil Rights Laws, 42 U.S.C. § 1983, United States Code, Title 42, Chapter 21, Subchapter I, § 1983**—This is a federal statute that allows an individual to sue public officials in federal court for violations of the individual's civil rights. Civil rights include such things as the Fourth Amendment's prohibitions against unreasonable search and seizure, violations of privacy rights, and violations of the right to freedom of religion, free speech, and free association. It serves as a deterrent to unlawful collection, use, or sharing of information rather than providing specific authority or a prohibition to the collection, use, or sharing of information.
- 15. Federal Driver's Privacy Protection Act (DPPA), 18 USC §§ 2721–2725**—Restricts access and prohibits the release of personal information from state motor vehicle records to ensure the privacy of persons whose records have been obtained by that department in connection with a motor vehicle record unless certain criteria are met.
- 16. Federal Records Act, 44 U.S.C. § 3301, United States Code, Title 44, Chapter 33, § 3301**—This chapter contains the laws governing disposal of records made or received by a federal agency in the normal course of business. It discusses procedures and notices, if required, and the role of the federal archivist. The law applies only to federal agencies, but there may be similar state or local laws applicable to state and local agencies.
- 17. Freedom of Information Act (FOIA), 5 U.S.C. § 552, United States Code, Title 5, Part I, Chapter 5, Subchapter II, § 552**—The federal FOIA, enacted in 1966, provides access to federal agency records or information. It does not, however, allow access to state or local government records. Nearly all states have their own public access statutes that provide access to state- and local-agency records. The interaction of federal and state FOIA laws can create complex issues. Federal statutes, in essence, provide a baseline of legal protections for individuals. While state legislatures may pass laws to supplement these federal guidelines, state laws that interfere with or are contrary to a federal law are preempted. By virtue of the Supremacy Clause of the U.S. Constitution (Article VI, Clause 2), federal law may restrict access to records otherwise available pursuant to a state's FOIA by requiring that certain information be kept confidential. Thus, federal confidentiality requirements may supersede a state FOIA statute mandating public disclosure of a record, but only when there is a specific federal statute (other than the federal FOIA) that mandates the records be kept confidential. In short, records may be available under one FOIA statute but not pursuant to another.

- 18. Health Insurance Portability and Accountability Act (HIPAA) of 1996, 42 U.S.C. § 201, United States Code, Title 42, Chapter 6A, Subchapter I, § 201; Public Law 104-191**—HIPAA was enacted to improve the Medicare and Medicaid programs and the efficiency and effectiveness of the nation's health care system by encouraging the development of a national health information system through the establishment of standards and requirements for the electronic transmission of health information. To that end, Congress directed the U.S. Department of Health and Human Services (HHS) to issue safeguards to protect the security and confidentiality of health information. To implement HIPAA's privacy requirements, HHS promulgated regulations setting national privacy standards for health information: the Standards for Privacy of Individually Identifiable Health Information (the "Privacy Rule")—42 U.S.C. §1320d-2; 45 CFR Parts 160, 164 (2003).
- 19. HIPAA, Standards for Privacy of Individually Identifiable Health Information, 45 CFR Parts 160 and 164, Code of Federal Regulations, Title 45, Parts 160 and 164**—This "Privacy Rule" sets forth national standards for the privacy and security of individually identifiable health information (45 CFR Part 164, Subpart E (2003)). This rule has been described as providing a "federal floor" of safeguards to protect the confidentiality of medical information. State laws that provide stronger privacy protection will continue to apply over and above the federal privacy protection. The general rule under these standards states that a covered entity may not use or disclose protected health information except as permitted or required by the rules (45 CFR §§ 164.502(a) and 164.103 [defining protected health information and use]). The Privacy Rule applies to the following covered entities: (1) a health plan, (2) a health care clearinghouse, and (3) a health care provider who transmits any health information in electronic form in connection with certain transactions (42 U.S.C. §1320d-1(a) (2003); 45 CFR § 160.102 (2003)). Since the Privacy Rule applies only to a covered entity, a governmental body begins its inquiry by first determining whether it is a covered entity under the Privacy Rule (45 CFR § 160.103 (2003) [defining health plan, health care clearinghouse, health care provider]). If it is a covered entity, it then looks to the Privacy Rule for a permitted or required disclosure.
- 20. Indian Civil Rights Act of 1968, 25 U.S.C. § 1301 et seq., United States Code, Title 25, Chapter 15, Subchapter I**—This act contains definitions of relevant terms and extends certain constitutional rights to Indian tribes exercising powers of self-government.
- 21. Intelligence Reform and Terrorism Prevention Act of 2004 (IRTPA), Section 1016, as amended by the 9/11 Commission Act**—This act broadly affects U.S. terrorism law and applies directly to the federal government. It establishes the Director of National Intelligence, the National Counterterrorism Center, and the Privacy and Civil Liberties Oversight Board. Of importance to SLTT agencies, IRTPA establishes the Information Sharing Environment (ISE) (see Appendix A, Glossary of Terms and Definitions) for the sharing of terrorism-related information at all levels of government, with private agencies, and with foreign partners.
- 22. National Child Protection Act of 1993, Public Law 103-209 (December 20, 1993), 107 Stat. 2490**—In each state, an authorized criminal justice agency of the state shall report child abuse crime information to or index child abuse crime information in the national criminal history background check system. A criminal justice agency can satisfy the requirement by reporting or indexing all felony and serious misdemeanor arrests and dispositions. The U.S. Attorney General (AG) is required to publish an annual statistical summary of child abuse crimes. The act requires that 80 percent of final dispositions be entered in the state databases by December 1998, with steps being taken toward 100 percent entry.

A 1994 amendment required that the AG—in consultation with federal, state, and local officials, including officials responsible for criminal history record systems, and representatives of public and private care organizations and health, legal, and social welfare organizations—shall develop guidelines for the adoption of appropriate safeguards by care providers and by the state for protecting children, the elderly, and individuals with disabilities from abuse.

23. National Crime Prevention and Privacy Compact, 42 U.S.C. § 14616, United States Code, Title 42, Chapter 140, Subchapter II, § 14616—The compact establishes an infrastructure by which states can exchange criminal records for non-criminal justice purposes according to the laws of the requesting state and provide reciprocity among the states to share records without charging each other for the information. The Compact Council, as a national independent authority, works in partnership with criminal history record custodians, end users, and policymakers to regulate and facilitate the sharing of complete, accurate, and timely criminal history record information to non-criminal justice users in order to enhance public safety, welfare, and the security of society while recognizing the importance of individual privacy rights.

24. National Security Act, Public Law 235, Section 606, in accordance with Executive Order 13549, Classified National Security Information Program for State, Local, Tribal, and Private Sector Entities, August 18, 2010—The National Security Act of 1947 mandated a major reorganization of foreign policy and military establishments of the U.S. government. The act created many of the institutions that U.S. Presidents found useful when formulating and implementing foreign policy, including the National Security Council and the Central Intelligence Agency. The 1947 law also caused far-reaching changes in the military establishment. The War Department and Navy Department merged into a single U.S. Department of Defense under the Secretary of Defense, who also directed the newly created Department of the Air Force. However, each of the three branches maintained its own service secretaries.

On October 7, 2011, President Barack Obama signed Executive Order 13549, entitled, “Structural Reforms to Improve the Security of Classified Networks and the Responsible Sharing and Safeguarding of Classified Information.” This order directs structural reforms to ensure responsible sharing and safeguarding of classified information on computer networks that shall be consistent with appropriate protections for privacy and civil liberties. Agencies bear the primary responsibility for meeting these twin goals. These structural reforms will ensure coordinated interagency development and reliable implementation of policies and minimum standards regarding information security, personnel security, and systems security; address both internal and external security threats and vulnerabilities; and provide policies and minimum standards for sharing classified information both within and outside the federal government. These policies and minimum standards will address all agencies that operate or access classified computer networks, all users of classified computer networks (including contractors and others who operate or access classified computer networks controlled by the federal government), and all classified information on those networks.

25. NIST Special Publication 800-53 (Appendix J) Security and Privacy Controls for Federal Information Systems and Organizations—Federal agencies are required to ensure that privacy protections are incorporated into information security planning. To that end, SP 800-53 Rev. 4 features eight families of privacy controls that are based on the FIPPs. The proliferation of social media, Smart Grid, mobile, and cloud computing as well as the transition from structured to unstructured information and metadata environments have added significant complexities and challenges for federal organizations in safeguarding privacy. These challenges extend well beyond the traditional information technology security view of protecting privacy, which focused primarily on ensuring confidentiality. The use of these standardized privacy controls will provide a more disciplined and structured approach for satisfying federal privacy requirements and demonstrating compliance with those requirements. Like their federal partners, SLTT agencies may use the privacy controls when evaluating their systems, processes, and programs.

26. Preparing for and Responding to a Breach of Personally Identifiable Information, OMB Memorandum M-17-12 (January 2017)—This memorandum sets forth the policy for federal agencies to prepare for and respond to a breach of PII. It includes a framework for assessing and mitigating the risk of harm to individuals potentially affected by a breach, as well as guidance on whether and how to provide notification and services to those individuals. This memorandum is intended to promote consistency in the way agencies prepare for and respond to a breach by requiring common standards and processes.

- 27. Privacy Act of 1974, 5 U.S.C. § 552a, United States Code, Title 5, Part I, Chapter 5, Subchapter II, § 552a**—The Privacy Act establishes a code of fair information practices that governs the collection, maintenance, use, and dissemination of information about individuals that is maintained in systems of records by federal agencies. A system of records is a group of records under the control of an agency from which information is retrieved by the name of the individual or by some identifier assigned to the individual. The Privacy Act prohibits the disclosure of a record about an individual from a system of records absent the written consent of the individual, unless the disclosure is pursuant to one of twelve statutory exceptions. The act also provides individuals with a means by which to seek access to and amendment of their records and sets agency record-keeping requirements. In addition, the Privacy Act requires that agencies give the public notice of their systems of records by publication in the *Federal Register*.
- 28. Privacy of Consumer Financial Information, 16 CFR Part 313, Code of Federal Regulations, Title 16, Chapter I, Part 313**—This code oversees the treatment of nonpublic personal information about consumers by financial institutions and requires the institution to provide notice to customers about its privacy policies, the conditions under which it can disclose this information, and its opt-out policies. This code also prohibits the disclosure of a consumer's credit card, deposit, or transaction account information to nonaffiliated third parties to market to the customer. The requirements for initial notice for the "opt-out" do not apply when nonpublic personal information is disclosed in order to comply with federal, state, or local laws or to comply with an authorized investigation, subpoena, or summons.
- 29. Protection of Sensitive Agency Information, Office of Management and Budget Memorandum M-06-16 (June 2006)**—This memorandum provides a security checklist from the National Institute of Standards and Technology (NIST) to protect remote information removed from or accessed from outside an agency's physical location specific to PII. The NIST checklist requires that agencies verify PII in need of protection, confirm the adequacy of organization policy surrounding PII protection, and implement any necessary protections for PII transported or stored off-site or accessed remotely. In addition to the NIST checklist, the memorandum recommends implementing information encryption on all mobile devices, allowing remote access only with two-factor authentication, using timeout functions on devices, and logging all computer-readable information extracts from databases with sensitive information, while verifying that each extract has either been erased within 90 days or that its use is still required.
- 30. Safeguarding Customer Information, 16 CFR Part 314, Code of Federal Regulations, Title 16, Chapter I, Part 314**—This Federal Trade Commission regulation implements Sections 501 and 505(b)(2) of the Gramm-Leach-Bliley Act. It sets forth standards for developing, implementing, and maintaining reasonable administrative, technical, and physical safeguards to protect the security, confidentiality, and integrity of customer information by financial institutions. While not directly applicable to government agencies, the regulation is useful in outlining the elements of a comprehensive information security program, including administrative, technical, and physical safeguards designed to (1) ensure the security and confidentiality of information, (2) protect against any anticipated threats or hazards to the security or integrity of information, and (3) protect against unauthorized access to or use of information that could result in substantial harm or inconvenience to any individual.
- 31. Sarbanes-Oxley Act of 2002, 15 U.S.C., Chapter 98, § 7201, United States Code, Title 15, Chapter 98, § 7201**—The Sarbanes-Oxley Act of 2002, Pub. L. 107-204 (July 30, 2002), commonly called Sarbanes-Oxley, is a federal law that sets new or enhanced standards for all U.S. public company boards, management, and public accounting firms. Its 11 titles include standards for public audits, internal controls, and financial disclosure. While not applicable to federal, state, local, tribal, or territorial governmental agencies, the business standards established by Sarbanes-Oxley are of value to such agencies in establishing their own policies and procedures to guide and control their business processes.

- 32. Uniting and Strengthening America by Providing Appropriate Tools Required to Intercept and Obstruct Terrorism Act of 2001 (USA PATRIOT Act), Public Law 107-56 (October 26, 2001), 115 Stat. 272**—The USA PATRIOT Act was enacted in response to the terrorist attacks of September 11, 2001. The act was designed to reduce the restrictions on law enforcement agencies' ability to gather intelligence and investigate terrorism within the United States; expand the Secretary of the Treasury's authority to regulate financial transactions, particularly those involving foreign individuals and entities; and broaden the discretion of law enforcement and immigration authorities in detaining and deporting illegal immigrants suspected of terrorism-related acts. The act also expanded the definition of "terrorism" to include domestic terrorism. In 2011, the act was extended for four years, including provisions for roving wiretaps, searches of business records, and the conduct of surveillance of "lone wolves"—individuals suspected of terrorism-related activities that are not linked to terrorist groups.
- 33. U.S. Constitution, First, Fourth, Fifth, Sixth, and Fourteenth Amendments**—The Bill of Rights establishes minimum standards for the protection of the civil rights and civil liberties of individuals in the United States. The First Amendment protects religious freedom, speech, the press, the right to peaceably assemble, and the right to petition the government for a redress of grievances. The Fourth Amendment protects the people from unreasonable searches and seizures and requires that warrants be issued only upon probable cause, supported by oath or affirmation, and particularly describing the place to be searched and the individual or things to be seized. The Sixth Amendment establishes the right of an accused individual to a speedy and public trial by an impartial jury, to be informed of the nature and cause of the charges, to confront witnesses, to have compulsory process to obtain witnesses, and to have the assistance of legal counsel. The Fourteenth Amendment addresses citizenship rights and equal protection of the laws. Although the equal protection clause applies explicitly only to state governments, equal protection requirements apply to the federal government through the Fifth Amendment Due Process Clause.
- 34. The USA FREEDOM Act of 2015** extended some provisions of **the USA PATRIOT Act** addressing the tracking of "lone wolves" and "roving wiretaps" of targets that communicate through multiple devices and replacing provisions related to "bulk collection" under Section 215 of the Patriot Act, with a requirement for a specific selection term used to limit the scope of tangible things sought consistent with the purpose for seeking those things in addition to showing that there are reasonable grounds to believe that the tangible things sought are relevant to an authorized investigation to obtain foreign intelligence information not concerning a United States person or to protect against international terrorism or clandestine intelligence activities.
- 35. Applicants and Recipients of Immigration Relief Under the Violence Against Women Act of 1994 (VAWA), Public Law 103-322, September 13, 1994, and the Victims of Trafficking and Violence Prevention Act of 2000 (T and U nonimmigrant status for victims of trafficking and other serious crimes), Public Law 106-386, Oct. 28, 2000, 8 U.S.C. § 1367, Penalties for Disclosure of Information**—The governing statute prohibits the unauthorized disclosure of information about VAWA,¹⁵ T, and U cases to anyone other than an officer or employee of the U.S. Department of Homeland Security, the U.S. Department of Justice, the U.S. Department of State, or parties covered by exception when there is a need to know. This confidentiality provision is commonly referred to as "Section 384" because it originally became law under Section 384 of the Illegal Immigration Reform and Immigrant Responsibility Act (IIRIRA) of 1996, [5] which protects the confidentiality of victims of domestic violence, trafficking, and other crimes who have filed for or have been granted immigration relief. 8 U.S.C. § 1367 Information is defined as any information relating to aliens who are seeking or have been approved for nonimmigrant or immigrant status as (1) battered spouses, children, or parents under provisions of VAWA; (2) victims of a severe form of human trafficking who generally are cooperating with law enforcement authorities (T nonimmigrant status); or (3) aliens who have suffered substantial physical or mental abuse as the result of qualifying criminal activity and have been, are being, or are likely to be helpful in the

investigation or prosecution of that activity (U nonimmigrant status). This includes information pertaining to qualifying family members who receive derivative T, U, or VAWA status. Because 8 U.S.C. § 1367 applies to any information about a protected individual, this includes records or other information that do not specifically identify the individual as an applicant for or a beneficiary of T nonimmigrant status, U nonimmigrant status, or relief under VAWA.

B. State, Local, Tribal, and Territorial Laws, Regulations, and Guidelines

The following list provides synopses of SLTT laws, regulations, and guidance that a center should review and, when appropriate, cite within the policy when developing a P/CRCL policy for a justice information system. The list is arranged in alphabetical order by popular name.

Appendix C

Fair Information Practice Principles

Fair Information Practice Principles (FIPPs) are a set of internationally recognized principles that inform information privacy policies within both government and the private sector.

Although specific articulations of the FIPPs vary and have evolved since their genesis in the 1970s, core elements are consistent among nations, states, and economic sectors. These core elements are incorporated into data privacy laws, policies, and governance documents around the world. For example, the core elements of the FIPPs can be found:

- At the heart of the Privacy Act of 1974, which applies these principles to U.S. federal agencies.¹⁶
- Mirrored in many states' laws and in fusion centers' privacy policies.
- In the ISO/IEC 29100 Privacy Framework, which has been adopted by numerous foreign countries and international organizations.

The following formulation of the FIPPs is used and implemented for the Information Sharing Environment (ISE) by the U.S. Department of Homeland Security (DHS).¹⁷ Note, however, that under certain circumstances, the FIPPs may be superseded by authorities paralleling those provided in the federal Privacy Act; state, local, tribal, or territorial law; or center policy.

1. **Purpose Specification**—Agencies should specifically articulate the authority that permits the collection of PII. The purpose(s) for which PII is collected should be specified at the time of data collection. Subsequent use of this data should be limited to the original purpose for which the PII was collected (or other purposes *compatible* with the original collection purpose).

Implementing the Purpose Specification Principle—Agencies are bound by specific constitutional and statutory authorities that circumscribe their ability to collect PII. The following are examples of ways agencies may implement this principle:

- Ensure that a valid lawful purpose exists and is documented for all collection of PII.
- Include the source and authority for the data so that access restrictions can be applied.
- Upon receipt of data containing PII from third parties, if possible, identify the purpose for which it was collected initially and limit agency use to only those uses compatible with the original purpose supporting collection.
- Ensure that metadata or other tags are associated with the data as it is shared.
- Institute a two-individual review and approval process to consider any Privacy Act or other legal or policy limitation before permitting use or sharing of data for purposes other than that for which it was collected.

2. **Data Quality/Integrity**—PII collected should be relevant to the purposes identified for its use and should be accurate, complete, and up to date.

Implementing the Data Quality/Integrity Principle—One important way to minimize potential downstream P/CRCL concerns is to ensure that any information collected, stored, and disseminated is accurate. This includes ensuring that the information provides sufficient context for any PII. Possible approaches include:

- Properly labeling PII.

- Determining a policy for safeguarding PII if there are “mixed” databases (i.e., those databases with PII on U.S. individuals and others, regardless of nationality).
- Instituting a source verification procedure to ensure reporting is based only on authorized data.
- Reconciling and updating PII whenever new relevant information is collected.
- Developing a protocol for ensuring data corrections are passed to those entities with which information has been shared.
- Creating a documented process for identifying and addressing situations in which data has been erroneously received, is inaccurate or has been expunged.

3. Collection Limitation/Data Minimization—PII should be collected only if the data is directly relevant and necessary to accomplish the specified purpose. PII should be obtained by lawful and fair means and retained only as long as is necessary to fulfill the specified purpose.

Implementing the Collection Limitation/Data Minimization Principle—Collection limitation may be implemented by:

- Designing a data storage system to pull data for review and then, if appropriate, automatically purging data after the specified retention period has been reached.
- Limiting data field elements to only those that are relevant.
- Ensuring that all distributed reports and products contain only that PII that is relevant and necessary (nothing extraneous or superfluous).
- Ensuring that all shared information with PII meets required thresholds for sharing, such as reasonable suspicion.

4. Use Limitation—PII should not be disclosed, made available, or otherwise used for purposes other than those specified except (a) with the consent of the individual or (b) by the authority of law.

Implementing the Use Limitation Principle—Sharing information should be tempered by adherence to key principles such as “authorized access.” Use limitation may be implemented by:

- Limiting users of data to those with credential-based access.
- Requiring that justifications be entered and logs maintained for all queries with sensitive PII and that an internal review process of those logs takes place at specified intervals.
- Requiring senior analysts to review all reports that use PII before dissemination to ensure (a) that PII is relevant and necessary and (b) that the recipient is authorized to receive the information in the performance of an authorized activity.
- Prior to sharing information, verify that partners have a lawful purpose for requesting information.
- Creating multiple use-based distribution lists and restricting distribution to those authorized to receive the information.

5. Security/Safeguards—Agencies should institute reasonable security safeguards to protect PII against loss, unauthorized access, destruction, misuse, modification, or disclosure.

Implementing the Security/Safeguards Principle—This principle can be implemented by:

- Maintaining up-to-date technology for network security.
- Ensuring that access to data systems requires that users meet certain training and/or vetting standards and that such access is documented and auditable.
- Ensuring that physical security measures are in place, such as requiring an identification card, credentials, and/or passcode for data access; disabling computers’ USB ports; and implementing firewalls to prevent access to commercial e-mail or messaging services.
- Implementing a protocol with technical and manual safeguards to ensure the accuracy and completeness of data system purges when records are deleted at the end of their retention period.
- Ensuring that data system purge protocols include complete record deletion on all backup systems.
- Transitioning older repositories into more modern systems to improve access controls.

- Masking data so that it is viewable only to authorized users.
- Maintaining an audit log to record when information is accessed and by whom for review by senior staff at specified intervals.
- Requiring authorized users to sign nondisclosure agreements.

6. Accountability/Audit—Agency personnel and contractors are accountable for complying with measures implementing the FIPPs, for providing training to all employees and contractors who use PII, and for auditing the actual use and storage of PII.

Implementing the Accountability/Audit Principle—Strong policies must not only be in place but also be effectively implemented. Accountability can be demonstrated by:

- Ensuring that upon entry for duty, all staff take an oath to adhere to the privacy and civil liberties protections articulated in the center's or host agency's mission, core values statements, other key documents, and/or the U.S. Constitution.
- Conducting effective orientation and periodic refresher training, including P/CRCL protections, for all individuals handling PII.
- Tailoring training to specific job functions, database access, or data source/storage requirements.
- Conducting regular audits of all systems in which records are kept to ensure compliance with the P/CRCL policies and all legal requirements.
- Following a privacy incident handling procedure for any data breaches or policy violations.
- Denying database access to individuals until they have completed mandatory systems access training (including training for handling of PII), show a mission need for access, and have any necessary clearances.
- Developing targeted and consistent corrective actions whenever noncompliance is found.

7. Openness/Transparency—To the extent feasible, agencies should be open about developments, practices, and policies with respect to the collection, use, dissemination, and maintenance of PII. Agencies should publish information about policies in this area, including the P/CRCL policy, and contact information for data corrections and complaints.

Implementing the Openness/Transparency Principle—Agencies can implement the Openness/Transparency principle by:

- Providing reports to an internal or external oversight body concerned with P/CRCL issues, including P/CRCL audit results.
- Publishing the P/CRCL policy and redress procedures.
- Meeting with community groups through initiatives or through other opportunities to explain the agency's mission and P/CRCL protections.
- Responding in the fullest way possible to freedom of information and/or sunshine requests and fully explaining any denial of information requests from the public.
- Conducting and publishing Privacy Impact Assessments (PIAs) in advance of implementing any new technologies that affect PII, thereby demonstrating that P/CRCL issues have been considered and addressed.

8. Individual Participation—To the extent practicable, involve the individual in the process of using PII and seek individual consent for the collection, use, dissemination, and maintenance of PII. Agencies should also provide mechanisms for appropriate access, correction, and redress regarding the agency's use of PII.

Implementing the Individual Participation Principle—To the extent appropriate, agencies can implement the Individual Participation principle by:

- Collecting information directly from the individual, to the extent possible and practical.
- Providing the individual with the ability to find out whether an agency maintains a record relating to him or her and, if not (i.e., access and/or correction is denied), then providing the individual with notice as to why the denial was made and how to challenge such a denial.
- Putting in place a mechanism by which an individual is able to prevent information about him or her that was obtained for one purpose from being used for other purposes without his or her knowledge.

Appendix D

Sample Fusion Center Privacy, Civil Rights, and Civil Liberties (P/CRCL) Policy

The following is a sample fusion center privacy, civil rights, and civil liberties (P/CRCL) policy that contains all of the sample policy language shown after each question in the template section of this document. However, while drafting a fusion center P/CRCL policy that includes this language, it is important that the policy author review each question and its associated guidance in the template section to customize the language. To facilitate this task, the policy language contained in this appendix has been written to mirror the same structure and policy categories as those reflected in the template. Therefore, the template questions may be followed, item by item, as the author customizes this language.

It is critical that the author of the policy not cut and paste the policy language in the template and use it as is, without making modifications. In many areas, the author is prompted to insert or customize language. These areas are shown **bolded and in brackets** [].

It is also important to note that this sample policy may not cover all concepts that are unique to your center's specific P/CRCL program. Any provisions that are not applicable should be deleted. During the policy development or update process, centers are encouraged to customize language with references to applicable statutes, rules, standards, guidelines, and policies.

Finally, since this guidance promotes transparency with the public, each center should ensure that its policy is written in a manner that is understandable by both center personnel and members of the public. While some of the provisions in this guidance may reflect concepts and processes long understood and integrated into the daily work of law enforcement, such that a center may not feel they are necessary to the policy, the provisions are included in the sample policy for the purposes of informing the general public and articulating the center's policies and procedures for protecting P/CRCL.

A. Purpose Statement

1. The mission of the **[name of center]** is to collect, evaluate, analyze, and disseminate information and intelligence data (records) regarding criminal and terrorist activity in the [region or state] while protecting privacy, civil rights, civil liberties, and other protected interests. This includes implementing appropriate privacy and civil liberties safeguards as outlined in the principles of the Privacy Act of 1974, as amended, to ensure that the information privacy and other legal rights of individuals and organizations are protected (see definitions of "Fair Information Practice Principles" [(FIPPs)] and "Protected Information" in **[insert policy definitions section (see Appendix A, Terms and Definitions)]**).

The purpose of this P/CRCL protection policy is to promote **[name of center]** and user conduct that complies with applicable federal, state, local, tribal, and territorial law **[cite to policy definitions section (see Appendix A, Terms and Definitions)]** and assists the center and its users in:

- Increasing public safety and improving national security.
- Minimizing the threat and risk of injury to specific individuals.
- Minimizing the threat and risk of physical or financial injury to law enforcement and others responsible for public protection, safety, or health.
- Minimizing the threat and risk of damage to real or personal property.
- Protecting individual privacy, civil rights, civil liberties, and other protected interests.
- Protecting the integrity of the criminal investigatory, criminal intelligence, and justice system processes and information.
- Minimizing the reluctance of individuals or groups to use or cooperate with the justice system.
- Supporting the role of the justice system in society.

- Promoting governmental legitimacy and accountability.
- Not unduly burdening the ongoing business of the justice system.
- Making the most effective use of public resources allocated to public safety agencies.

B. Policy Applicability and Legal Compliance

1. All **[name of center]** personnel, participating agency personnel, personnel providing information technology services to the center, staff members in other public agencies and private contractors providing services to the center, and other authorized users who are not employed by the center or a contractor will comply with the center's P/CRCL policy. This policy applies to information the center gathers or collects, receives, maintains, stores, accesses, discloses, or disseminates to center personnel, governmental agencies (including Information Sharing Environment [ISE] participating centers and agencies), and participating justice and public safety agencies, as well as to private contractors, private entities, and the general public.
2. The **[name of center]** will provide a printed or electronic copy of this policy to all center personnel, non-center personnel who provide services to the center, and participating agencies and individual users. The **[name of center]** will require both a written acknowledgement of receipt of this policy and a written agreement to comply with this policy and the applicable provisions it contains.
3. C. Governance and Oversight

1. Primary responsibility for the operation of the **[name of center]**; its justice systems, operations, and coordination of personnel; the receiving, seeking, retention, evaluation, data quality, analysis, destruction, sharing, disclosure, or dissemination of information; and the enforcement of this policy is assigned to the **[position/title]** of the center.
2. The Privacy Officer receives reports regarding alleged errors and violations of the provisions of this policy, receives and coordinates complaint resolution under the center's redress policy, and serves as the liaison for the center (and for the Information Sharing Environment), ensuring that privacy, civil rights, and civil liberties protections are implemented through efforts such as training, business process changes, and system designs that incorporate privacy-enhancing technologies. 1. For examples of primary terms and definitions used in this policy, refer to **[insert section or appendix of policy (see Appendix A, Terms and Definitions)]**.

E. Information

1. The **[name of center]** will seek or retain information (including "protected attributes," subject to conditions articulated in Section E.2., that:
 - Is based on a possible threat to public safety or the enforcement of criminal law, or
 - Is based on reasonable suspicion that an identifiable individual or organization has committed a criminal offense or is involved in or planning criminal (including terrorist) conduct or activity that presents a threat to any individual, the community, or the nation and that the information is relevant to the criminal (including terrorist) conduct or activity, or
 - Is relevant to the investigation and prosecution of suspected criminal (including terrorist) incidents; the resulting justice system response; the enforcement of sanctions, orders, or sentences; or the prevention of crime, or
 - Is useful in crime analysis or in the administration of criminal justice and public safety (including topical searches), and
 - The source of the information is reliable and verifiable or limitations on the quality of the information are identified, and
 - The information was collected in a fair and lawful manner, with the knowledge and consent of the individual, if appropriate.

The center may retain protected information that is based on a level of suspicion that is less than "reasonable suspicion," such as tips and leads (including suspicious activity report [SAR] information) subject to the policies and procedures specified in this policy.

2. In accordance with applicable laws, guidance, and regulations, the **[name of center]** will not seek or retain and will inform information-originating agencies not to submit information about individuals or organizations solely on the basis of their religious, political, or social views or activities; their participation in a particular noncriminal organization or lawful event; or their races, ethnicities, citizenship, national origin, ages, disabilities, genders, gender identities, or sexual orientations.

When participating on a federal law enforcement task force or when documenting a SAR or an ISE-SAR in the Nationwide Suspicious Activity Reporting (SAR) Initiative (NSI), race, ethnicity, gender, national origin, religion, sexual orientation, or gender identity must not be considered as factors creating suspicion. However, those attributes may be documented in specific suspect descriptions for identification purposes.

3. The **[name of center]** applies labels to center-originated information (or ensures that the originating agency has applied labels) to indicate to the accessing authorized user that:

- The information is protected information (as defined by the ISE Privacy Guidelines) **[or]** (as defined by the center to include PII on any individual) **[cite applicable authority, if any, and cite to center's definitions of "protected information" and "personally identifiable information," in Appendix A of policy]**, and, to the extent expressly provided in this policy, includes organizational entities.
 - The information is subject to **[local, state or federal]** laws restricting access, use, or disclosure.
4. The **[name of center]** personnel will, upon receipt of information, assess the information to determine or review its nature, usability, and quality. Personnel will assign categories to the information (or ensure that the originating agency has assigned categories to the information) to reflect the assessment, such as:
- Whether the information consists of tips and leads (including SAR data), criminal history, intelligence information, case records, conditions of supervision, case progress, or other information category.
 - The nature of the source as it affects veracity (for example, anonymous tip, trained interviewer or investigator, public record, private sector).
 - The reliability of the source (for example, reliable, usually reliable, unreliable, unknown).
 - The validity of the content (for example, confirmed, probable, doubtful, cannot be judged).
5. At the time a decision is made by the **[name of center]** to retain information, it will be labeled (by record, data set, or system of records), to the maximum extent feasible, pursuant to applicable limitations on access and sensitivity of disclosure to:
- Protect confidential sources and police undercover techniques and methods.
 - Not interfere with or compromise pending criminal investigations.
 - Protect an individual's right of privacy and his or her civil rights and civil liberties.
 - Provide legally required protections based on the individual's status as a child, sexual abuse victim, resident of a substance abuse treatment program, resident of a mental health treatment program, or resident of a domestic abuse shelter.
6. The labels assigned to existing information under **[insert section number of policy (see Section E.5 above)]** will be reevaluated whenever:
- New information is added that has an impact on access limitations or the sensitivity of disclosure of the information.
 - There is a change in the use of the information affecting access or disclosure limitations; for example, the information becomes part of court proceedings for which there are different public access laws.
7. **[Name of center]** personnel are required to adhere to the following practices and procedures for the receipt, collection, assessment, storage, access, dissemination, retention, and security of tips and leads (including SAR information). Center personnel will:
- Prior to allowing access to or dissemination of the information, ensure that attempts to validate or refute the information have taken place and that the information has been assessed for sensitivity and confidence by subjecting it to an evaluation or screening process to determine its credibility and value and categorize the information as unsubstantiated or uncorroborated if attempts to validate or determine the reliability of the information have been unsuccessful. The center will use a standard reporting format and data collection codes for SAR information.
 - Store the information using the same storage method used for data which rises to the level of reasonable suspicion and which includes an audit and inspection process, supporting documentation, and labeling of the data to delineate it from other information.
 - Allow access to or disseminate the information using the same (or a more restrictive) access or dissemination standard that is used for data that rises to the level of reasonable suspicion (for example, "need-to-know" and "right-to-know" access or dissemination for PII).

- Regularly provide access to or disseminate the information in response to an interagency inquiry for law enforcement, homeland security, or public safety and analytical purposes or provide an assessment of the information to any agency, entity, individual, or the public when credible information indicates potential imminent danger to life or property.
 - Retain information for **[insert retention period]** in order to work an unvalidated tip or lead to determine its credibility and value or assign a “disposition” label (for example, undetermined or unresolved, cleared or unfounded, verified, or under active investigation) so that a subsequently authorized user knows the status and purpose for the retention and will retain the information based on the retention period associated with the disposition label.
 - Adhere to and follow the center’s physical, administrative, and technical security measures to ensure the protection and security of tips, leads, and SAR information. Tips, leads, and SAR information will be secured in a system that is the same as or similar to the system that secures data that rises to the level of reasonable suspicion.
8. The **[name of center]** incorporates the gathering, processing, reporting, analyzing, and sharing of terrorism-related suspicious activities and incidents (SAR process) into existing processes and systems used to manage other crime-related information and criminal intelligence, thus leveraging existing policies and protocols utilized to protect the information, as well as information privacy, civil rights, and civil liberties.
9. The **[name of center]** will identify and review protected information that may be accessed from or disseminated by the center prior to sharing that information through the Information Sharing Environment. Further, the center will provide notice mechanisms, including but not limited to metadata or data field labels, to enable ISE authorized users to determine the nature of the protected information and how to handle the information in accordance with applicable legal requirements.
10. The **[name of center]** requires certain basic descriptive information (metadata tags or labels) to be entered and electronically associated with data (or content) for which there are special laws, rules, or policies regarding access, use, and disclosure, including terrorism-related information shared through the ISE. The types of information include:
- The name of the originating center, department or agency, component, and subcomponent.
 - The name of the center’s justice information system from which the information is disseminated.
 - The date the information was collected and, when feasible, the date its accuracy was last verified.
 - The title and contact information for the person to whom questions regarding the information should be directed.
11. The **[name of center]** will attach (or ensure that the originating agency has attached) specific labels and descriptive metadata to information that will be used, accessed, or disseminated to clearly indicate any legal restrictions on information sharing based on information sensitivity or classification.
12. The **[name of center]** will keep a record of the source of all information sought and collected by the center.

F. Acquiring and Receiving Information

1. Information-gathering (acquisition) and access and investigative techniques used by the **[name of center]** and information-originating agencies will remain in compliance with and will adhere to applicable laws and guidance, including, but not limited to:

- 28 CFR Part 23 regarding “criminal intelligence information,” as applicable.
 - The FIPPs; see **[refer to Appendix C, “Fair Information Practice Principles”]** but note that under certain circumstances, the FIPPs may be superseded by authorities paralleling those provided in the federal Privacy Act; state, local, tribal, or territorial law; or center policy).
 - Criminal intelligence guidelines established under the U.S. Department of Justice’s (DOJ) National Criminal Intelligence Sharing Plan (NCISP) (Ver. 2).
 - Constitutional provisions; **[state]** code, Section **[insert number]**; and administrative rules, as well as regulations and policies that apply to multijurisdictional intelligence and information databases.
2. The **[name of center]**’s SAR process provides for human review and vetting to ensure that information is both gathered in an authorized and lawful manner and, when applicable, determined to have a potential terrorism nexus. Law enforcement officers and appropriate center and participating agency staff members will be trained to recognize those behaviors and incidents that are indicative of criminal activity associated with terrorism.
 3. The **[name of center]**’s SAR process includes safeguards to ensure, to the greatest degree possible, that only information regarding individuals involved in activities that have been determined to be consistent with criminal activities associated with terrorism will be documented and shared through the ISE. These safeguards are intended to ensure that information that could violate civil rights (race, ethnicity, national origin, religion, etc.) and civil liberties (speech, assembly, association, religious exercise, etc.) will not be intentionally or inadvertently gathered, documented, processed, and shared. **[Refer to policy Sections E.2 and F.2]**
 4. Information-gathering and investigative techniques used by the **[name of center]** will and those used by originating agencies should be the least intrusive means necessary in the particular circumstances to gather information it is authorized to seek or retain.
 5. External agencies that access the **[name of center]**’s information or share information with the center are governed by the laws and rules governing those individual agencies, including applicable federal and state laws.
 6. The **[name of center]** will contract only with commercial database entities that provide an assurance that their methods for gathering PII comply with applicable local, state, tribal, territorial, and federal laws, statutes, and regulations and that these methods are not based on misleading information-gathering practices.
 7. The **[name of center]** will not directly or indirectly receive, seek, accept, or retain information from:
 - An individual who or nongovernmental entity that may receive a fee or benefit for providing the information, except as expressly authorized by law or center policy.
 - An individual who or information provider that is legally prohibited from obtaining or disclosing the information.

G. Data Quality Assurance

1. The **[name of center]** will make every reasonable effort to ensure that information sought or retained is derived from dependable and trustworthy sources; accurate; current; complete, including the relevant context in which it was sought or received and other related information; and merged with other information about the same individual or organization only when the applicable standard **[refer to Section I, Merging Records, or appropriate policy section]** has been met.
2. The **[name of center]** will put in place a process for additional fact development during the vetting process where a SAR includes PII and is based on behaviors that are not inherently criminal. The **[name of center]** will articulate additional facts or circumstances to support the determination that

the behavior observed is not innocent but rather reasonably indicative of preoperational planning associated with terrorism.

3. At the time of retention in the system, the information will be labeled regarding its level of quality (accuracy, completeness, currency, and confidence [verifiability and reliability]).
4. The **[name of center]** investigates, in a timely manner, alleged errors and deficiencies (or refers them to the originating agency) and corrects, deletes, or refrains from using protected information found to be erroneous or deficient.
5. The labeling of retained information will be reevaluated by the **[name of center]** or the originating agency when new information is gathered that has an impact on confidence (source reliability and content validity) in previously retained information.
6. The **[name of center]** will conduct periodic data quality reviews of information it originates and make every reasonable effort to ensure that the information will be corrected, deleted from the system, or not used when the center identifies information that is erroneous, misleading, obsolete, or otherwise unreliable; the center did not have authority to gather the information or to provide the information to another agency; or the center used prohibited means to gather the information (except when the center's information source did not act as the agent of the center in gathering the information).
7. Originating agencies external to the **[name of center]** are responsible for reviewing the quality and accuracy of the data provided to the center. The center will review the quality of information it has received from an originating agency and advise the appropriate contact person in the originating agency, in writing or electronically, if its data is alleged, suspected, or found to be inaccurate, incomplete, out of date, or unverifiable.
8. The **[name of center]** will use written or electronic notification to inform recipient agencies when information previously provided to the recipient agency is deleted or changed by the center because the information is determined to be erroneous, includes incorrectly merged information, is out of date, cannot be verified, or lacks adequate context such that the rights of the individual may be affected.

H. Collation and Analysis

1. Information acquired or received by the **[name of center]** or accessed from other sources will be analyzed only by qualified and properly trained individuals who have successfully completed a background check and possess the appropriate security clearance.
2. Information subject to collation and analysis is information as defined and identified in **[refer to Section E, Information, or appropriate policy section]**.
3. Information acquired or received by the **[name of center]** or accessed from other sources is analyzed according to priorities and needs and will be analyzed only to:
 - Further crime prevention (including terrorism), law enforcement, public safety, force deployment, or prosecution objectives and priorities established by the center.
 - Provide tactical and/or strategic intelligence on the existence, identification, and capability of individuals and organizations suspected of having engaged in or engaging in criminal (including terrorist) activities.

Best Practice Sample Language: The **[name of center]** requires that all analytical products be reviewed [and approved] by the Privacy Officer [or privacy oversight committee] to ensure that they provide appropriate privacy, civil rights, and civil liberties protections prior to dissemination or sharing by the center.

I. Merging Records

1. Information will be merged only by qualified individuals who have successfully completed a background check and possess the appropriate security clearance, if applicable, and have been selected, approved, and trained accordingly.
2. Records about an individual or an organization from two or more sources will not be merged by the **[name of center]** unless there is sufficient identifying information to clearly establish that the information is about the same individual or organization. The set of identifiers sufficient to allow merging will consist of all available attributes that can contribute to a higher accuracy of match.

OR

The set of identifying information sufficient to allow merging by the **[name of center]** may include the name (full or partial) and, in most cases, one or more of the following: date of birth; law enforcement or corrections system identification number; individual identifiers, such as fingerprints, photographs, physical description, height, weight, eye and hair color, race, ethnicity, tattoos, or scars; social security number; driver's license number; or other biometrics, such as DNA, retinal scan, or facial recognition. The identifiers or characteristics that, when combined, could clearly establish that the information from multiple records is about the same organization may include the name, federal or state tax ID number, office address, and telephone number.

3. If the matching requirements are not fully met but there is reason to believe the records are about the same individual, the information may be associated by the **[name of center]** if accompanied by a clear statement that it has not been adequately established that the information relates to the same individual or organization.

J. Sharing and Disclosure

1. Credentialed, role-based access criteria will be used by the **[name of center]**, as appropriate, to control:
 - The information to which a particular group or class of users can have access based on the group or class.
 - The information a class of users can add, change, delete, or print.
 - To whom, individually, the information can be disclosed and under what circumstances.
2. The **[name of center]** adheres to the current version of the ISE-SAR Functional Standard for its suspicious activity reporting (SAR) process, including the use of a standard reporting format and commonly accepted data collection codes and a sharing process that complies with the ISE-SAR Functional Standard for suspicious activity potentially associated with terrorism.
3. Access to or disclosure of records retained by the **[name of center]** will be provided only *to persons within the center or in other governmental agencies* who are authorized to have access and only for legitimate law enforcement, public protection, public prosecution, public health, or justice purposes and only for the performance of official duties in accordance with law and procedures applicable to the agency for which the person is working. An audit trail sufficient to allow the identification of each individual who accessed information retained by the center and the nature of the information accessed will be kept by the center.
4. Agencies external to the **[name of center]** may not disseminate information accessed or disseminated from the center without approval from the center or other originator of the information.
5. Records retained by the **[name of center]** may be accessed by or *disseminated to those responsible for public protection, public safety, or public health* only for public protection, public safety, or public health purposes and only in the performance of official duties in accordance with applicable laws and procedures. An audit trail sufficient to allow the identification of each individual

who accessed or received information retained by the center and the nature of the information accessed will be kept by the center.

6. Information gathered or collected and records retained by the **[name of center]** may be accessed or disseminated *for specific purposes* upon request by persons authorized by law to have such access and only for those uses and purposes specified in the law. An audit trail sufficient to allow the identification of each individual who requested, accessed, or received information retained by the center; the nature of the information requested, accessed, or received; and the specific purpose will be kept for a minimum of **[specify the retention period for your jurisdiction for this type of request]** by the center.
7. Information gathered or collected and records retained by the **[name of center]** may be accessed or disclosed to a *member of the public* only if the information is defined by law [citation to applicable law] to be a public record or otherwise appropriate for release to further the center's mission and is not exempt from disclosure by law. Such information may be disclosed only in accordance with the law and procedures applicable to the center for this type of information. An audit trail sufficient to allow the identification of each individual member of the public who accessed or received information retained by the center and the nature of the information accessed will be kept by the center. **[Refer to Section J.9 for the categories of records that will ordinarily not be provided to the public pursuant to applicable legal authority.]**
8. Information gathered or collected and records retained by the **[name of center]** *will not be*:
 - Sold, published, exchanged, or disclosed for commercial purposes.
 - Disclosed or published without prior notice to the originating agency that such information is subject to disclosure or publication, unless disclosure is agreed to as part of the normal operations of the agency or specifically authorized by the originating agency.
 - Disseminated to persons not authorized to access or use the information.
9. There are several categories of records that will ordinarily *not be provided* to the public:
 - Records required to be kept confidential by law are exempted from disclosure requirements under **[cite public records act and applicable section]**.
 - Information determined by the federal government to meet the definition of "classified information" as defined in the National Security Act, Public Law 235, Section 606, and in accordance with Executive Order 13549, Classified National Security Information Program for State, Local, Tribal, and Private Sector Entities, August 18, 2010.
 - Investigatory records of law enforcement agencies that are exempted from disclosure requirements under [cite public records act and applicable section]. However, certain law enforcement records must be made available for inspection and copying under **[cite public records act and applicable section]**.
 - A record or part of a record the public disclosure of which would have a reasonable likelihood of threatening public safety by exposing a vulnerability to terrorist attack is exempted from disclosure requirements under **[cite public records act and applicable section]**. By way of example, this may include a record assembled, prepared, or maintained to prevent, mitigate, or respond to an act of terrorism under **[cite public records act and applicable section]** or an act of agricultural terrorism under **[cite public records act and applicable section]**, vulnerability assessments, risk planning documents, needs assessments, and threat assessments.
 - Protected federal, state, local, tribal, or territorial records, which may include records originated and controlled by another agency that cannot, under **[cite applicable law]**, be shared without permission.
 - A record, or part of a record that constitutes trade secrets or information that is commercial, financial, or otherwise subject to a nondisclosure agreement that was obtained from a person and is privileged and confidential **[cite applicable law]**.

10. The **[name of center]** shall not confirm the existence or nonexistence of information to any person or agency that would not be eligible to receive the information unless otherwise required by law.

K. Redress

K.1 Disclosure

1. Upon satisfactory verification (fingerprints, driver's license, or other specified identifying documentation) of his or her identity and subject to the conditions specified in 2., below, an individual is entitled to know the existence of and to review the information about him or her that has been gathered and retained by the **[name of center]**. The individual may obtain a copy of the information for the purpose of challenging the accuracy or completeness of the information (correction). The center's response to the request for information will be made within a reasonable time and in a form that is readily intelligible to the individual. A record will be kept of all requests and of what information is disclosed to an individual.
2. The existence, content, and source of the information will not be made available by the **[name of center]** to an individual when **[the policy must cite applicable legal authority for each stated basis for denial]**. Examples may include:
 - Disclosure would interfere with, compromise, or delay an ongoing investigation or prosecution.
 - Disclosure would endanger the health or safety of an individual, organization, or community.
 - The information is in a criminal intelligence information system subject to 28 CFR Part 23 [see 28 CFR § 23.20(e)].
 - The information relates to **[title, regulation, code, etc.]**.
 - The information source does not reside with the center.
 - The center did not originate and does not have a right to disclose the information.
 - Other *authorized* basis for denial.

If the information does not originate with the center, the requestor will be referred to the originating agency, if appropriate or required, or the center will notify the source agency of the request and its determination that disclosure by the center or referral of the requestor to the source agency was neither required nor appropriate under applicable law.

K.2 Corrections

1. If an individual requests correction of information ***originating with the*** **[name of center]** that has been disclosed, the center's Privacy Officer or designee will inform the individual of the procedure for requesting and considering requested corrections, including appeal rights if requests are denied in whole or in part. A record will be kept of all requests for corrections and the resulting action, if any.

K.3 Appeals

1. The individual who has requested disclosure or to whom information has been disclosed will be given reasons if disclosure or requests for corrections are denied by the **[name of center]** or the originating agency. The individual will also be informed of the procedure for appeal when the center or originating agency has cited an exemption for the type of information requested or has declined to correct challenged information to the satisfaction of the individual to whom the information relates.

K.4 Complaints

1. The center will inform the individual of the procedure for submitting (if needed) and resolving such complaints. Complaints will be received by the center's Privacy Officer or **[insert title of designee or other individual]** at the following address: **[insert mailing address, e-mail address, and/or**

link to page if complaints can be submitted electronically]. The Privacy Officer or **[insert title of designee or other individual]** will acknowledge the complaint and state that it will be reviewed but will not confirm the existence or nonexistence of the information to the complainant unless otherwise required by law. If the information did not originate with the center, the Privacy Officer **[or insert title of designee or other individual]** will notify the originating agency in writing or electronically within 10 days and, upon request, assist such agency to correct any identified data/record deficiencies, purge the information, or verify that the record is accurate. All information held by the center that is the subject of a complaint will be reviewed within 30 days and confirmed or corrected/purged if determined to be inaccurate or incomplete, to include incorrectly merged information, or to be out of date. If there is no resolution within 30 days, the center will not share the information until such time as the complaint has been resolved. A record will be kept by the center of all complaints and the resulting action taken in response to the complaint.

Sample Best Practice Language: This complaint procedure is applicable to all requests for information and intelligence held by the center. If an individual has a complaint with regard to the accuracy or completeness of terrorism-related protected information that:

- (a) Is exempt from disclosure.
 - (b) Has been or may be shared through the ISE.
 - (1) Is held by the **[name of center]** and
 - (2) Allegedly has resulted in demonstrable harm to the complainant.
2. To delineate protected information shared through the ISE from other data, the **[name of center]** maintains records of agencies sharing terrorism-related information and employs system mechanisms to identify the originating agency when the information is shared.

L. Security Safeguards

1. The **[name of center]**'s **[insert position title]** is designated and trained to serve as the center's security officer.
2. The center will comply with generally accepted industry or other applicable standards for security, in accordance with **[insert the name of the center security policy or reference applicable standard(s)]**. Security safeguards will cover any type of medium (printed and electronic) or technology (e.g., physical servers, virtual machines, and mobile devices) used in a work-related **[name of center]** activity.

The **[name of center]** will operate in a secure facility protected from external intrusion. The center will utilize secure internal and external safeguards against network intrusions. Access to the center's databases from outside the facility will be allowed only over secure networks.

3. The **[name of center]** will secure tips, leads, and SAR information in a separate repository system using security procedures and policies that are the same as or similar to those used for a system that secures data rising to the level of reasonable suspicion under 28 CFR Part 23.
4. The **[name of center]** will store information in a manner that ensures it cannot be added to, modified, accessed, destroyed, or purged except by personnel authorized to take such actions.
5. Access to **[name of center]** information will be granted only to center personnel whose positions and job duties require such access; who have successfully completed a background check and possess an appropriate security clearance, if applicable; and who have been selected, approved, and trained accordingly.
6. Queries made to the **[name of center]**'s data applications will be logged into the data system identifying the user initiating the query.

7. The **[name of center]** will utilize watch logs to maintain audit trails of requested and disseminated information.
8. To prevent public records disclosure, risk and vulnerability assessments will not be stored with publicly available data.
9. All individuals with access to **[name of center]**'s information or information systems will report a suspected or confirmed breach to the Privacy Officer as soon as possible and without unreasonable delay, consistent with applicable laws, regulations, policies, and procedures. This includes a breach in any medium or form, including paper, oral, and electronic.

[Best Practice Sample Language: To the extent allowed by existing data breach notification law] Following assessment of the suspected or confirmed breach and as soon as practicable, the **[name of center]** will notify the originating agency from which the center received PII of the nature and scope of a suspected or confirmed breach of such information.

[Determine whether your state has a data breach notification law and select the appropriate provision.]

Option 1: The **[name of center]** adheres to **[insert citation to applicable data breach notification law.]**. The **[name of center]** will determine whether a data breach requires notification to an affected individual, in accordance with applicable laws, regulations, policies, and procedures.

Option 2: The **[name of center]** will adhere to breach procedures established by Office Management and Budget (OMB) Memorandum M-17-12 (January 13, 2017). The provisions adopted by the **[name of center]** are cited below. In accordance with OMB M-17-12 **[insert citations to the sections and paragraphs of OMB M-17-12 that will be adopted]** and relevant laws, regulations, policies, and procedures, the **[name of center]** will determine whether, when, and how to provide notification to potentially affected individuals and other relevant entities.

Option 3:

The **[name of center]** will determine whether a data breach requires notification to an affected individual, in accordance with applicable laws, regulations, policies, and procedures.
- b. When the Privacy Officer is notified of a suspected or confirmed breach, the Privacy Officer will determine whether the center's response can be conducted at the staff level or whether a breach response team, consisting of the Privacy Officer, **[insert the Director, the center's security officer, legal counsel, privacy oversight committee, and/or other designee(s)]** must be convened to respond to the breach. The Privacy Officer, in coordination with the breach response team, when applicable, will assess the risk of harm to individuals potentially affected by a breach (e.g., the nature and sensitivity of the PII potentially compromised by the breach, the likelihood of access and use of PII, and the type of breach involved), evaluate how the center may best mitigate the identified risks, and provide recommendations to the Director on suggested countermeasures, guidance, or other actions.

The Director will determine whether a data breach requires notification to an affected individual, in accordance with applicable laws, regulations, policies, and

procedures. If required, the **[name of center]** will notify an individual about whom PII was or is reasonably believed to have been breached and access to which threatens physical, reputational, or financial harm to the person. If notice to the individual is required, it will be made promptly and without unreasonable delay following discovery of the breach. Notice will be provided consistent with the legitimate needs of law enforcement to investigate the breach or any measures necessary to determine the scope of the breach and, if necessary, to reasonably restore the integrity of any information system affected by the breach.

The Privacy Officer is responsible for developing and updating the center's data breach response plan on an annual basis and in accordance with any changes in law, guidance, standards, agency policy, procedures, staffing, and/or technology, for maintaining documentation about each data breach reported to the center and the center's response, and for keeping center administrators informed of the status of an ongoing response. The Director will determine when the response to a breach is concluded, based on input from the Privacy Officer.

M. Information Retention and Destruction

1. All criminal intelligence information, as that term is defined in 28 CFR § 23.3, will be reviewed for record retention (validation or purge) by **[name of center]** at least every five (5) years, in accordance with 28 CFR Part 23. For other information or intelligence, the record retention will be established by state law or local ordinance, or in accordance with a retention schedule established by the **[name of center]**. **[Identify each data set and its retention schedule or cite to a publicly available retention schedule covering the data sets.]**

Sample Best Practice Language: To ensure that all of the center's data sets are reviewed and updated or purged systematically, the **[name of center]** will identify its data sets, ensure that the retention of its data sets aligns with business need, and develop/implement a retention schedule for each data set that provides for the periodic review and update and establishes purge criteria. Operational procedures for the purge and the method of destruction or other disposition for purged materials will also be established.

2. When information has no further value or meets the criteria for removal according to the **[name of center]**'s retention and destruction policy or according to applicable law, it will be purged, destroyed, and deleted or returned to the submitting (originating) agency.
3. The **[name of center]** will delete information or return it to the originating agency once its retention period has expired as provided by this policy or as otherwise agreed upon with the originating agency in a participation or membership agreement.
4. **[Select an option below]**

Option 1:

The procedure contained in **[cite law, statute, regulation, or policy]** will be followed by **[name of center]** for notification of appropriate parties, including the originating agency, before information is deleted or returned in accordance with this policy or as otherwise agreed upon with the originating agency in a participation or membership agreement.

OR

Option 2:

No approval will be required from the originating agency before information held by the **[name of center]** is destroyed or returned in accordance with this policy or as otherwise agreed upon with the originating agency in a participation or membership agreement.

5. Notification of proposed destruction or return of records may or may not be provided to the originating agency by the **[name of center]**, depending on the relevance of the information and any agreement with the originating agency.
6. A record of information to be reviewed for retention will be maintained by the **[name of center]** and, for an appropriate system(s), notice will be given to the submitter at least 30 days prior to the required review and validation/purge date.
7. A printed or electronic confirmation of the deletion will be provided to the originating agency when required under law or if pursuant to the terms of a preestablished agreement with the agency.

N. Accountability and Enforcement

N.1 Information System Transparency

1. The **[name of center]** will be open with the public regarding information and intelligence collection practices. The center's P/CRCL policy will be provided to the public for review, made available upon request, and posted on the center's website **[or web page]** at **[insert web address]**.
2. The **[name of center]**'s **[Privacy Officer or other position title]** will be responsible for receiving and responding to inquiries and complaints about privacy, civil rights, and civil liberties protections in the information system(s) maintained or accessed by the center. The **[Privacy Officer or other position title]** can be contacted at **[insert mailing address or e-mail address]**.

N.2 Accountability

1. The audit log of queries made to the **[name of center]** will identify the user initiating the query.
2. The **[name of center]** will maintain an audit trail of accessed, requested, or disseminated information. An audit trail will be kept for a minimum of **[specify the retention period for your jurisdiction/center for this type of request]** of requests for access to information for specific purposes and of what information is disseminated to each person in response to the request.
3. The **[name of center]** will adopt and follow procedures and practices by which it can ensure and evaluate the compliance of users with system requirements and with the provisions of this policy and applicable law. This will include logging access to these systems and periodic auditing of these systems, so as to not establish a pattern of the audits. These audits will be mandated at least **[quarterly, semiannually, annually, or some other time period]**, and a record of the audits will be maintained by the **[Privacy Officer or title of designee]** of the center. Audits may be completed by an independent third party or a designated representative of the **[name of entity]**.

Appropriate elements of this audit process and key audit outcomes will be compiled into a report and may be provided to command staff and oversight entities or governance boards.

Optional: The [name of center] will provide an overview of audit findings to the public to enhance transparency with respect to privacy, civil rights, and civil liberties protections built into the [name of center]'s operations.

4. The **[name of center]**'s personnel or other authorized users shall report errors and suspected or confirmed violations of center policies relating to protected information to the center's Privacy Officer. **[Refer to policy (see Section C.3 of this template).]**

5. The **[name of center]** will annually conduct an audit and inspection of the information and intelligence contained in its information system(s) and may include any type of medium (printed and electronic) or technology (e.g., physical servers, virtual machines, and mobile devices) used in a work-related **[name of center]** activity.

The audit will be conducted by the center's **[designate audit committee, office, or position]** (or **[a designated independent panel]**). This **[committee/office/position]** (or **[independent panel]**) has the option of conducting a random audit, without announcement, at any time and without prior notice to staff of the center. The audit will be conducted in such a manner as to protect the confidentiality, sensitivity, and privacy of the center's information and intelligence system(s).

6. The **[name of center]**'s privacy committee, guided by the appointed and trained Privacy Officer, will review and update the provisions protecting privacy, civil rights, and civil liberties contained in this policy annually and will make appropriate changes in response to changes in applicable law, technology, the purpose and use of the information systems, and public expectations.

N.3 Enforcement

1. If center personnel, a participating agency, or an authorized user is found to be in noncompliance with the provisions of this policy regarding the gathering, collection, use, retention, destruction, sharing, classification, or disclosure of information, the **[title of center Director]** of the **[name of center]** will:
 - Suspend or discontinue access to information by the center personnel, the participating agency, or the authorized user.
 - Suspend, demote, transfer, or terminate center personnel, as permitted by applicable personnel policies.
 - Apply administrative actions or sanctions as provided by **[state agency or center]** rules and regulations or as provided in agency/center personnel policies.
 - If the authorized user is from an agency external to the agency/center, request that the user's employer enforce the policy's provisions.
 - Refer the matter to appropriate authorities for criminal prosecution, as necessary, to effectuate the purposes of the policy.
2. The **[name of center]** reserves the right to restrict the qualifications and number of personnel having access to center information and to suspend or withhold service and deny access to any participating agency or participating agency personnel violating the center's P/CRCL policy.

O. Training

1. The **[name of center]** will require the following individuals to participate in training programs regarding implementation of and adherence to the privacy, civil rights, and civil liberties policy:
 - All center personnel.
 - Participating agency personnel.
 - Personnel providing information technology services to the center.
 - Staff members in other public agencies or private contractors providing services to the center.
 - Authorized users who are not employed by the center or a contractor.
2. The **[name of center]** will provide special training regarding the center's requirements and policies for collection, use, and disclosure of protected information to personnel authorized to share protected information through the Information Sharing Environment.
3. The **[name of center]**'s P/CRCL policy training program will cover:
 - Purposes of the P/CRCL protection policy.
 - Substance and intent of the provisions of the policy relating to collection, use, analysis, retention, destruction, sharing, and disclosure of information retained by the center.

- Originating and participating agency responsibilities and obligations under applicable law and policy.
- How to implement the policy in the day-to-day work of the user, whether a paper or systems user.
- The potential impact of violations of the agency's P/CRCL policy.
- Mechanisms for reporting violations of center P/CRCL protection policies and procedures.
- How to identify, report, and respond to a suspected or confirmed breach of PII.
- The nature and possible penalties for policy violations, including possible transfer, dismissal, criminal liability, and immunity, if any.
- Updates to the P/CRCL policy, if any, in response to changes in law and implementation experience. **[Refer to Section C addressing Governance and Oversight.]**
- ISE Core Awareness Training, available at ise.gov.

Best Practice Sample Language: Subject to course availability, the Privacy Officer of the **[name of center]** will also take courses offered by the U.S. Department of Homeland Security addressing:

- P/CRCL training of trainers.
- Derivative classification marking.

Addendum A

Summary of Major Changes Incorporated in the Fusion Center Privacy, Civil Rights, and Civil Liberties (P/CRCL) Policy Template, Version 3.0

The updated version of the Fusion Center P/CRCL Policy Template:

- Revises the title and scope of the content to explicitly include CRCL, in addition to privacy
- Clarifies that CRCL protections in the policy extend beyond “citizens” and apply more broadly to “individuals in the United States”
- Explains how a privacy impact assessment informs a privacy policy
- Revises Section II.B.1 (“Policy Applicability and Legal Compliance”) to align the description of personnel who are subject to the P/CRCL Policy under Section II.B.1, with the list of personnel who are required to participate in training programs regarding the implementation of and adherence to the P/CRCL policy under Section II.O.1
- Revises the options available to fusion centers during the P/CRCL review and update process under Section II.C.2 (“Governance”)
- Updates Section II.E.2 (“Information”) governing the information that may not be sought, retained, shared, or disclosed by the center, in order to align the provision with the [DOJ's Guidance for Federal Law Enforcement Agencies regarding the Use of Race, Ethnicity, Gender, National Origin, Religion, Sexual Orientation, or Gender Identity](#) (December 2014) and the [ISE-SAR Functional Standard, Version 1.5.5](#) (February 2015)
- Includes a **new** best practice in Section II.E.7 (“Information”), stating that fusion centers should “state the retention period for non-validated tips and leads”
- Replaces the phrase “legally gathered” in Section II.F.2 with the phrase “gathered in an authorized and lawful manner,” in order to clarify the meaning of the provision
- Includes a new question and policy language under Section II.G.2 to align with Part B of the ISE-SAR Functional Standard v. 1.5.5, addressing the need for additional fact development during the vetting process under certain circumstances
- Modifies Section II.I (“Merging Records”) by:
 - Adding a **new** provision under Section II.I.1 to clarify who is authorized (position/title, credentials, clearance level[s], etc.) to merge records
 - Renumbering (and revising) Section II.I.1, Example 1 from the 2010 draft to be Section II.I.2, Example 1 in the current updated draft
- Revises Section II.J.8 (“Sharing and Disclosure”)
- Revises the language in Section II.J.9 (“Sharing and Disclosure”) governing the categories of records that will ordinarily not be provided to the public
- Revises the language in Section II.L (“Security Safeguards”) by:
 - Offering **new** policy language in Section II.L.2 to accompany a best practice (that was previously included in the 2010 template)
 - Revising data breach notification language in Section II.L.9, as follows:
 - Imposes a **new** responsibility on personnel for reporting suspected or confirmed breaches
 - Updates the template to reflect the current OMB data breach notification guidance (OMB M-17-12) and states that centers may choose to use this guidance to supplement existing law or policy, to determine which provisions are applicable, and to adapt those provisions to the specific needs of the center. (See Option 2)
 - Adds a **new** option (Option 3.a) under which centers use and insert excerpted language from **existing** policy and procedures on data breach notification
 - Revises template language under Option 3.b for those centers that do not have an existing data breach notification policy and for those that used or customized the template language from the 2010 *Fusion Center Privacy Policy Development Template*
- Modifies Section II.M.1 (“Information Retention and Destruction”)
 - To differentiate between the retention of criminal intelligence information and other information or intelligence
 - To incorporate language on the applicability of 28 CFR Part 23
 - To include a **new** best practice

- Includes a **new** best practice in Section II.N.1 (“Information System Transparency”):
- Clarifies Section II.N.2.3 (“Accountability and Enforcement/Accountability”)
- Revises Section II.O.1 (“Training”)
 - To align the list of personnel who are required to participate in training programs regarding the implementation of and adherence to the P/CRCL policy under Section II.O.1, with the description of personnel who are subject to the P/CRCL Policy under Section II.B.1:
 - To add ISE Core Awareness Training to the P/CRCL policy training program and to include a new best practice
- Modifies Appendix A (“Terms and Definitions”):
 - **To revise the following definitions:** Access, Agency, Biometrics, Civil Liberties, Civil Rights, Confidentiality, Credentials, Data Breach, Disclosure, Electronically Maintained, Fair Information Practice Principles, Need to Know, Originating Agency, Personally Identifiable Information, Protected Information, Public, Record, Right to Know, Source Agency, Suspicious Activity, Suspicious Activity Reporting, Terrorism Information, Tips and Leads
 - **To add the following definitions:** Analysis, Collect, Criminal Activity, Evaluation, Fusion Center, Information Sharing Environment, Joint Terrorism Task Force, NSI SAR Data Repository, Owning Agency, Pre-operational Planning, Purge, Reasonably Indicative, Submitting Agency,

 - Information Quality to Data Quality
 - Persons to U.S. Person (*with revisions*)
 - Privacy Policy to P/CRCL Policy (*with revisions*)

- Revises Appendix B
 - To add new federal laws, regulations, and guidance, where appropriate
 - To summarize primary federal laws, regulations, and guidance
 - To indicate that fusion centers should similarly insert a synopsis of applicable SLTT laws, regulations and guidance in Appendix B
- Removes the former Appendix C (“Suspicious Activity Reporting (SAR) Summary of Provisions”)
- Includes the Fair Information Practice Principles as the new Appendix C
- Creates a new Appendix D (“Sample Fusion Center Privacy, Civil Rights, and Civil Liberties Policy”)
- Creates a new Appendix E (“Technology-related P/CRCL Policies of the [Name of Center]”)
- Creates new Appendix F (“Resources”)
- Creates a new Addendum, including:
 - Addendum A (“Summary of Major Changes Incorporated in the Fusion Center Privacy, Civil Rights, and Civil Liberties Policy Template”)
