ON OR BEFORE JANUARY 1, 2016, THE MARYLAND POLICE TRAINING COMMISSION SHALL DEVELOP AND PUBLISH ONLINE A POLICY FOR THE ISSUANCE AND USE OF A BODY-WORN CAMERA BY A LAW ENFORCEMENT OFFICER THAT ADDRESSES:

(1) THE TESTING OF BODY-WORN CAMERAS TO ENSURE ADEQUATE FUNCTIONING;

(2) THE PROCEDURE FOR THE LAW ENFORCEMENT OFFICER TO FOLLOW IF THE CAMERA FAILS TO PROPERLY OPERATE AT THE BEGINNING OF OR DURING THE LAW ENFORCEMENT OFFICER'S SHIFT;

(5) WHEN RECORDING IS DISCRETIONARY;

28 **SECTION 2. AND BE IT FURTHER ENACTED, That:**

1 (a) There is a Commission Regarding the Implementation and Use of Body
2 Cameras by Law Enforcement Officers.

3 (b) The Commission consists of the following members:

4 (1) one member of the Senate of Maryland, appointed by the President of
5 the Senate;

6 (2) one member of the House of Delegates, appointed by the Speaker of the
7 House;

8 (3) the Secretary of State Police or the Secretary's designee;

9 (4) the Attorney General or the Attorney General's designee;

10 (5) the Public Defender or the Public Defender's designee;

11 (6) one representative of the Governor's Office of Crime Control and
12 Prevention;

13 (7) one representative of the Maryland Fraternal Order of Police;

14 (8) one representative from each of the five major local law enforcement
15 agencies in the State, as determined and appointed by the Governor;

16 (9) one representative of a law enforcement agency that currently utilizes
17 body cameras to record law enforcement officer activities, as appointed by the chair of the
18 Commission;

19 (10) one representative of the American Civil Liberties Union;

20 (11) one representative of the National Association for the Advancement of
21 Colored People;

22 (12) one representative of the Maryland Sheriff's Association;

23 (13) three representatives of the general public, appointed by the Governor;

24 ~~and~~

25 (14) two experts in any field deemed relevant for the purpose of the
26 Commission, as determined and appointed by the chair of the Commission; ~~and~~

27 (15) one representative of the Maryland Chiefs of Police Association; and

28 (16) one representative of CASA de Maryland.

1 (c) The Governor shall appoint a chair of the Commission from among its
2 members.

3 (d) The Governor's Office of Crime Control and Prevention and the Department
4 of State Police shall provide staff for the Commission.

5 (e) A member of the Commission:

6 (1) may not receive compensation as a member of the Commission; but

7 (2) is entitled to reimbursement for expenses under the Standard State
8 Travel Regulations, as provided in the State budget.

9 (f) The Commission shall study and make recommendations regarding the best
10 practices for the use of body cameras by a law enforcement officer.

11 (g) On or before October 1, 2015, the Commission shall report its findings and
12 recommendations to the Maryland Police Training Commission and, in accordance with §
13 2-1246 of the State Government Article, the General Assembly.

14 SECTION 3. AND BE IT FURTHER ENACTED, That:

15 (1) A jurisdiction that commences a pilot program for the use of body-worn
16 cameras or electronic control devices before the issuance of a policy established in
17 accordance with § 3-510 of the Public Safety Article is not subject to § 10-402(c)(11)(ii)2 of
18 the Courts and Judicial Proceedings Article for the duration of the pilot program.

19 (2) On the conclusion of a pilot program described in this section, a
20 jurisdiction's fully implemented program shall conform to § 10-402(c)(11)(ii)2 of the Courts
21 and Judicial Proceedings Article.

22 SECTION 4. AND BE IT FURTHER ENACTED, That a jurisdiction that has
23 established a program to use body-worn cameras or electronic devices on or before the date
24 this Act becomes effective is not subject to § 10-402(c)(11)(ii)2 of the Courts and Judicial
25 Proceedings Article until a policy is issued in accordance with § 3-510 of the Public Safety
26 Article.

27 SECTION ~~3~~ 5. AND BE IT FURTHER ENACTED, That this Act is an emergency
28 measure, is necessary for the immediate preservation of the public health or safety, has
29 been passed by a yea and nay vote supported by three-fifths of all the members elected to
30 each of the two Houses of the General Assembly, and shall take effect from the date it is
31 enacted. Section 2 of this Act shall remain effective through June 1, 2016, and, at the end
32 of June 1, 2016, with no further action required by the General Assembly, Section 2 of this
33 Act shall be abrogated and of no further force and effect.
