15	Subject: Public safety; law enforcement officers; video recording
16	Statement of purpose of bill as introduced: This bill proposes to require law
17	enforcement agencies to ensure that law enforcement officers engaged in law
18	enforcement activities are equipped with a video recording device on the
19	officer's person or vehicle. The bill also proposes to require a law
20	enforcement officer to record on video any interaction with a person who the
21	officer has reasonable suspicion to believe is committing a crime or civil

1	violation. Video recording is not required under exigent circumstances or if
2	video equipment is unavailable or malfunctioning. The bill proposes to require
3	a law enforcement officer operating a vehicle containing a video recording
4	device to turn the device on whenever the vehicle's blue lights are in operation.

11	(a) A law enforcement agency shall ensure that whenever a law
12	enforcement officer is engaged in law enforcement activities:
13	(1) the law enforcement officer is equipped with a video recording
14	device on his or her person; or
15	(2) the law enforcement officer's vehicle is equipped with a video
16	recording device.
17	(b) As used in this section:
18	(1) "Law enforcement agency" means the Department of Public Safety,
19	a municipal police department, or a sheriff's department.

5	(a)(1) A law enforcement officer shall record on video any interaction with
6	a person who the officer has reasonable suspicion to believe is committing a

8	(2) Video recording required by this subsection shall:
9	(A) begin no later than when the officer develops reasonable
10	suspicion to believe the person is committing a crime or civil violation;
11	(B) include:
12	(i) pursuit, apprehension, questioning, and arrest or citation of
13	the person;
14	(ii) the person being informed that the videotaping is occurring;
15	(iii) the person being advised of his or her rights under Miranda v.
16	Arizona, 384 U.S. 436 (1966); and
17	(C) conclude after arrest, citation, or release of the person.
18	(3) A videotape made pursuant to this subsection may be offered into
19	evidence in a criminal or civil proceeding.

1	(4) No videotaping shall be required under this subsection if:
2	(A) the videotape equipment malfunctioned or was inoperable at the
3	time of the incident, and reasonable efforts have been made to maintain the
4	equipment in operable condition;
5	(B) videotaping equipment was unavailable at the time of the
6	incident, and reasonable efforts have been made to make the equipment
7	available; or
8	(C) exigent circumstances existed which made videotaping the
9	incident dangerous or impracticable.
10	(b)(1) When a law enforcement officer is operating a law enforcement
11	vehicle containing mobile video recording equipment, the officer shall begin
12	operating the equipment whenever the officer initiates operation of the
13	vehicle's blue signal lights.
14	(2) This subsection shall not apply if the law enforcement officer
15	otherwise records the event pursuant to subsection (a) of this section.
