FY 2024 COMMUNITY-BASED APPROACHES TO PREVENT AND ADDRESS HATE CRIME



Who May Apply:

Native American tribal organizations (other than federally recognized tribal governments); nonprofits having a 501(c)(3) status with the IRS, other than institutions of higher education; nonprofits that do not have a 501(c) (3) status with the IRS, other than institutions of higher education; public, private, and state-controlled institutions of higher education; community-based and civil rights organizations that are tribal, nonprofit, and academic

Why Apply:

Receive funding to support comprehensive community-based approaches to addressing hate crimes. These approaches should promote community awareness and preparedness, increase victim reporting, and improve responses to hate crimes.

Maximum per Award:

- Up to \$400,000 for community-based organizations
- Up to \$2,000,000 for national civil rights organizations

BJA encourages the following entities to apply:

- Agencies that have not previously received BJA funding.
- Convening or governing bodies that can apply on behalf of one or more entities.

Examples of strategies/ activities that can be funded:

- Establish or enhance a task force or working group to address hate crimes.
- Conduct culturally responsive outreach, engagement, and education about hate incidents and hate crimes.
- Support several smaller organizations or communities through an intermediary program.
- Develop and deploy hate crime prevention and community healing activities and materials.

How to apply and when:

Submit a two-step application.

- (1) Register in <u>Grants.gov</u> and follow the prompts to submit two forms by June 4, 2024.
- (2) Then complete the full application in <u>JustGrants.usdoj.gov</u> by June 11, 2024. The application's major elements are:
 - (a) The **proposal abstract** that summarizes the problem you wish to address with your project (no more than 400 words).
 - (b) The proposal narrative that describes your project's strategies, activities, and major deliverables as well as your capacity to address the problem.
 - (c) The **web-based budget** form that details how you will allocate the grant funds by task, date, and responsible person.
